Import Control Exemption Notice (No. 5) 1979

Pursuant to regulation 17 of the Import Control Regulations 1973*, the Minister of Trade and Industry hereby gives notice as follows:

(a) This notice may be cited as the Import Control Exemption Notice (No. 5) 1979.
 (b) This notice shall come into force on the 1st day of January 1980.

- 2. Goods of the classes specified and for the purposes of the Customs Tariff falling within the Tariff items in the First Schedule hereto-imported from and being the produce or manufacture of any country, are hereby exempted from the requirement of a licence under the said regulations.
- 3. The exemptions from the requirement of a licence under the said regulations in respect of the goods of the classes set forth in the Second Schedule hereto, included in the exempting notice shown in the Second Schedule, are hereby withdrawn.

WHEREAS, by Our Warrant dated the 7th day of August 1978*, issued under the authority of the Letters Patent of His Late Majesty King George the Fifth, dated the 11th day of May 1917, and under the authority of and subject to the provisions of the Commissions of Inquiry Act 1908, and with the advice and consent of the Executive Council of New Zealand, you were appointed to be a Commission to inquire into and report upon the matters in Our said Warrant set out, being matters concerning the structure and operation of the Maori Land Court and the Maori Appellate Court:
