- (b) Whether there was any impropriety on the part of any person in relation to the circumstances in which, or the basis on which, the application was considered on any occasion:
- (c) In respect of the approval of the application by the Board,-

(i) Whether there was any error of jurisdiction or otherwise; and

(ii) Whether there was any impropriety by way of (1) Whether there was any impropriety by way of departure from previously accepted criteria for granting loans or from what have been previously accepted as proper conditions of loans, or otherwise:
(d) Whether any amendment to the legislation governing the functions, procedures, and practices of the Marginal Lands Board is necessary or expedient.

A sitting open to the public: And it is hereby declared that the powers hereby conferred

shall be exercisable notwithstanding the absence at any time of any one of the members hereby appointed so long as the Chairman or a member deputed by the Chairman to act in his stead, and one other member, are present and concur in the exercise of the powers: And it is hereby declared that you have liberty to report your proceedings and recommendations under this Commis-sion from time to time if you shall judge it expedient so to do:

And, using all due diligence, you are required to report to me in writing under your hand not later than the 14th day of November 1980 your findings and opinions on the matters aforesaid, together with such recommendations as you think fit to make in respect thereof.
