Revocation of the Commission Appointing The Right Honourable Sir Keith Jacka Holyoake, K.G., G.C.M.G., C.H., to be Governor-General and Commander-in-Chief of New Zealand

ELIZABETH THE SECOND, by the Grace of God Queen of New Zealand and Her Other Realms and Territories, Head of the Commonwealth, Defender of the Faith:

To Our Right Trusty and Well-beloved Counsellor Sir Keith Jacka Holyoake, Knight Companion of Our Most Noble Order of the Garter, Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Member of Our Order of the Companions of Honour, Principal Companion of Our Service Order:

GREETING:

WHEREAS by Our Commission under Our Seal of New Zealand bearing date at Saint James's the 13th day of October 1977, We did appoint you the said Sir Keith Jacka Holyoake to be, during Our pleasure, Our Governor-General and Commander-in-Chief in and over New Zealand:

AND WHEREAS you the said Sir Keith Jacka Holyoake did on the 26th day of October 1977, assume the said office of Governor-General and Commander-in-Chief by taking the prescribed oaths before Our Right Trusty and Well-beloved Counsellor Sir Herbert Richard Churton Wild, Chief Justice of New Zealand:

AND WHEREAS you the said Sir Keith Jacka Holyoake have given faithful and loyal service in pursuance of Our said Commission appointing you to be Our Governor-General and Commander-in-Chief in and over New Zealand:

Now THEREFORE: as it is Our Will and Pleasure to appoint Our Trusty and Well-beloved the Honourable Sir David Stuart Beattie, Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, one of Our Counsel learned in the law, to be your successor as Our Governor-General and Commander-in-Chief in and over New Zealand, We do by these presents revoke Our Commission under Our Seal of New Zealand, bearing date the 13th day of October 1977, appointing you the said Sir Keith Jacka Holyoake to be Our Governor-General and Commander-in-Chief in and over New Zealand:

And We direct that this Our command and the revocation effected by it shall take effect from the close of the 27th day of October 1980.

Given at Our Court at Saint James's, and issued under the Seal of New Zealand this 11th day of September 1980, in the twenty-ninth year of Our Reign.

Assumption of the Administration of the Government of New Zealand by The Right Honourable Sir Ronald Keith Davison, Chief Justice

A PROCLAMATION

WHEREAS His late Majesty King George V was graciously pleased, by Letters Patent passed under the Great Seal of the United Kingdom, and bearing date at Westminister the 11th day of May 1917, to constitute the office of the Governor-General and Commander-in-Chief in and over New Zealand: And whereas Her Majesty Queen Elizabeth II was pleased, by a Commission passed under the Royal Sign Manual and Seal of New Zealand, bearing date at Saint James's the 13th day of October 1977, to appoint the Right Honourable Sir Keith Jacka Holyoake, to be Governor-General and Commander-in-Chief in and over New Zealand during Her Majesty's pleasure: And whereas His late Majesty King George V was pleased, by a Commission passed under the Royal Sign Manual and Signet bearing date at Saint James's the 23rd day of July 1917, amongst other things, to appoint the Chief Justice of New Zealand for the time being to administer the Government thereof in the case of the death, incapacity, or removal, or of the departure from New Zealand of the Governor-General appointed under the said Letters Patent, with all and singular the powers and authorities granted by the said Letters Patent: And whereas it has pleased Her Majesty to revoke the Commission appointing the said Right Honourable Sir Keith Jacka Holyoake, to be Governor-General and Commander-in-Chief in and over New Zealand with effect from the close of the 27th day of October 1980.

Now, therefore, I, the Right Honourable Sir Ronald Keith Davison, Knight Grand Cross of the Most Excellent Order of the British Empire, Companion of the Most Distinguished Order of Saint Michael and Saint George, Chief Justice of New Zealand, hereby proclaim and declare that I have this day taken the oaths prescribed by the said Letters Patent before the Right Honourable Sir Clifford Parris Richmond, Knight Commander of the Most Excellent Order of the British Empire, President of the Court of Appeal, and that I have assumed the administration of the Government of New Zealand under and by virtue of His late Majesty's said Commission.

Given under the hand of His Excellency the Administrator of the Government, and issued under the Seal of New Zealand this 28th day of October 1980.
