The Transport (Towage Fees) Notice 1981

PURSUANT to section 2 (1) of the Transport Act 1962 (as amended by section 2 (4) of the Transport Amendment Act 1980), the Deputy Secretary for Transport, acting pursuant to section 6 (2) of the Ministry of Transport Act 1968, hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Transport (Towage Fees) Notice 1981.
 (2) This notice shall come into force on the 1st day of April 1981.
- 2. Towage fees—The towage fees payable under section 42A of the Transport Act 1962 shall be the fees set out in the Schedule to this notice.
