ORDER IN COUNCIL

At the Government Buildings at Wellington this 21st day of April 1981

Present:

THE RIGHT HON. D. S. THOMSON PRESIDING IN COUNCIL

PURSUANT to the Local Government Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order:

## ORDER

1. **Title and commencement**—(1) This order may be cited as the Manawatu Region Constitution Order 1981.

(2) This order shall come into force on the 1st day of May 1981, except in so far as it is necessary for the constituent authorities to proceed prior to that date with the appointment of the first members of the Council in terms of clause 6 of this order, and for matters incidental thereto.

2. **Manawatu Region**—(1) There is hereby constituted a region to be called the Manawatu Region (hereinafter referred to as "the Region").

(2) The constituent districts of the Region shall be the districts of:

- (a) The County of KIWITEA;
- (b) The County of POHANGINA;
- (c) The County of OROUA;
- (d) The Borough of FEILDING;
- (e) The County of MANAWATU;
- (f) The Borough of FOXTON;
- (g) The County of KAIRANGA;
- (h) The City of PALMERSTON NORTH;
- (i) The County of DANNEVIRKE;
- (j) The Borough of DANNEVIRKE;
- (k) The County of WOODVILLE;
- (l) The Borough of WOODVILLE;
- (m) The County of PAHIATUA;
- (n) The Borough of PAHIATUA.

3. **Manawatu United Council**—The council for the Region shall be a united council described as "The Manawatu United Council" (hereinafter referred to as "the Council").

4. **Membership of Council**—The Council shall consist of 18 members of whom:

- (a) One shall be appointed by the KIWITEA County Council;
- (b) One shall be appointed by the POHANGINA County Council;
- (c) One shall be appointed by the OROUA County Council;
- (d) One shall be appointed by the FEILDING Borough Council;
- (e) One shall be appointed by the MANAWATU County Council;
- (f) One shall be appointed by the FOXTON Borough Council;
- (g) One shall be appointed by the KAIRANGA County Council;
- (h) Five shall be appointed by the PALMERSTON NORTH City Council;
- (i) One shall be appointed by the DANNEVIRKE County Council;
- (j) One shall be appointed by the DANNEVIRKE Borough Council;

- (k) One shall be appointed by the Woodville County Council;
- (l) One shall be appointed by the Woodville Borough Council;
- (m) One shall be appointed by the Pahiatua County Council;
- (n) One shall be appointed by the Pahiatua Borough Council.

**5. Administering authority**—The administering authority of the Council shall be the Palmerston North City Council.

**6. First appointment of members**—(1) Each constituent authority shall, not later than 1 month after the date of the commencement of this order, appoint the first member or the first members of the Council which that authority is to appoint under clause 4 of this order.

(2) The members of the Council appointed pursuant to subclause (1) of this clause shall come into office on the day of the first meeting of the Council.

(3) Each constituent authority shall, not later than the 1st day of June 1981, give the names of the person or persons appointed by it pursuant to subclause (1) of this clause to the principal administrative officer of the administering authority.

(4) The principal administrative officer of the administering authority shall not be prevented, by any failure to comply with subclause (3) of this clause, from convening the first meeting of the Council in accordance with clause 7 of this order.

**7. First meeting of Council**—(1) The first meeting of the Council shall be held not later than two months after the date of the commencement of this order.

(2) The principal administrative officer of the administering authority shall convene the first meeting of the Council and shall preside at that meeting until the election of the Chairman.

(3) That principal administrative officer may do all things necessary for the convening of that meeting.

**8. Committees**—(1) Subject to section 104 of the Local Government Act 1974, section 6 of the Town and Country Planning Act 1977, and subclause (2) of this clause, the Council may appoint such committees as it thinks fit.

(2) The Council shall appoint and maintain a Civil Defence Committee which committee shall include a nominee of the Director of Civil Defence and a nominee of the Commissioner of Works.

**9. Finance**—(1) For the purposes of and subject to section 123 of the Local Government Act 1974, the net expenditure of the Council for each financial year shall be apportioned among the constituent authorities of the Region in the proportion that the adjusted net capital value of the district of each constituent authority bears to the total adjusted net capital value of the Region.

(2) For the purposes of section 123 of the Local Government Act 1974 the functions of regional planning and civil defence shall be deemed to be functions for the benefit of the whole Region.

Rule 8 (2) The council shall hold a meeting as soon as convenient after the holding of the annual general meeting to elect from among its number a president. The president shall, so long as he continues to be a member of the society, hold office for a term of 1 year. He shall be eligible for re-election, subject to his term of office as councillor not having expired, or if that term of office has expired, subject to his re-election as a councillor by ballot of the general membership. If for any reason the position of president becomes vacant, the council may elect 1 of its number to be president for the unexpired term.

Rule 9 (a) The secretary shall no later than the first Monday in March insert in 1 or more daily newspapers, circulating in the district a notice inviting nominations for the council, and stating the time of closing for such nominations.

Rule 9 (c) At the annual general meeting the members to fill the vacancies shall be elected by ballot from the nominees by vote of members of the society present at such meeting in the following manner:

The secretary shall hand 1 voting paper containing the names of all nominees to each member present, who shall leave uncanceled the name of any nominee for whom he desires to vote, and shall strike out the name of any nominee for whom he does not desire to vote. Each member shall vote for the full number of candidates required to fill all vacancies, and any voting paper failing to comply with this requirement shall be classified as invalid.

Rule 9 (d) Upon the completion of voting the voting papers shall be folded up and handed to the scrutineers appointed by the meeting. The scrutineers shall thereupon in the presence of each other count the ballot and certify the result of the ballot to the chairman, who shall forthwith announce to the meeting the names of the members successful in the ballot and declare them elected to the council for the prescribed term of office. Such election will be effective as from the conclusion of the annual general meeting.

Rule 9 (f) If the number of nominations for the council does not exceed the number required, the chairman of the meeting shall, at the annual general meeting declare those nominees duly elected, and if there remain any vacancies on the council, the members present at that meeting may elect from those members present sufficient members to fill the vacancy or vacancies.

Rule 16 The annual general meeting of the society shall be notified to members by notices placed in any daily newspaper circulating within the district. Such notices shall appear at least 14 clear days prior to the date of the annual general meeting, and shall give notice of the business to be transacted at the meeting.

Rule 19 At all meetings of the society or of the council, the president or in his absence the vice-president (to be chosen by the meeting, if more than 1 are present), shall take the chair. If neither the president nor any vice-president is present or willing to act, the meeting shall elect a chairman. The chairman shall have a deliberative vote, and in the case of an equality of votes, shall have a casting vote also.

#### *Notice to Make Returns of Income under Income Tax Act 1976*

PURSUANT to the Income Tax Act 1976, the Commissioner of Inland Revenue gives notice as follows:

(1) Returns of income for the year ended 31 March 1981 (or other approved balance date) are required from:

- (a) All companies, all partnerships, all persons in business (including farming) or in a profession, all persons in partnership, all trustees, executors and administrators, notwithstanding that by reason of a loss being incurred for the year or carried forward from a previous year, no taxation is payable.
- (b) Every person whose total income from employment exceeded \$11,500.
- (c) Every person who derived income from employment, the whole or any part of which was not taxed at source.
- (d) Every person who derived interest and/or dividends, exceeding \$200.
- (e) Every person who derived assessable income other than income from employment, except that no return is required where the total income did not exceed \$200 and consisted exclusively of interest and dividends.
- (f) Every person who paid provisional tax in respect of income for the year ended 31 March 1981.
- (g) Every person who received withholding payments. Note, however, that a return is not required where a person receives not more than \$4,900 from withholding payments or withholding payments and income from employment not exceeding \$4,900 in aggregate.
- (h) Every incorporated body which derived assessable income.
- (i) Every absentee who derived income from New Zealand.

(2) Returns may be furnished by posting or delivering the same to the office of the Inland Revenue Department nearest to the place of residence of the taxpayer, or if the taxpayer's records are held in another office of the department, then to the latter office.

(3) Returns are due on:

- (a) 7 June 1981 in any case where income was derived from salary, wages, superannuation (including National Superannuation), pensions, taxable allowances, etc., and
  - (i) No other income whatsoever was derived, or
  - (ii) The other income derived consisted exclusively of not more than \$500 in total from dividends, net rents, interest (after the interest and dividend exemption).
- (b) 7 August 1981 in all other cases or within 2 months of balance date, whichever is the later. No action for failure to furnish a return due on 7 August 1981 will be taken if it is furnished by 7 September 1981.

The return to be used is IR 5 (green print) in the case of paragraph (3) (a) above, and the IR 3 (black print) in the case of (3) (b) above.

In addition to return IR 3, farmers are to complete supplementary return IR 3F, and persons in business or in a profession are to complete supplementary return IR 3B. (The supplementary returns are not required if a copy of the annual

accounts is furnished with the return.) Companies are to use IR 4, and estates and trusts IR 5A. Each form indicates the classes of taxpayers who are to use that form, and where applicable, the due dates for payment of provisional tax.

(4) Return forms and guides have been mailed to all taxpayers. Additional forms are available from Inland Revenue and Post Offices.

5. Any person who shall do or cause to be done or knowingly permits or suffers to be done, or is concerned in doing anything whatsoever contrary to this Bylaw shall be guilty of an offence under this Bylaw.

Fifty years of public demand since this book was first published resulted in the need for reprints in 1934 and 1952. The text has been reproduced unchanged but the originals of some of the figures could not be traced and these have been replaced with similar illustrations. There have been many advances in our knowledge of Maori life since this book first appeared. The work of numerous ethnologists, and more recently archaeologists, has critically examined many of the earlier concepts, confirming some, disproving others, and altering others to varying degrees. No one has yet produced a synthesis of the results of all this scholarship, and there is still nothing as comprehensive as this book of Best's to give a general account of the Maori. This book was first published when Best was 68 and thus represents the accumulated knowledge of a lifetime. It has now become a classic introduction to Maori life. Its continued availability should help the reader to obtain a basic background to old time Maori life which can be extended by further reading.
