PURSUANT to the Commerce Act 1975, I, Desmond James Gasson, pursuant to a delegation from the Secretary of Trade and Industry, hereby make the following price order:

1. This order may be cited as Price Order No. 235 and shall be read together with and deemed part of Price Order No. 204\* (hereinafter referred to as the principal order).

2. This order shall come into force on the 16th day of January 1982.

3. The principal order is hereby amended by revoking the Schedule thereto, (as amended by Price Order No. 228†,) and substituting the following Schedule.

*Price Order No. 236 (Californian Navel Oranges)*

PURSUANT to the Commerce Act 1975, I, Desmond James Gasson, pursuant to a delegation from the Secretary of Trade and Industry, hereby make the following price order:

1. This order may be cited as Price Order No. 236 and shall come into force on the 19th day of January 1982.
2. Price Order No. 196\* is hereby revoked.

## APPLICATION OF THIS ORDER

3. This order applies with respect to all Californian navel oranges sold by way of retail in New Zealand.

## MAXIMUM RETAIL PRICES OF CALIFORNIAN NAVEL ORANGES

4. (1) The maximum price that may be charged or received by any retailer for any Californian navel oranges to which this order applies shall be:

- (a) When sold by a retailer carrying on business in any of the metropolitan areas of Auckland, Wellington, Christchurch, or Dunedin, or in any of the Cities or Boroughs of Whangarei, Hamilton, Tauranga, Rotorua, Gisborne, New Plymouth, Stratford, Hawera, Wanganui, Palmerston North, Napier, Hastings, Masterton, Blenheim, Nelson, Greymouth, Timaru, Westport, Oamaru, Balclutha, Gore, Invercargill, or Alexandra—

\$1.69 a kilogram.

- (b) When sold by a retailer carrying on business elsewhere—

\$1.71 a kilogram.

(2) If in respect of any lot of oranges the price calculated in accordance with the foregoing provisions of this clause is not an exact number of cents, the maximum price of the lot shall be computed to the nearest whole cent.

## PROVISIONS FOR SPECIAL PRICES

5. Notwithstanding anything to the contrary in the foregoing provisions of this order, and subject to such conditions, if any, as he thinks fit, the Secretary, on application by any retailer, may authorise special maximum prices in respect of any Californian navel oranges to which this order applies where special circumstances exist, or for any reason extraordinary charges (freight or otherwise) are incurred by the retailer. Any authority given by the Secretary under this clause may apply with respect to a specified lot or consignment of

oranges, or may relate generally to Californian navel oranges to which this order applies sold by the retailer to whom approval remains in force.

## DUTY IMPOSED ON RETAILERS

6. Every retailer who offers or exposes for sale in any Californian navel oranges to which this order applies shall keep in a prominent position in such proximity to the oranges to which it relates as to be obviously visible thereon, a ticket, placard, or label on which shall be printed in legible and prominent characters the following particulars:

- (a) The retail price per kilogram.
- (b) The words "Californian Navel".

## DEFINITION OF METROPOLITAN AREAS

Name of Metropolitan Area	Districts Included Therein
Auckland	The Cities of Auckland, East Auckland, Mount Albert, Takapuna and the Boroughs of Devonport, Glen Eden, Henderson, Mount Eden, Mount Roskill, Wellington, New Lynn, Northcote, Onehunga, One Tree Hill, and Otahuhu.
Wellington	The Cities of Wellington, Lower Hutt, and Porirua, the Boroughs of Eastbourne, Petone, and the District Community of Wainuiomata.
Christchurch	The City of Christchurch, the Boroughs of Riccarton, and the Counties of Selwyn, Ashburton, and Waimairi.
Dunedin	The City of Dunedin and the Boroughs of Green Island, Port Chalmers, and Kilda.
