AUSTRALIA - NEW ZEALAND CLOSER ECONOMIC RELATIONS—TRADE AGREEMENT (ANZCERTA)

CERTAIN CER EX-NAFTA LICENCE AND OTHER ANZCERTA LICENCE ISSUES

I CER Ex-NAFTA Schedule A Licences Allocated by the Australian Government

In terms of Article 5, paragraph 18 of ANZCERTA, exclusive access for goods under NAFTA has been maintained additional to the ANZCERTA access formula.

Under Article 20, paragraph 2 of ANZCERTA, the Australian Government retained the right for the 1983-84 and 1984-85 import licensing years, for certain product categories, to nominate the Australian exporters and apportion the licence allocation, as was previously the case under Schedule A of NAFTA. In 1983-84 these licences were issued as type 11; in 1984-85, as type 10. For 1985-86 the allocation of these licences will be taken over by the New Zealand Government. Licence will be allocated to the 1984-85 licence-holders. Where access levels have not been fully taken up, the balance is available on request to the Executive Officer, General Industries 2, Department of Trade and Industry, Private Bag, Wellington.

Although it is intended to reissue these licences for 1985-86 to the 1984-85 holders, their reissue in subsequent years could be dependent on usage.

Details of the large majority of these licences were published in the Supplement (No. 220) to the New Zealand Gazette of Thursday 15 December 1983, published Tuesday 20 December, "ANZCERT Certain 1983-84 CER Ex NAFTA Licence and ANZCERT Licence issues", pages 4570-4575. However, between the date of publication of that Gazette and the end of the import licensing year, 30 June 1984, the following licences were also issued:

II CER Ex-NAFTA Schedule A Licences Allocated by the New Zealand Government

In terms of Article 5, paragraph 18 of ANZCERT, exclusive access for goods under Schedule A of NAFTA has been maintained additional to the ANZCERT access formula.

Under Article 20, paragraph 2 of ANZCERT, allocations of access are determined by New Zealand where NAFTA Schedule A access was not fully allocated or where only one Australian exporter was interested in the market for the 1982-83 import licensing period.

For these Ex-NAFTA Schedule A product categories, New Zealand allocates the licence to the previous licence-holders. Although these licences are normally issued to previous licence-holders, their reissue in subsequent years could be dependent upon usage. As noted in I above, the New Zealand Government will take over the allocation of all CER Ex-NAFTA Schedule A licences for the 1985-86 import licensing period.

Where access levels have not been fully taken up, the balance is available on request. Interested importers should apply in writing to "The Executive Officer, General Industries 2, Department of Trade and Industry, Private Bag, Welllington".

VIII ANZCERT: Guideline "R" Rationalisation/Complementation Policy

Guideline "R" of the "Guidelines for the Allocation of Manufacturers' Exclusive Australian Licences" is considered to be an important element of ANZCERT because it provides the basis for using the agreement to progress the development of efficient export-orientated industries in New Zealand.

By providing additional licences, Rationalisation/Manufacturers' Exclusive Australian Licences (R/MEALs), to companies involved in significant product rationalisation and/or product complementation proposals, Guideline "R" will enable individual manufacturers to place themselves in a better position to compete and trade successfully in the New Zealand/Australia free trade area as access is progressively liberalised.

Under Guideline "R" consideration can be given to the issuing of additional licence where the share of a MEAL received by a manufacturer does not allow rationalisation/complementation to proceed as quickly as desired, or where no MEALs have been received. Where Guideline "R" licences are issued these are additional to the ANZCERT EAL formulae.

Full details of the Guideline "R" provision are contained in the I.L.S. 1984, pages 218-219.

The ANZCER Trade Agreement, Article 10 para 1. Annex E (page 120), states that the provision of access to the New Zealand market for imports of wheat flour originating in Australia shall be mutually determined by the Member States. The arrangement subsequently so mutually determined provides for the EAL allocation to be split as follows:

- (a) 50% to the New Zealand Wheat Board for import of wheat flours.
- (b) 50% put up for tender available to other commercial importers but endorsed to exclude wheat flour i.e., licences to be endorsed "available only for speciality flours other than of wheat".
