- 7. This licence shall come into force on the 1st day of April 1985 and shall continue in force for a period of one year from that date unless it is sooner lawfully determined in accordance with clauses 8 or 9 hereof.
- 8. The Governor-General in Council may pursuant to section 22 of the Electricity Act 1968 cancel this licence if the Board is in breach of the provisions contained in clause 2 of these conditions.

plant and other machinery and other removable equipment authorised by the licence to be erected, installed or provided and if within 12 months after being so required the Board fails or neglects to remove the same, then the same shall, without payment of any compensation vest <code>In</code> and become the property of the Crown and it shall be lawful for any person **authorised** by the Minister of Energy in that behalf. subject to compliance with section 15A of the Electricity Act 1968 to enter upon any land or premises and take possession of and remove the same or any part thereof.

- 1 I. Nothing contained in the licence, either expressly or by implication shall be deemed to authorise the Board to erect, construct or maintain any lines or works except subject to such conditions (not inconsistent with this licence) as may from time to time be lawfully imposed by any local authority within the district of which any such lines or works may be situated.
