- 2 All submissions from local manufacturers must include:

 - the range of alternative goods made locally; the grounds on which objection is made (including reasons why the local product is a suitable alternative); present and potential output; details of factory cost in terms of materials, labour, overheads, including the proportion of domestic and imported content.
- All submissions objecting to a request for the imposition of duty must include:
 - reasons why the local product on which protection is sought is not a suitable alternative; full technical details of the goods against which tariff protection is sought.
- Where further information is required in order to make a submission an objector should contact the applicant in writing and refer a copy of the enquiry to the port where the application was lodged quoting the details in paragraph I above.
- Any submission not supported by the information required in the paragraphs above will not be regarded as a valid objection.
