*Fire Districts Boundaries (North Auckland) Notice 1985*

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

## NOTICE

**1. Title of commencement**—(1) This notice may be cited as the Fire Districts Boundaries (North Auckland) Notice 1985.

(2) This notice shall come into effect on 1st day of August 1985.

**2. Fire District Boundaries**—The boundaries of the following Fire Districts have been altered and shall henceforth be as defined in the Schedule hereto.

(1) The Whangarei Fire District being all that area described in the First Schedule hereto.

(2) The Hikurangi Fire District being all that area described in the Second Schedule hereto.

(3) The Ngunguru Fire District being all that area described in the Third Schedule hereto.

(4) The Ruakaka Fire District being all that area described in the Fourth Schedule hereto.

(5) The Dargaville Fire District being all that area described in the Fifth Schedule hereto.

(6) The Ruawai Fire District being all that area described in the Sixth Schedule hereto.

(7) The Portland Fire District being all that area described in the Seventh Schedule hereto.

(8) The Kaikohe Fire District being all that area described in the Eighth Schedule hereto.

(9) The Kaeo Fire District being all that area described in the Ninth Schedule hereto.

(10) The Kerikeri Fire District being all that area described in the Tenth Schedule hereto.

(11) The Kohukohu Fire District being all that area described in the Eleventh Schedule hereto.

(12) The Okaihau Fire District being all that area described in the Twelfth Schedule hereto.

(13) The Rawene Fire District being all that area described in the Thirteenth Schedule hereto.

(14) The Kaitaia Fire District being all that area described in the Fourteenth Schedule hereto.

(15) The Mangonui Fire District being all that area described in the Fifteenth Schedule hereto.

(16) The Kawakawa Fire District being all that area described in the Sixteenth Schedule hereto.

(17) The Paihia Fire District being all that area described in the Seventeenth Schedule hereto.

(18) The Russell Fire District being all that area described in the Eighteenth Schedule hereto.

(19) The Maungaturoto Fire District being all that area described in the Nineteenth Schedule hereto.

(20) The Kaiwaka Fire District being all that area described in the Twentieth Schedule hereto.

(21) The Waipu Fire District being all that area described in the Twenty-first Schedule hereto.

## FIRST SCHEDULE

## WHANGAREI FIRE DISTRICT

ALL that area in the North Auckland Land District, City and County of Whangarei containing 9,930 hectares, more or less, bounded by a line commencing at the easternmost corner of Te Rewarewa BIA3B1 in Block XIII, Whangarei Survey District on the shores of the Whangarei Harbour and proceeding southwesterly generally along those shores to the south-western boundary of Lot 8 D.P. 59029 in Block XVI, Purua Survey District; thence north-westerly along that boundary to State Highway No. 1; thence northerly along the eastern side of that Highway to the south-western corner of part Lot 13 D.P. 13347; thence north-westerly along a right line to the southeastern corner of part Lot 3, D.P. 26890; thence westerly and northerly generally along the generally southern and western boundaries of that part Lot 3 to the southernmost corner of Lot 1 D.P. 33086; thence westerly and northerly generally along the generally southern and western boundaries of that Lot 1 of the easternmost corner of Section 22, Block XVI, Purua Survey District; thence north-westerly along the south-western boundaries of part Lot 2 D.P. 53728, Lot 3, D.P. 49606 and Lot 3, D.P. 86583 to the westernmost corner of the last-mentioned Lot 3; thence northerly along the western boundaries of that Lot 3, Lot 1, D.P. 86583 and Part Raumanga 2 to the right bank of the Waiponamu Stream; thence westerly and southerly generally along the right banks of that stream and the Nihotetea Stream to the south-western boundary of Lot 2, D.P. 91970; thence northwesterly along that boundary to the westernmost corner of that Lot 2; thence north-easterly along the north-western boundary of the said Lot 2 to the southernmost corner of Lot 6, D.P. 56587; thence north-westerly along the south-western boundaries of that Lot 6 and Lot 2 D.P. 85459 in Block XV, Purua Survey District to the westernmost corner of the last-mentioned Lot 2; thence south-westerly and north-westerly generally along the generally south-eastern and south-western boundaries of part Papataua Block to the northernmost corner of Section 13, Block XV, Purua Survey District; thence southerly generally along the generally western boundary of that Section 13 to its westernmost corner; thence north-westerly along the north-eastern boundary of Section 18, Block XV, Purua Survey District to its northernmost corner and along a right line to the southernmost corner of Lot 10, D.P. 57029; thence westerly along the southern boundaries of that Lot 10, Lots 9, 8 and 7, D.P. 57029 and Lot 3, D.P. 62748 to the south-western corner of the last-mentioned Lot 3; thence northerly along the western boundary of that Lot 3 to its north-western corner; thence westerly and northerly along the southern and western boundaries of Lot 1, D.P. 72737 in Block XI, Purua Survey District to State Highway No. 14; thence northerly along a right line to the south-western corner of Lot 2, D.P. 60304 and along the eastern side of Millington Road to the southernmost corner of Lot 1, D.P. 69842; thence north-easterly along the north-western boundary of Lot 1 D.P. 73884 to its northernmost corner and along a right line to the south-western corner of Lot 2, D.P. 13000; thence easterly generally along the generally southern boundaries of that Lot 2, Allotment 38, Kaitara Parish and Allotment 8, Pukenui Parish in Block XII, Purua Survey District to the south-easternmost corner of the last-mentioned Allotment 8; thence northerly along the eastern boundaries of the last-mentioned Allotment 8 and Allotment 76, Whangarei Parish to the easternmost corner of the last-mentioned Allotment 76; thence north-westerly along the north-eastern boundary of the said Allotment 76 of Whau Valley Road; thence northerly along the eastern side of that road to the northernmost corner of Lot 1, D.P. 33712 and along a right line to the eastern corner of Allotment 54, Whangarei Parish; thence north-westerly along the north-eastern boundary of that Allotment 54 to its northern corner; thence northerly generally along the generally western boundaries of Allotments 56 and 60, Whangarei Parish in Block VIII, Purua Survey District to the north-westernmost corner of the last-mentioned Allotment 60; thence south-westerly along the south-eastern boundary of part Pukemiro 2C4E and the north-western boundaries of Allotments 58 and Allotment N.W. 55, Whangarei Parish in Block XII, Purua Survey District to the south-western corner of the last-mentioned Allotment N.W. 55; thence north-westerly along the south-western boundaries of Lot 2 D.P. 36064 and Lot 1, D.P. 24601 to the south-eastern corner of Allotment 52, Kaitara Parish; thence northerly along the eastern boundary of that Allotment 52 to its northern corner; thence south-westerly along the north-western boundary of that Allotment 52 to a point in line with the eastern boundary of Lot 2, D.P. 24734; thence northerly along a right line to and along the eastern boundary of Lot 2, D.P. 24734 and the production of the last-mentioned boundary to the northern side of Three Mile Bush Road in Block VIII, Purua Survey District; thence easterly and northerly along the southern and eastern boundaries of part Ngararatunua No. 2 Block to the southern boundary of part Ngararatunua 2B3 Block; thence easterly along the northern end of Rotomate Road and the southern boundary of part Ngararatunua 2B9A1B2 Block to its south-eastern corner; thence northerly along the western boundary of Lot 2, D.P. 91800 and the eastern boundaries of part Ngararatunua 2B9A1B2 Block and part Ngararatunua D1A Block to its intersection with the southern side of Pipiwai Road; thence northerly along a right line to the intersection of the middle of the Waikoropupu

Stream and the northern side of Pipiwai Road; thence easterly generally along the middle of the Waikoropupu Stream to its intersection with the northern side of Pipiwai Road, thence easterly along the northern side of Pipiwai Road to the south-easternmost corner of Lot 1, D.P. 74384; thence easterly along a right line to the south-easternmost corner of Lot 1, D.P. 4578; thence north-easterly along a right line to the south-westernmost corner of Lot 2, D.P. 4578 and along the south-eastern boundary of that Lot 2 to its easternmost corner; thence northerly along the eastern boundaries of Lot 2, D.P. 4578, part Puriritahi Block (8 acres 1 rood 23.2 perches), Lot 1, D.P. 74448, Lot 2, D.P. 93855, Lots 3, 4 and 5, D.P. 74446, and Lot 1, D.P. 8351 to the easternmost corner of that Lot 1; thence north-easterly along a right line to the south-easternmost corner of part Tupua Block (12 acres 3 roods 11 perches); thence northerly along the eastern boundaries of that part Tupua Block and part Maungarei Block (8 acres 3 roods 20 perches) to the southernmost corner of Lot 1, D.P. 27420; thence south-easterly along a right line to the westernmost corner of Lot 1, D.P. 56390 in Block VIII, Purua Survey District; thence south-easterly and north-easterly along the south-western and south-eastern boundaries of that Lot 1 to the northernmost corner of Lot 1, D.P. 44131 and along a right line to the north-western corner of Lot 1, D.P. 27999; thence north-easterly along the north-western boundary of that Lot 1 and the south-eastern boundaries of Allotment 234, Whangarei Parish to its easternmost corner and along a right line to the southernmost corner of Lot 3, D.P. 46318; thence north-easterly and southerly along the north-western and eastern boundaries of part Allotment 21, Whangarei Parish to a point in line with the south-eastern boundary of Lot 4, D.P. 64544; thence north-easterly to and along that boundary to the northernmost corner of Allotment 88, Whangarei Parish; thence south-easterly along the north-eastern boundary of that Allotment 88 to the westernmost corner of Allotment W. 84, Whangarei Parish; thence north-easterly and south-easterly along the north-western and north-eastern boundaries of that Allotment W. 84 to a point in line with the north-western boundary of Allotment N.E. 84, Whangarei Parish; thence north-easterly to and along that boundary to its northernmost corner and along a right line to the westernmost corner of Lot 1, D.P. 90030; thence south-easterly along the south-western boundaries of that Lot 1, Lot 2, D.P. 90030, Lot 1, D.P. 93853; Lot 1, D.P. 68323 and Lot 1, D.P. 91014 to the southernmost corner of the last-mentioned Lot 1; thence north-easterly along the south-eastern boundary of that Lot 1, part Allotment 90 and Allotment 89, Whangarei Parish in Block V, Whangarei Survey District, to the right bank of the Mangakino Stream; thence south-easterly generally along the right banks of the Mangakino Stream and Hatea River to a point in line with the north-eastern boundary of Whitingaramarama Block; thence south-easterly to and along that boundary to the southernmost corner of Lot 3, D.P. 94615; thence north-easterly along the south-eastern boundary of that Lot 3, Lot 1, D.P. 94614 and the production of the last-mentioned boundary to the south-western boundary of Lot 6, D.P. 56943; thence north-westerly along that boundary to the north-western corner of that Lot 6; thence north-easterly along the north-western boundaries of Lots 6, 7, 8 and 13, D.P. 56943 to the northernmost corner of the last-mentioned Lot 13; thence south-easterly along the north-eastern boundary of that Lot 13 to the southernmost corner of Maruata 6B and along a right line to the south-westernmost corner of Lot 1, D.P. 60612; thence south-easterly and north-easterly along the south-western and south-eastern boundaries of that Lot 1 to its easternmost corner; thence north-easterly generally along the north-western side of Ngunguru Road and its production to the left bank of the Waitangi River, and along the north-western side of Ngunguru Road to the southernmost corner of Lot 1, D.P. 43545 in Block VI, Whangarei Survey District; thence north-westerly along the south-western boundaries of that Lot 1 and Lot 1, D.P. 93728 to the north-western corner of the last-mentioned Lot 1; thence north-easterly along the north-western boundaries of that Lot 1 and Lot 1, D.P. 35698 to the northernmost corner of the last-mentioned Lot 1; thence south-easterly along the north-eastern boundary of that Lot 1 and its production to the south-eastern side of Ngunguru Road; thence south-westerly along the south-eastern side of that road to the northern corner of Lot 2, D.P. 63824; thence south-easterly along the north-eastern boundary of that Lot 2 to the left bank of the Waitangi River; thence south-westerly along the left bank of that river to a point in line with the eastern boundary of part Lot 6, Deeds Plan P42; thence southerly to and along that boundary and the eastern boundary of Lot 1, D.P. 54062 to the south-western corner of part Allotment 46, Parahaki Parish; thence north-easterly along the south-eastern boundary of that part Allotment 46 to the north-eastern corner of part Allotment 106, Parahaki Parish contained in certificate of title 677/271; thence southerly along the eastern boundary of that part Allotment 106 and part Allotment 51, Parahaki Parish to the south-western corner of Allotment 53, Parahaki Parish; thence south-easterly along the south-western boundary of that Allotment 53 to Adams Road; thence southerly along the western side of Adams Road to the south-eastern corner of Lot 1, D.P. 89701, along a right line to the northernmost corner of part Allotment 128, Parahaki Parish and along the western boundary of that part Allotment 128 to the south-eastern corner of part Allotment 39, Parahaki Parish; thence westerly along the southern boundary of that part Allotment 39 to the north-eastern

corner of Allotment 123, Parahaki Parish; thence southerly along the eastern boundary of that Allotment 123 to the south-western corner of Lot 2, D.P. 82408, along a right line to the north-western corner of Lot 1, D.P. 83132, along the western boundaries of that Lot 1 and Allotment 151, Parahaki Parish to the south-westernmost corner of the last-mentioned Allotment 151, along a right line to the northernmost corner of Allotment 149, Parahaki Parish, along the western boundary of that Allotment 149 and along a right line to the north-eastern corner of part Lot 3, D.P. 24632; thence westerly along the northern boundaries of the part Lot 3 and part Lot 1, D.P. 24632 to the northern side of the legal road passing through the last-mentioned part Lot 1, along a right line to the intersection of the southern side of that road and the northern boundary of the said part Lot 1, along the southern side of Whereora Road to the north-western corner of Lot 1, D.P. 41587 in Block IX, Whangarei Survey District and along a right line to the north-eastern corner of part Allotment 86, Parahaki Parish, and along the northern boundary of that part Allotment 86 to the western corner of the said part Allotment 86; thence north-westerly along a right line to the north-eastern corner of part Allotment 85, Parahaki Parish contained in certificate of title 42A/162, and along the northern boundary of the last-mentioned part Allotment 85 to its northernmost corner; thence westerly along the southern boundary of Allotment 115, Parahaki Parish to the south-western corner of that Allotment 115; thence north-westerly along the northern boundary of part Allotment 84, Parahaki Parish to its north-westernmost corner; thence southerly along the western boundaries of part Allotment 84, Allotment 89, 90 and 91, Parahaki Parish to the south-western corner of the last-mentioned Allotment 91; thence easterly along the southern boundaries of parts Allotment W. 93, and Allotment E. 93 to the south-eastern corner of the last-mentioned Allotment E. 93 and along the northern side of Old Parua Bay Road and Abbey Caves Road to the south-easternmost corner of part Allotment 92, Parahaki Parish; thence northerly along a right line to the north-westernmost corner of part Allotment 8, Parahaki Parish; thence south-easterly generally along the generally south-western boundary of part Allotment 8, Parahaki Parish to its south-western corner; thence easterly along the southern boundary of that part Allotment 8 to the right bank of the Awaroa Creek; thence northerly generally along the right bank of that Creek to a point in line with the south-eastern boundary of part Allotment 16, Parahaki Parish; thence north-easterly to and along that boundary to the north-westernmost corner of Lot 1, D.P. 69512; thence easterly along the northern boundary of that Lot 1 to its north-eastern corner; thence north-easterly along the north-western side of Awaroa Creek Road to the north-eastern corner of Allotment N.E. 14, Parahaki Parish in Block X, Whangarei Survey District; thence south-easterly along a right line to the northernmost corner of part Allotment 7, Wariara Parish; thence south-easterly generally along the generally south-western side of Mt Tiger Road to the easternmost corner of Allotment 9, Wariara Parish, along a right line to the northernmost corner of Allotment 14, Wariara Parish, along the south-western side of Mt Tiger Road to the easternmost corner of that Allotment 14; thence south-westerly along the south-eastern boundaries of the said Allotment 14 and Allotments N. 15, S. 15, N.E. 16, S.W. 16, 17 and 18 and part 19, Wariara Parish to the westernmost corner of Allotment 24, Wariara Parish in Block IX, Whangarei Survey District; thence south-easterly along the south-western boundary of that Allotment 24 and its production to the north-western boundary of part Lot 3, D.P. 24243 in Block X, Whangarei Survey District; thence south-westerly along the north-western boundaries of that part Lot 3, Lot 1, D.P. 75041 and part Lot 3, D.P. 24243 to the westernmost corner of the last-mentioned part Lot 3; thence south-easterly along the south-western boundary of that part Lot 3 to the north-westernmost corner of part Waikaraka Block in Block XIV, Whangarei Survey District; thence south-westerly along the north-western boundary of that block and its production to the shores of the Whangarei Harbour; thence south-westerly and north-westerly generally along those shores to the south-western corner of Allotment 388A, Town of Grahamtown in Block XIII, Whangarei Survey District; thence westerly along a right line to the point of commencement.

As the same is more particularly delineated on plan No. OPS 4/1/B01, deposited in the National Headquarters of the New Zealand Fire Service and thereon bordered red.

of the last-mentioned boundary to and along the north-eastern side of Jordan Valley Road to the eastern side of Hukerenui Road; thence northerly along the eastern side of that road to the northern boundary of Section 9, Block XV, Hukerenui Survey District; thence easterly along that boundary and its production to the left bank of Wairua River; thence northerly generally along the left bank of that river and Whakapara River to a point in line with the north-eastern boundary of Puhipuhi 5C12A in Block XI, Hukerenui Survey District; thence north-westerly to and along that boundary to the southern corner of Puhipuhi 5C12B; thence north-easterly along the south-eastern boundary of Puhipuhi 5C12B to its eastern corner; thence westerly along the southern side of the North Auckland Railway to a point in line with the north-western boundary of Lot 1, D.P. 89526; thence north-easterly to and along that boundary to the eastern corner of part Section 24, Block XI, Hukerenui Survey District; thence north-westerly along the north-eastern boundary of that part Section 24 to its north-easternmost corner; thence northerly along the western boundary of part Puhipuhi 5A shown on D.P. 9567 to the left bank of Waiariki River; thence north-easterly generally along the left bank of that river to the north-western corner of Puhipuhi 5C2B; thence easterly along the southern boundary of Puhipuhi 5C1C to its south-eastern corner in Block XII, Hukerenui Survey District; thence northerly along the western side of Puhipuhi Road to the eastern corner of Puhipuhi 5C1A in Block VIII, Hukerenui Survey District; thence easterly along a right line to the western corner of part Puhipuhi 1, contained in *New Zealand Gazette*, 1885, page 1441, along the southern boundary of that part Puhipuhi 1 to its southern corner; thence south-easterly along the south-western boundary of part Section 12A, Block VIII, Hukerenui Survey District to its southern corner; thence north-easterly and south-easterly along the north-western and north-eastern boundaries of Lot 2, D.P. 18210 and the production of the last-mentioned boundary to the left bank of Kaimamaku Stream; thence north-easterly generally along the left bank of that stream to the north-eastern boundary of part Section 9, Block XII, Hukerenui Survey District shown on S.O. Plan 1862; thence south-easterly along that boundary and the north-eastern boundary of Section 68, Block XII, Hukerenui Survey District and its production to the south-eastern side of Russell Road; thence south-westerly along the south-eastern side of that road to the south-western corner of part Lot 1, D.P. 29564; thence north-easterly along the north-western side of Whimp Road to the westernmost corner of Section 33, Block XII, Hukerenui Survey District; thence south-easterly generally along the north-eastern side of the legal road passing through part Section 13, Block XII, Hukerenui Survey District forming part of the south-western boundary of Lot 3, D.P. 21823 to the northernmost corner of Lot 2, D.P. 21823; thence southerly along the eastern side of Enwright Road to the southern corner of Section 55, Block XII, Hukerenui Survey District, along a right line to the north-western corner of Section 58, Block XII, Hukerenui Survey District, along the western boundary of that Section 58, the eastern side of the legal road passing through part Section 15, Block XII, Hukerenui Survey District contained in certificate of title 24B/1499 and the western boundary of Section W. 12, Block XII, Hukerenui Survey District to its southern corner; thence north-easterly and south-easterly along the north-western and north-eastern boundaries of part Section 1, Block XII, Hukerenui Survey District shown on D.P. 23759 to its south-eastern corner; thence north-easterly along the north-western boundary of part Section 3, Block XVI, Hukerenui Survey District to the western side of Otonga Marua Road; thence southerly along that western side to the north-western side of Marua Road, along a right line to the north-easternmost corner of Section 4, Block XVI, Hukerenui Survey District, along the western side of Jellick Road to its south-western corner; thence easterly along the southern end of that road to the north-western corner of Section 46, Block XI, Opuahanga Survey District; thence southerly along the western boundaries of that Section 46 and Section 48, Block XI, Opuahanga Survey District to the southern corner of the last-mentioned Section 48 and along a right line to the north-westernmost corner of Section 22A, Block XI, Opuahanga Survey District; thence south-westerly generally along the generally south-eastern side of the legal road forming the generally north-western boundaries of Lot 2 of Section 7, Block XVI, Hukerenui Survey District, Allotments 152, N.E. 50, S.W. 50 and N.W. 52, Hikurangi Parish to the northernmost boundary of Allotment 157, Hikurangi Parish; thence westerly along that boundary and the northern boundary of Allotment S.E. 53, Hikurangi Parish to its north-western corner; thence southerly along the western boundary of that Allotment S.E. 53 to its south-western corner; thence westerly along the northern boundary of Allotment 144, Hikurangi Parish to its north-western corner; thence southerly and westerly along the eastern and southern boundaries of Allotment S.W. 55, Hikurangi Parish in Block V, Purua Survey District to its south-western corner; thence southerly along the westernmost boundary of Allotment 157 and the western boundaries of Allotments 146 and Part 57, Hikurangi Parish to the north-western boundary of Allotment 14, Hikurangi Parish; thence south-westerly and south-easterly along that boundary and the south-western boundary of that Allotment 14 and the production of the last-mentioned boundary to the left bank of Mangahuru Stream; thence south-easterly generally along the left bank of that stream to the eastern side of the North Auckland Railway passing through part Allotment 35, Whangarei Parish; thence southerly generally along the generally

thence north-easterly and south-easterly along the north-western and north-eastern boundaries of Allotment 602, Waipu Parish and the production of the last-mentioned boundary to the north-western boundary of Allotment 397A, Waipu Parish; thence south-westerly and south-easterly generally along the north-western and generally south-western boundaries of Allotment 397A, Waipu Parish to the left bank of the Waipu River; thence easterly along the left bank of the Waipu River to the sea coast; thence southerly along a right line to the intersection of the sea coast and the right bank of the Waipu River; thence south-easterly along the right bank of the Waipu River to the south-westernmost corner of part Allotment 398A, Waipu Parish, and the generally south-western boundaries of Allotments 503 and 528, Waipu Parish and the production of the last-mentioned boundary to the western boundary of part Allotment 301 as shown on D.P. 21517 in Block VII, Waipu Survey District; thence northerly along the western boundary of the last-mentioned part Allotment 301 to the sea coast; thence southerly generally along that sea coast crossing the mouths of all inlets and along the left bank of Wairahi Stream in Block VII, Waipu Survey District to a point in line with the generally northern boundary of Lot 1, D.P. 58222; thence westerly generally and southerly to and along that generally northern boundary and the western boundary of that Lot 1, to the easternmost corner of Lot 2, D.P. 36810; thence north-westerly generally along the north-eastern boundaries of that Lot 2, Allotment 302, 346 and 339, Waipu Parish, part Lot 2, D.P. 28344, Lot 1, D.P. 75786 and Lot 1, D.P. 28344 to its northernmost corner; thence south-westerly along the north-western boundary of that Lot 1, to Cullen Road, along a right line to the northernmost corner of Allotment 338, Waipu Parish and along the south-eastern boundaries of part Allotment S.E. 135 and Allotment S.E. 134, Waipu Parish to the southernmost corner of the last-mentioned Allotment 134; thence north-westerly and south-westerly along the north-eastern and north-western boundaries of Allotment 133, Waipu Parish to the easternmost corner of Allotment N.E. 127, Waipu Parish; thence north-westerly along the north-eastern boundary of that Allotment N.E. 127 in Block VI, Waipu Survey District to its northernmost corner, along a right line to the easternmost corner of Allotment 127A, Waipu Parish, along the north-eastern boundary of that Allotment 127A to its northernmost corner, along a right line to the easternmost corner of Section 6, Block VI, Waipu Survey District and along the north-eastern boundary of that Section 6 to its northernmost corner; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of part Allotment 35, Waipu Parish to its westernmost corner; thence south-westerly along a right line to the northernmost corner of Section 9, Block VI, Waipu Survey District, along the north-western boundary of that Section 9 to its westernmost corner; thence north-westerly and north-easterly along the south-western and north-western boundaries of part Allotment 129, Waipu Parish to a point in line with the south-western boundary of Allotment 456, Waipu Parish in Block III, Waipu Survey District; thence north-westerly to and along that boundary and the generally north-eastern boundary of Section 17, Block III, Waipu Survey District to its northernmost corner; thence northerly generally westerly generally and southerly along the generally eastern, generally northern and western boundaries of part Section 2, Block III, Waipu Survey District to the easternmost corner of Lot 1, D.P. 69472; thence westerly along the northern boundaries of that Lot 1, and Section 13, Block III, Waipu Survey District to its northernmost corner and along a right line to the north-eastern corner of part Allotment 229, Waipu Parish; thence southerly along the eastern boundaries of the said Allotment 229 and Allotment 85, Waipu Parish to its southernmost corner in Block II, Waipu Survey District; thence easterly and southerly along the northern and eastern boundaries of part Allotment 84, Waipu Parish in Block VI, Waipu Survey District contained in certificate of title 595/329 to its southernmost corner and along the eastern boundary of part Allotment 62, Waipu Parish to the easternmost corner of Allotment 61A, Waipu Parish; thence westerly along the southern boundaries of the said Allotment 61A and Lot 1, D.P. 45580 in Block V, Waipu Survey District to its south-western corner; thence south-westerly along a right line to the north-westernmost corner of part Allotment 112, Waipu Parish, along the north-western boundary of the said part Allotment 112 and its production to the left bank of the

Waihoihoi River; thence southerly generally along that left bank and the western boundary of Allotment 113 and part Allotment 115, Waipu Parish to its westernmost corner; thence easterly, southerly and westerly along the northern, eastern and southern boundaries of part Allotment 114, Waipu Parish to the easternmost corner of Allotment 599, Waipu Parish and continuing westerly along the southern boundaries of the said Allotment 599 and land taken for use, convenience and enjoyment (by *New Zealand Gazette* 1960, p. 371) to State Highway No. 1, along a right line to the easternmost corner of part Allotment 548, Waipu Parish and along the northern boundary of that part Allotment 548 to its northernmost corner; thence southerly along the western boundary of the said part Allotment 548 to the easternmost corner of part Allotment 317, Waipu Parish; thence westerly along the northern boundary of the said part Allotment 317 and along a right line to the southernmost corner of Allotment 207, Waipu Parish along the southern boundaries of that Allotment 207 and Allotment 573, Waipu Parish and northern boundaries of Allotment 577 and part Allotment 317, Waipu Parish to its westernmost corner; thence north-westerly along a right line to the southernmost corner of Allotment 370, Waipu Parish; thence north-easterly and north-westerly along the south-eastern and north-eastern boundaries of the said Allotment 370 to its northernmost corner, thence north-easterly, north-westerly and south-westerly along the south-eastern, north-eastern and north-western boundaries of Allotment 369, Waipu Parish to the southernmost corner of Allotment 211, Waipu Parish; thence north-westerly along the generally north-eastern boundaries of Allotments 211A, 251A, 251 and part Allotment 51, Waipu Parish and the production of the last-mentioned boundary to the northern side of Finlayson Brook Road in Block IV, Waipu Survey District; thence northerly along the eastern boundary of part Allotment 203, Waipu Parish and the western boundary of Allotment 328, Waipu Parish in Block II, Waipu Survey District to its north-western corner; thence north-easterly along the north-western boundaries of Allotments 328, 325 and 283 Waipu Parish to the northernmost corner of the said Allotment 283; thence south-easterly, north-easterly and north-westerly along the south-western, south-eastern and north-eastern boundaries of Allotment 284, Waipu Parish to the westernmost corner of Allotment 256, Waipu Parish; thence north-easterly generally along the generally south-eastern boundary of Allotment 382A to the westernmost corner of Allotment 258, Waipu Parish; thence south-easterly along the north-eastern boundary of the said Allotment 258 to its easternmost corner; thence northerly and easterly along the western and northern boundaries of part Allotment 32, Waipu Parish contained in certificate of title 567/105 to the left bank of the Ahuroa River; thence northerly generally along that left bank to the south-western boundary of Allotment 589, Waipu Parish; thence north-westerly, northerly and south-easterly along the south-western, western and north-eastern boundaries of that Allotment 589 to the left bank of the Ahuroa River; thence north-easterly along that left bank to the easternmost corner of part Allotment 198, Waipu Parish; thence north-westerly along the south-western boundary of part Allotment 68, Waipu Parish to the southern side of Ahuroa Road, along a right line to the intersection of the northern side of Ahuroa Road and the south-western boundary of the said part Allotment 68 and along the south-western boundaries of that part Allotment 68, Allotment 268 and Allotment 70, Waipu Parish to its westernmost corner; thence south-westerly generally along the north-western side of Allotment 269, Waipu Parish to the eastern side of Walters Road, along a right line to the northernmost corner of Allotment 270, Waipu Parish and along the generally north-western boundaries of that Allotment 270, and Allotments 176, 175 and 276, Waipu Parish to its north-western corner thence north-westerly along a right line to the easternmost corner of Allotment 288, Waipu Parish; thence south-westerly along the north-western boundary of that Allotment 288 to its westernmost corner; thence northerly along the generally western boundary of Allotment 289, Waipu Parish to a point in line with the northern boundary of Allotment 180, Waipu Parish; thence westerly to and along that boundary to the southernmost corner of Allotment 290, Waipu Parish in Block I, Waipu Survey District; thence northerly along the generally eastern boundary of that Allotment 290 to the southern side of a legal road and along a right line to the southernmost corner of Allotment 291 Waipu Parish; thence westerly and northerly along the southern and western boundaries of that Allotment 291 to its westernmost corner; thence northerly along the eastern boundary of Allotment 215, Waipu Parish to its northernmost corner in Block XII; Ruakaka Survey District; thence easterly along the northern side of Allotment 216, Waipu Parish to a point in line with the eastern boundary of Lot 4, D.P. 33258; thence northerly to and along that boundary to the northernmost corner of that Lot 4, and along a right line to the point of commencement.

As the same is more particularly delineated on plan No. OPS 4/1/1B21 deposited in the National Headquarters of the New Zealand Fire Service and thereon bordered red.
