APPLICATIONS AND BIDS CLOSE ON 2 FEBRUARY 1987 AT 5 P.M.

PURSUANT to the Import Control Regulations 1973 (S.R. 1980/246), I, P. E. Donovan, Deputy Secretary (Industries) of the Department of Trade and Industry, acting under delegated authority hereby announce the availability of certain licence units left unpaid from Rounds 34 and 36 at the prices shown. The continuity provision will not apply to these licence.

Application for the units shown should be made on form T. & I. 401 and should reach the Registrar of Tenders, P.O. Box 3146, Wellington no later than 5 p.m. on 2 February 1987.

Where demand exceeds supply, the allocation of licence will be by random computer selection. Any licence remaining after this initial allocation will be treated as residual licence and be available at the prices shown.

Payment should be made against the results letter. A period of 1 month will be allowed.

PURSUANT to the Import Control Regulations 1973, Amendment No. 3 (S.R. 1980/246), and within the terms of the Australia - New Zealand Closer Economic Relations Trade Agreement (ANZCERTA), I. P. E. Donovan, Deputy Secretary of Trade and Industry hereby call for tenders for import licences (Tendered Exclusive Australian Licences or TEALS) for the goods specified below.

UNUSED 1985/86 MEALS

1. Amounts for tender in Part I are the Manufacturers Exclusive Australian Licences (MEALS) taken up but not used in the 1985/86 import licensing year. CALENDAR YEAR ANZCERTA LICENCES

3. Tendered in Part II are the ANZCERTA annual allocations for those products made available on a calendar year basis. These are rubber products, synthetic carpet, and some wood panel products.

SUBMISSION OF BIDS

4. All tenders close at 5 p.m. on Monday, 2 February 1986. with The Registrar, Import Licence Tendering, Department of Trade and Industry, P.O. Box 3146, Wellington. No late tenders can be accepted. Tenders must be mailed to the above address in time to arrive before the closing time or be delivered by hand to the First Floor Reception, Bowen State Building, Bowen Street, Wellington. Envelopes should be clearly marked "ANZCERTA Import Licence Tender" on the bottom right-hand corner.

BIDS AND BID FORMS

5. This Supplement to the *New Zealand Gazette* will be sent to all persons and organisations on the Register of Tenderers. Prospective tenderers not on the Register of Tenderers can purchase the *Gazette* at the bookshops of the Government Printer. Registered tenderers will also be sent bid forms. Other persons can obtain these from the Department of Trade and Industry. Application forms for entering on to the Register of Tenderers can be obtained from the Department of Trade and Industry.

6. The bid forms to be used are printed on green coloured paper and are marked 'T. & I. 335D' or on pink paper, T & I 335E. They are the same forms as are used for global import licence tenders.

MEAL HOLDERS

7. Except for the calendar year licences tendered in Part II manufacturers are permitted to tender in the same item codes in which they currently hold MEALS provided they used at least 75 percent of any MEAL they held in 1985/86.

TENDER AMOUNTS

8. All licences are tendered in units of \$2,000 CIF. Tenderers may bid for all or any number of the units available. All licences won by a tendered in each tender number will be aggregated into one licence. One invoice will be issued for the amount of the premium due for each tender number.

LICENCE PERIOD

9. The licensing year licences being tendered in Part I of this round will all be valid until 30 June 1987. The calendar year licences being tendered in Part II of this round will be valid until 31 December 1987. Extension to the licence periods will be granted only in very exceptional circumstances. These circumstances are detailed in the 'Guide to Global Import Licence Tendering' and also apply to ANZCERTA licence.

RULES OF ORIGIN

10. ANZCERTA import licences may only be used to import goods of Australian origin. The rules of origin for Australian goods are contained in the Customs Regulations 1968, as amended, and in Article 3 of the ANZCER Trade Agreement.

MOTOR VEHICLES AND COMPONENTS

11. Access arrangements for most motor vehicles and parts for motor vehicles are provided for by the Motor Vehicle Industry Plan. ANZCERTA TEALS cannot be used to import these goods. Licences for item codes in which motor vehicle parts fall will have their product coverage endorsed "excluding those of a kind commonly used with the vehicles specified in Appendix B attached". A copy of Appendix B will be attached to relevant licences. It reads:

(1) Pursuant to Annex C of the ANZCER Trade Agreement, in the item codes listed below, the Exclusive Australian Licences are only available for goods EXCLUDING components of a kind commonly used with:

- (a) Tractors for articulated vehicles, being tractors that are designed for operation solely or principally on the highway; or
(b) Vehicles of Tariff Heading 87.02, other than air-cushioned vehicles or assembled convertible road/rail motor coaches.

RESIDUAL EXCLUSIVE AUSTRALIAN LICENCES
