NOTICE is hereby given that I intend to exercise the power conferred on me by section 14 of the International Air Services Licensing Act 1947 to amend the terms of International Air Services Licence issued to Continental Airlines to permit the airline to operate DC10 and B747 aircraft on the routes San Francisco/Los Angeles – Honolulu – Auckland – Sydney/Melbourne and San Francisco/Los Angeles – Papeete – Auckland – Sydney/Melbourne.
