TENDERS CLOSE ON 9 NOVEMBER 1987 AT 5 P.M.

PURSUANT to the Import Control Regulations 1973 (S.R. 1980/246), I, P. E. Donovan, Deputy Secretary of Trade and Industry, acting under delegated authority call tenders for the goods specified below. Tenders close on the 9th November 1987 at 5 p.m. and must be received by the Registrar of Tenders by then to be valid.

Instructions for tenders and the general terms and conditions which apply to the submission and acceptance of tenders are set out in the Guide to Global Import Licence Tendering dated November 1986, as amended by notice in the *New Zealand Gazette*, No. 62, dated 30 April 1987. Bids may be submitted through the departmental bureaufax system. Tenders should be addressed to the Registrar of Tenders, P.O. Box 3146, Wellington, or Bureaufax (04) 734 638 or be delivered by hand to the First Floor of the Bowen State Building, Wellington. Tenders for Round 54 must reach the Registrar no later than 5 p.m. on Monday, 9th November 1987.

FOOTWEAR INDUSTRY DEVELOPMENT PLAN

FINISHED FOOTWEAR: NINTH ALLOCATION

This is the ninth round held under the Footwear Industry Development Plan, and is the second on a value basis (as a result of the 1986 review of the FIDP). Continuity licence is now available and the limit on the amount that can be won by a single tenderer is removed.

Those bidding should note that tariff levels on footwear are to be changed on 1 July 1988.

Licences will be valid 1 January 1988 to 31 December 1988.
