HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Whereas, pursuant to section 43 (4) of the Auckland Regional Authority Act 1963, the Auckland Regional Authority is entitled to exercise all the powers, authorities, and discretions vested in the Auckland Metropolitan Drainage Board by the Auckland Metropolitan Drainage Act 1960.

And whereas the said Auckland Regional Authority has petitioned His Excellency the Governor-General that certain areas of Waitemata City be included within the Inner Area of the Auckland Metropolitan Drainage District.

Now therefore, pursuant to section 8 of the Auckland Metropolitan Drainage Act 1960, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

Order

1. Title and commencement—(1) This order may be cited as the Auckland Metropolitan Drainage District Order (No. 2) 1987.

(2) This order shall come into force on 1 November 1987.

2. Boundary altered—The boundary of the inner area of the Auckland Metropolitan Drainage District is hereby altered so as to include the areas defined in the Schedules hereto.

3. Determination of financial obligations—The financial obligations and assessments under the Auckland Metropolitan Drainage District Act 1960 of the Waitemata City Council with respect to the land defined in the Schedules hereto shall be determined on and from 1 November 1987.

First Schedule

All that area in the North Auckland Land District, City of Waitemata, bounded by a line commencing at a point on the line of mean high water mark spring tide of the Manukau Harbour being the production of the north-eastern boundary of part Allotment 294, Waikomiti Parish, in Block VII, Titirangi Survey District, and proceeding north-westerly generally along the boundary of the inner area of the Auckland Metropolitan Drainage District as described in the Third Schedule of section 4 of the Auckland Metropolitan Drainage Act 1960 to the northernmost corner of Lot 60, D.P. 36329; thence southerly generally and north-westerly generally along the boundary of the inner area of the Auckland Metropolitan Drainage District as described in *New Zealand Gazette*, 1970, page 98, to the southernmost corner of Lot 59, D.P. 36329; thence south-westerly generally along the boundary of the inner area of the Auckland Metropolitan Drainage District as described in the Third Schedule of section 4 of the Auckland Metropolitan Drainage Act 1960, to the southernmost corner of Lot 1, D.P. 54109; thence westerly generally along the boundary of aforesaid district as described in *New Zealand Gazette*, 1966, page 150 to the north-western corner of Lot 6, D.P. 16793, to and along the boundary of the inner area of the aforesaid district as described in *New Zealand Gazette*, 1980, page 900, to the north-westernmost corner of Lot 3, D.P. 54666, to and along the boundary of the inner area of the aforesaid district as described in *New Zealand Gazette*, 1982, page 1014, to the easternmost corner of Lot 35, D.P. 20025; thence

northwesterly generally along the boundary of the inner area of the aforesaid district as described in the Third Schedule of section 4 of the Auckland Metropolitan Drainage Act 1960, to the intersection of the northern side of Woodlands Park Road and the western side of Scenic Drive; thence westerly along the northern side of Woodlands Park Road to the northernmost corner of an area of 0.07 perches shown on S.O. Plan 23931; thence westerly and south-westerly generally along the boundary of the Auckland Metropolitan Drainage District as described in the First Schedule of section 3 of the Auckland Metropolitan Drainage Act 1960 to the north-western corner of Lot 31, D.P. 39183, Block VI, Titirangi Survey District; thence southerly and westerly generally along the generally eastern and southern boundaries of part Lot 1, D.P. 35700, to the south-westernmost corner of the last-mentioned part of Lot 1; thence south-westerly along the boundary of the Auckland Metropolitan Drainage District as described in the First Schedule of section 3 of the Auckland Metropolitan Drainage Act 1960, to the northernmost corner of Lot 2, D.P. 50278; thence south-easterly generally along the generally south-western boundaries of the last-mentioned Lot 2 to the north-western corner of Lot 5, D.P. 22144; thence southerly along the western boundary of the last-mentioned Lot 5 to its south-western corner; thence south-westerly along a right line across Huia Road, to the southernmost corner of an area marked Road Reserve, as shown on D.P. 22144, 8 square metres (0.3 perches), (now part Huia Road) and continuing south-westerly along the north-western boundaries of Lots 23, 22, 21, 20, 19, 18, 17, 16, 15, 14 and 13, D.P. 22144 to the northernmost corner of Lot 1, D.P. 24312; thence south-easterly generally along the generally north-eastern boundaries of the last-mentioned Lot 1 and the generally north-eastern boundaries of Lot 2, D.P. 24312, to the south-easternmost corner of the said Lot 2; thence easterly along the northern boundary of part Lot 1, D.P. 63221 to its north-eastern corner, thence northerly along the eastern boundary of Lot 144, D.P. 30907 to its intersection with the southern corner of part Lot 2, D.P. 45596; thence north-easterly and north-westerly along the south-eastern and north-eastern boundaries of the last-mentioned part Lot 2 to the southernmost corner of Lot 1, D.P. 45596; thence northerly along the eastern boundaries of the last-mentioned Lot 1 to its northernmost corner, thence easterly along the northern boundary of part Allotment 22, Waikomiti Parish, (comprised in certificate of title 778/67), crossing the intervening Laingholm Drive to the north-eastern corner of an area marked E, as shown on S.O. Plan 58583; thence southerly along the eastern boundaries of the said area marked E to its intersection with the north-eastern side of Deirdre Place; thence south-easterly along the said north-eastern side of Deirdre Place, bearing 130°37', distance 23.00 metres to its intersection with the line of mean high water mark spring tide of the Manukau Harbour; thence north-easterly generally along the boundary of the Auckland Metropolitan Drainage District as described in the First Schedule of section 3 of the Auckland Metropolitan Drainage Act 1960, to the point of commencement.

Second Schedule

All that area in the North Auckland Land District, City of Waitemata, bounded by a line commencing at a point on the boundary of the inner area of the Auckland Metropolitan Drainage District, as described in the Second Schedule of *New Zealand Gazette*, 1975, page 812, being the intersection of the south-eastern side of West Coast Road and the production south-easterly of the north-eastern boundary of Lot 1, D.P. 24748, Block II, Titirangi Survey District and proceeding north-westerly along a right line across West Coast Road, to and along the south-western boundary of part Allotment 251, Waikomiti Parish, (comprised in certificate of title 568/123) to its westernmost corner, thence north-easterly along the north-western boundary of the last-mentioned part Allotment 251 and the north-western boundary of part Allotment 251, Waikomiti Parish, (comprised in certificate of title 568/124) to

its northernmost corner; thence south-easterly along the north-eastern boundary of the last-mentioned part Allotment 251 and that last-mentioned boundary produced across West Coast Road to its south-eastern side; thence south-westerly along that south-eastern side of West Coast Road to the point of commencement.

Indecent Publications Act 1963

Decision No. 16/87

Reference No.: IND 23/84

Before the Indecent Publications Tribunal

In the matter of the Indecent Publications Act 1963, and in the matter of an application by the Comptroller of Customs for a decision in respect of the following publication: *Black Men, White Men*:

Chairman: Judge R. R. Kearney.

Members: H. B. Dick, R. Barrington, A. J. Graham and K. Hulme.

Hearing at Wellington on the 11th day of September 1987.

Appearances: M. J. Wotherspoon for applicant. No appearance for respondent.

Decision

This publication was privately imported through the port of Whangarei in June 1984 and seized by the Comptroller of Customs as being indecent. The importer disputed the forfeiture and the book was referred to the tribunal prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

The application came on for hearing before the tribunal as then constituted on 13 December 1984, and the only member of that tribunal who is still a member was H. B. Dick. For reasons which are not apparent from the file and cannot be recalled by the then chairman, no decision was given in respect of the publication. On the occasion of the original hearing K. Wild made submissions on behalf of the importer and no written representations appear on the file from the importer or from persons having an interest in the book. The opposition of the Comptroller of Customs to the book was principally on the basis that the book dealt with the topic of male homosexuality in a way which, because of the law as it then was, would make the book indecent in New Zealand.

In submissions on behalf of the Comptroller of Customs when the matter came before us on 11 September, Mr Wotherspoon had this to say:

"This book is an anthology of stories, interviews, poems and photographs dealing with male homosexuality. While the publication appears to have some literary merit, the topics and the inclusion of photographs of single nude males may warrant an age restriction. The majority of stories in the publication are well written, and some indeed have considerable literary merit."

The tribunal is satisfied that the publication is a serious one and that it has a limited market amongst male homosexuals. The tribunal accordingly classifies this publication as not indecent.

Much of the written material is of a coarse and lewd kind, and

clearly designed to attract the prurient. That which concerns the tribunal is the portrayal of models in acts of multiple sex and a 7 page photographic presentation of 2 females engaged in explicit sexual acts.

The tribunal is satisfied that this publication is indecent as being injurious to the public good and accordingly classifies it as unconditionally indecent.

Decision

These publications were part of a commercial shipment imported by Exchange Traders through the port of Dunedin in or about February 1987. The publications were seized by the Collector of Customs and the importer has disputed seizure. The books have been submitted to the tribunal by the Comptroller of Customs for classification and decision. Having read and considered all of the publications, and considered the submissions of Mr Wotherspoon and Mr Highly, the tribunal has determined that it is sensible to deal with the publications in groups.

Kinky Couples Special; *Porn Discoveries Special*, No. 8; *X-Rated Cinema*; *X-Rated Video*; *Erotic X-Film Guide Guide*, Vol. 4, No. 5 and No. 1, *Velvet Talks*, Vol. 8, No. 4; *Velvet Talks*, June 1986; *Group Love*, No. 6; *Lovers in Action*; *Candi*, Vol. 9, No. 37; *Luscious*, Vol. 1, No. 2; *Exclusive*, Vol. 4, No. 9; *Lovebirds*, No. 76:

All of these publications are very similar in their presentation. They are soft-covered magazines, and in most cases are principally pictorial displays of nude and partly nude males and females, with some text almost entirely devoted to the prurient aspects of sexual activity. There is little, if any, presentation in the magazines which might be considered as of a serious nature, and no one could pretend for the productions that they had any artistic or literary merit. Each of the magazines contains numerous multiple model scenes of sexual activity between men and women, and between women, and such presentations the tribunal unanimously finds would be injurious to the public good in the way contemplated by the

legislation. The publications in the tribunal's finding are clearly indecent, and the tribunal classifies them as of conditionally indecent.

Hustler, February 1980; *Hustler*, December 1980; *Best of Hustler*, Vol. 9; *Hustler*, March 1984, *Hustler*, May 1984:

The *Hustler* magazines are published in the United States of America by Larry Flint who is also chairman of the board of directors. Various issues of *Hustler* magazine have been referred to the tribunal over the years, and on each occasion the tribunal has found the publications in question to be unconditionally indecent.

The magazines are well produced and contain a mixture of articles, reviews, humour and fiction. Some of this material is of a very high standard and certainly unobjectionable in terms of the indecent publications legislation. Much of the content is obviously well researched and certainly well written, and makes for interesting and entertaining reading. The tribunal is unanimous in its finding however that a significant amount of material in these publications is clearly indecent in terms of the Indecent Publications Act. There are photographs of many persons engaged in a variety of sexual activity, and of female models engaged in lesbian sexual acts. In addition, there are numerous photos of a single female model where the poses are clearly designed to emphasise the genitalia, and in many of those photographs those depictions by themselves have caused some of the members of the tribunal at least to consider whether they would justify an indecent classification for the publication.

When one balances the excellent material in these publications against the offensive and objectionable material in terms of the Indecent Publications Act, the final assessment in the tribunal's unanimous decision is not to overcome the objectionable material and accordingly each of these publications is classified as unconditionally indecent.

Christina's Island; Christina's Sins; Christina's Promise; Christina's World; Christina's Nights; Christina's Treasure; Christina's Rapture; Christina's Quest; Christina In Love; Christina's Hunger; Christina's Delight; Christina's Bliss; Christina's Escape; Christina's Ecstasy; Christina's Surrender; Song For Christina; Christina's Passion

Some of the Christina series has previously been submitted to the tribunal, and in decision 6/84 on 13 December 1983 *Christina's Secret* was classified unconditionally indecent. More recently, following the tribunal's hearing on 3 December 1986, the novel *Christina's Touch* was declared by the tribunal to be unconditionally indecent. Each of these publications is an account of the sexual adventures of the heroine, Christina. In each there is what can only be described as a very tenuous plot to link the various sexual encounters that Christina and others engage in. The descriptions of the various and many sexual encounters are graphic in the extreme and cover a wide range of explicit sexual activity. The novels, if indeed one could fairly classify them as such, have little if any literary merit, are clearly intended to attract and indulge the interest of the prurient reader, and the cumulative effect in each of the books of the succession of sexual encounters portrayed in considerable intimate detail is such as to justify the Tribunal's clear view a classification of unconditionally indecent. They are classified accordingly.

Emanuelle; Emanuelle 2; Randiana; Joy:

These 4 publications are not unlike the Christina publications and might well have been written by the same series of writers. *Emanuelle* is a translation of a modern French novel, and is an account of the sexual obsessions of a young wife who flies to Bangkok to join her husband in the diplomatic community there. In 1973 in decision 698 the tribunal classified *Emanuelle*

as indecent. The publications have nothing to commend them by way of literary merit or serious writing, and the total effect is such as to justify in the tribunal's clear view a decision that they are unconditionally indecent. *Randiana* has no real plot at all, and consists simply of a series of sexual exploits loosely hung together to make a sequence of sexual encounters and experiences. The novel *Joy* is also said to be a translation from the French, and it too is a very loosely connected and explicit sequence of alleged sexual exploits, encounters and experiences. The book has no literary merit in the view of the tribunal, is poorly written and is clearly indecent in terms of the legislation. The tribunal being satisfied that this publication, as with the others, would be injurious to the public good, classifies it and *Randiana* as unconditionally indecent. Mr Highley, in his submission to the tribunal, informed the tribunal that much of the material was in fact unsolicited material provided to him by overseas contacts, and he also informed the tribunal that he had seen the Christina novels freely available in other shops and outlets in the Dunedin area. Mr Highley did not advance any submissions to the tribunal to the effect that any of these publications should not be declared unconditionally indecent other than the general submission to the effect that much of the material was relatively harmless.

A number of previous issues of *Drummer* have been submitted to the tribunal and have previously been given unconditionally indecent classifications, with a 2 year serial restriction order made pursuant to section 15 (a) of the Indecent Publications Act 1963. Those orders are set out in decision No. 1056. A further decision of the tribunal, No. 1065, dealt with other copies of this publication.

The earlier decisions of the tribunal in respect of this publication dealt principally with the issue of depicting and supporting homosexual activity, which at that time was illegal in New Zealand.

Since the passing of the Homosexual Law Reform Act the tribunal has classified a number of homosexual magazines in terms other than unconditionally indecent, and in the main putting an R18 classification of them. The tribunal is, however, in respect of this publication, satisfied that an unconditionally indecent classification is justified.

The magazine is quite clearly a male homosexual magazine, and it has a very strong pictorial and written emphasis towards bondage and sado-masochism. A great deal of the written material in the magazine is concentrated on rather coarse and crude portrayals of homosexual activity. That feature of the publication, which in the tribunal's view, as indicated, clearly justifies an unconditionally indecent classification, is the emphasis on bondage and sado-masochism. In the tribunal's finding such portrayals, either in pictorial or written form, are clearly injurious to the public good and indecent in terms of the Indecent Publications Act. The publication is accordingly classified unconditionally indecent.

In his submission on behalf of the Comptroller of Customs, Mr Wotherspoon pointed out that although the magazine was more restrained than similar publications submitted to the tribunal and lacked the multiple models and excessive intimacy scenes in such magazines, that the poses nevertheless were presented in such a way as to warrant at least a restriction by age in respect of those persons who might have access to the publication.

Whilst some members expressed some concern at the significant emphasis on the male genitalia, the tribunal was nevertheless unanimous that all that was required for this publication was that it be classified as indecent in the hands of persons under the age of 18 years, and so classifies it.

The tribunal is satisfied that these magazines come within the category of hardcore pornography and have little to commend them. There is no text in any of the publications or articles that

could in any way be used to balance the impact of the photographs if that in fact were possible.

The tribunal is unanimous in its decision that these publications are clearly injurious to the public good and indecent in terms of the legislation, and each is accordingly classified as unconditionally indecent.
