Plants Act 1970

Notice of Prohibition of the Importation of *Alstroemeria* (Notice No. 4250)

Pursuant to section 6 of the Plants Act 1970, I hereby restrict the introduction into New Zealand of all *Alstroemeria* plants growing under sterile conditions in flasks or similar containers from all countries unless I am satisfied the importation will not introduce virus diseases not known to be present in New Zealand. All imports of the above plants shall be subject to prior approval by permit to import issued by the officer-in-charge of the Ministry of Agriculture and Fisheries Plant Protection Centre at Lynfield, Auckland.

This notice shall take effect on the day following its publication in the *Gazette*.

Emergency Restrictions on Importation of Fresh Fruit (Notice No. 4251)

Pursuant to section 6 of the Plants Act 1970, I hereby prohibit the importation of fresh fruit of the family Cucurbitaceae from Australia unless the fruit is accompanied by an international health certificate endorsed to the effect that the fruit has been inspected and found free from infestation by fruit fly larvae (family tephritidae) and has been fumigated in accordance with the Schedule affixed hereto.

Schedule

Fumigation requirements of fresh fruit of the Cucurbitaceae family imported into New Zealand from Australia.

Pressure: Atmospheric.

Fumigant: Ethylene Dibromide.

Rate: 22 grams per cubic metre.

Time period: 2 hours minimum.

Flesh temperature of fruit: 20°C or above.

At no time during the fumigation process is the fumigation chamber to be loaded above 50 percent of its capacity for holding fruit.

This notice shall take effect on the day following its publication in the *Gazette*.

Short title and commencement—(1) This notice may be cited as the Customs Exchange Rates Notice (No. 25) 1987.

(2) This notice shall come into force on the 7th day of December 1987.

Exchange rates—Where under any provisions of the Customs Act 1966 any amount which is required to be taken into account for the purpose of assessing duty or any other purpose is not an amount in New Zealand currency, the amount to be so taken into account shall be the equivalent in New Zealand currency of that amount ascertained in

accordance with the rate of exchange set out in the Schedule to this notice.

Electricity Act 1968

Stewart Island County Council Electricity Supply Licence 1987

David John Butcher, Minister of Energy, acting pursuant to section 20 of the Electricity Act 1968, hereby licence Stewart Island County Council, hereinafter called the electrical supply authority to supply electricity, and to lay, construct, put up, place and use all electric lines and works which may from time to time be required for the distribution and supply of electricity within the area specified in the Schedule hereto.

This licence is issued subject to the following conditions.

Conditions

This licence may be cited as the Stewart Island County Council Electricity Supply Licence 1987.

The electrical supply authority shall comply with the provisions of this licence, the Electricity Act 1968 and all enactments made in amendment of or substitution for that Act, any electrical codes of practice made under that Act, the Electrical Supply Regulations 1984, the Electrical Wiring Regulations 1976 and all regulations made in amendment of or substitution for any of those regulations.

Any notice to be given to the electrical supply authority shall be sufficient if sent by registered post letter to the offices of the electrical supply authority.

Any notice to be given on the part of the Minister of Energy shall be sufficient if given in writing signed by the Minister or by any persons acting under the authority of the Minister.

Any notice to be given to the Minister of Energy shall be sufficient if given in writing to or sent by registered post letter addressed to the Secretary of Energy, Ministry of Energy, Wellington.

This licence shall come into force on the 16th day of November 1987 and shall continue in force until the 31st day of March 2008, unless it is sooner lawfully determined in accordance with clauses 7 or 8 hereof.

The Governor-General in Council may, pursuant to section 2 of the Electricity Act 1968, cancel this licence if the electrical supply authority is in breach of the provisions contained in clause 2 of these conditions.

This licence may be cancelled by the Minister of Energy at the request of or with the consent of the electrical supply authority.

At the expiry or cancellation of this licence, the electrical supply authority shall as required by notice in writing by the Minister of Energy remove all buildings, poles and other erections and all transmission lines, plant and other machinery and other removable equipment authorised by the licence to be erected, installed or provided and if within 12 months after

being so required the electrical supply authority fails or neglects to remove the same, then the same shall, without payment of any compensation vest in and become the property of the Crown and it shall be lawful for any person authorised by the Minister of Energy in that behalf, subject to compliance with section 15A of the Electricity Act 1968 to enter upon any land or premises and take possession of and remove the same or any part thereof.

10. Nothing contained in the licence, either expressly or by implication shall be deemed to authorise the electrical supply authority to erect, construct or maintain any lines or works except subject to such conditions (not inconsistent with this licence) as may from time to time be lawfully imposed by any local authority within the district of which any such lines or works may be situated.

11. The systems of supply shall be as described in paragraphs (a), (b), (c), (d), (e), (f) and (g) of regulation 13 of the Electrical Supply Regulations 1984.

12. The electrical supply authority shall, 6 months prior to the expiry of the term of this licence provided in clause 6 herein, make written application to the Minister of Energy for the granting of a new licence.

Area of Supply

All that area in the Southland Land District bounded by a line commencing at a point on the high-water mark of Lee Bay in line with the north-western boundary of Scenic Reserve 168, Block I, Paterson S.D. and proceeding generally northerly and south-easterly along the said high-water mark to Mamaku Point; thence south-easterly along a right line to Horseshoe Point and along another right line to Ackers Point; thence generally south-westerly and westerly along the high-water mark of the sea coast, to and north-westerly along the high-water mark of the north-eastern side of Kaipipi Bay to a point in line with the north-western boundary of Block 4A, Maori Reserve 1A1; thence north-easterly to and along that boundary to and along the north-western boundary of Block 4D, Maori Reserve 1A1, the western boundary of Section 159, Block I, Paterson S.D., the western end of a public road, the western, northern and north-eastern boundaries of Section 158, Block I, Paterson S.D., the north-eastern boundary of Section 157, Block I, Paterson S.D., and the north-western boundaries of Sections 164, 163 and 162 and Scenic Reserve 168, Block I, Paterson S.D. and the last-mentioned boundary produced to the high-water mark of the sea in Lee Bay, the point of commencement.

- (e) The cylinder test pressure.
- (f) The nominal water capacity of the cylinder.
- (g) The tare weight of the cylinder.

2. That they be clearly marked or labelled to indicate that the cylinder is suitable for use with LPG.

3. That they be provided with valve threads and fittings which provide the following functions:

- (a) Filling connection incorporating a non return valve.
- (b) Service valve incorporating an excess flow valve.
- (c) Contents gauge.
- (d) Pressure relief valve.
- (e) A fixed liquid level indicator and an automatic fill shut off device which prevents the cylinder being filled beyond 85 percent of the total cylinder capacity.

Valves and fittings shall have a service pressure rating of at least that of the cylinder to which they are fitted and shall be dimensioned, threaded and marked in accordance with the requirements of section 2.2 of New Zealand Standard NZS 5422:1987 "The use of LPG and CNG Fuels in Internal Combustion Engines—Part 1 LPG Fuel".

4. That they be tested at periods not exceeding 5 years in accordance with the requirements of Australian Standard AS 2337.1-1987 or in accordance with the periodic test requirements laid down in the specification to which the cylinder was manufactured.

5. That they be fitted to a motor vehicle in such a position that they will not be subject to the direct rays of the sun, either by fitting them within a suitable vehicle compartment, or by providing a suitable shield if the cylinders are fitted to the exterior of the vehicle.

6. The terms of this approval do not allow the continued importation of such LPG fuel cylinders and it does not apply to cylinders which have not been installed in a motor vehicle by 31 December 1985.
