### Area Health Boards Act 1983

#### Delegation of Functions of Department of Health to Taranaki Area Health Board

Pursuant to section 36 (2) of the Area Health Boards Act 1983, I, George Cockburn Salmond, Director-General of Health, hereby delegate, with the consent of the Minister of Health, to the Taranaki Area Health Board the functions of the Department of Health specified in Part A of the Schedule to this delegation, subject to the conditions set out in Part B of the Schedule to this delegation.

#### Schedule

##### Part A—Delegated Functions—Health Act 1956

###### Dental Health

Functions—The organisation and control of dental services so far as such services are paid for out of public money, in the following respects:

Management and maintenance of the School Dental Service, including consultation with education boards, in accordance with Government policy;

Having epidemiological surveys made for the purpose of identifying and analysing local dental health needs, measuring the extent to which needs are being met, and developing local dental health objectives and plans to meet those objectives within Government policy guidelines;

Consultation with the dental profession;

The provision and maintenance of dental services in hospitals;

Co-ordinating dental services to ensure the availability and provision of dental care of a high standard throughout the area health district;

Providing public health dentistry and preventive dentistry components in the training programmes at schools of nursing and health inspectors' courses;

Planning and co-ordinating study programmes and observation programmes for international aid students.

###### Public Health

Functions—The provision of advice to local authorities in matters relating to public health; the prevention, limitation, and suppression of infectious and other diseases; the promotion and carrying out of researches and investigations of matters concerning public health and the prevention or treatment of disease; the organisation and control of medical services so far as such services are paid for out of public money; the taking of all such steps as may be desirable to secure the preparation, effective carrying out, and co-ordination of measures conducive to the public health; all in the following respects:

###### Environmental Health

The promotion, surveillance, and evaluation of public water supplies and community water supplies; the preparation of reports for loan and subsidy applications for waterworks; the promotion of improved standards of treatment and operation of water supplies; the provision of advice and assistance to local authorities on water supplies; the investigation of complaints concerning water supplies;

The promotion, surveillance, and evaluation of sewerage and of sewage disposal systems, and other methods of human waste disposal; the preparation of reports for loan and subsidy applications for sewage disposal works; the provision of advice and assistance to local authorities concerning sewerage and sewage disposal systems; the promotion of improved standards of treatment and operation of sewerage and sewage

disposal systems; the investigation of complaints concerning sewerage and sewage disposal systems;

The promotion, surveillance, and evaluation of solid waste collection and disposal systems; the preparation of reports for loan subsidy applications for solid waste management; the provision of advice and assistance to local authorities concerning solid waste collection and disposal; the promotion of improved standards of operation and management concerning solid waste collection and disposal; the investigation of complaints concerning solid waste collection and disposal;

The promotion, surveillance, and evaluation of hazardous waste disposal systems; the preparation of reports for loan and subsidy applications for hazardous waste management; the provision of advice and assistance to local authorities concerning hazardous waste disposal; the promotion of improved standards of operation and management concerning hazardous waste disposal; the investigation of complaints concerning hazardous waste disposal;

The surveillance and evaluation of swimming pool sanitation; the promotion of adequate standards of swimming pool sanitation;

The surveillance and evaluation of the effectiveness of pest control; the provision of advice and assistance to local authorities and harbour boards on the control of rats, vermin, and insect pests;

The periodic review of the sanitary condition of dwellings, boarding houses, hostels, motels, old peoples homes, and camping grounds;

The provision of advice to local authorities on public health needs with respect to public health issues of regional planning schemes and district planning schemes;

The investigation of odour emission, and other undesirable emissions, to the atmosphere; consultation, where appropriate, with the regional air pollution control officer and the local authority concerned;

The establishment and operation of monitoring programmes to measure air pollution in the area health district or any part thereof;

The surveillance and periodic evaluation of the noise climate; the provision of advice and assistance to local authorities on environmental noise; undertaking environmental noise surveys;

The provision of advice and assistance to local authorities, Government departments, public hospitals, and private hospitals, with respect to public health matters and health protection matters, as may be required;

The provision of advice and assistance to local authorities, regional councils and united councils, with respect to public health aspects of civil defence;

The investigation of applications for the establishment of offensive trades; the investigation of any proposal for the erection or extension of any premises for the purposes of or in connection with any offensive trade; granting or refusing consent to applications for the establishment or extension of any offensive trade;

The provision of health inspection services to local authorities;

The surveillance and evaluation of crematoria; the provision of advice and assistance to local authorities concerning crematoria; the investigation of complaints concerning crematoria; ensuring compliance with the Cremation Regulations 1973;

Ensuring compliance with Part IV of the Health Act 1956, and the Health (Quarantine) Regulations 1983;

Having regular sanitation inspections made of coastal shipping vessels;

The inspection and evaluation of port sanitation, including

passenger terminal facilities, cargo workers' canteens, and all wharves and related buildings; having samples taken of the water supply at ports to enable assessments of bacteriological and chemical content of the water; making recommendations with respect to port sanitation and water quality to relevant authorities;

The inspection of the following classes of premises for the purpose of the evaluation of and, where appropriate, the reporting on public health standards at the premises, and for the purpose of ensuring compliance with the requirements of the Health Act 1956, and any regulations made thereunder, relevant to the said premises:

Schools

Old peoples' homes

Swimming pools

Hairdressers' premises

The inspection of, and reporting on, child care centres and residential homes for the purpose of the evaluation of the physical environmental standards, sanitary condition, and any adverse conditions;

The inspection of chartered clubs and other licensed premises for the purpose of the evaluation of health standards maintained at such clubs or premises, and reporting thereon;

Providing information as requested for the purpose of FAO and World Health Organisation food contamination monitoring programmes;

#### *Occupational Health*

Providing medical, nursing, and scientific advice about occupational health hazards and diseases to Government departments, employer organisations, employee organisations, Accident Compensation Corporation voluntary organisations, and other relevant organisations;

Providing assistance in establishing occupational health services to relevant organisations, industry, Government departments;

Providing services for the investigation of, the reporting on, and, where possible, the improvement of environmental working conditions and the health of workers;

Providing occupational health services in priority areas, through occupational health centres, or in accordance with Government policy;

Ensuring, and promoting, the control of hazards at work;

Ensuring, and promoting, the safe use of chemicals in agriculture and industry;

Investigating occupational diseases;

The undertaking and assessment of noise surveys in workplaces;

Carrying out assessments and measurements on behalf of the National Radiation Laboratory pursuant to the Radiation Protection Act 1965 and the Radiation Protection Regulations 1982;

Investigation, evaluation, and reporting on occupational deafness, and promoting its prevention;

Giving appropriate advice and technical assistance on health issues in industrial disputes;

Investigation of problems and complaints relating to occupational health;

Undertaking special surveys or investigations on a regional basis or as part of a national programme;

Providing appropriate training of occupational health staff;

Promoting awareness of occupational health hazards by appropriate education programmes for schools, tertiary institutions, industry, Government departments;

Ensuring that all persons on whom obligations are imposed

by the following regulations meet those obligations, and otherwise comply with those regulations;

Asbestos Regulations 1983

Electroplating Regulations 1955

Fumigation Regulations 1967

Lead Process Regulations 1950

Spray Coating Regulations 1962

#### *Health Promotion*

Arranging for medical and developmental examinations of children from specific groups;

Arranging for medical examination and assessment of school children referred by parents, teachers, psychologists, general practitioners, nurses, and others;

Arranging for immunisations, including BCG vaccination and Rubella immunisation for selected groups;

Health surveillance and advice and support for selected age groups;

The provision of support for Plunket nurses, and for staff of the area health board;

The provision of advice on, and participation in, health promotion and health education programmes;

The provision of support and advisory services for community health development;

Arranging for hearing and vision tests on children, including follow-up tests; referral of children with suspected defects; consulting with parents, and schools with respect to children with suspected defects;

Implementation of health education programmes within the area health district, whether of a regional or national nature;

The planning, co-ordination, and evaluation of health promotion and health education programmes;

The provision of inservice training for area health board staff in health promotion and health education;

Preparation and provision of statistics on:

Infectious and notifiable diseases notifications

Clinical attendances for venereal diseases

Immunisations

X-ray surveillance of immigrants

Medical requirements of South Pacific immigrants

Child health

Arranging for measures to control and prevent the incidence of non-communicable diseases;

Promotion of health through good nutrition;

Undertaking measures to investigate, and control or prevent, the spread of infectious diseases; ensuring the isolation of persons likely to spread any infectious disease;

Ensuring compliance with the Venereal Diseases Regulations 1982.

#### *Public Health Nursing*

Functions—The organisation and control of public health nursing services so far as such services are paid for out of public money, in the following respects:

The promotion of primary health care by developing community profiles in consultation with the local community for the purpose of identifying health needs;

The provision of a family-centred nursing service that identifies family health needs and meets those needs by providing appropriate health surveillance, advice, and support for "at risk" groups;

The supervision of infants and children in conjunction with the Plunket Society, and in accord with Government policy;

The provision of health surveillance of children in primary,

intermediate, and secondary schools, including correspondence schools;

The provision of health promotion services to post-school adolescents;

Carrying out immunisation programmes, and undertaking measures to assist in disease prevention and control;

The provision of a health surveillance support service for the well-elderly in the community, including visits to the elderly, and consultation with other agencies in the planning and provision of services for the well-elderly;

Assessment of standards of care for the elderly in licensed old peoples' homes, together with advice to managers of old people's homes on health aspects of the standards of care, and making reports on the standards of care;

Assessment of standards of care for patients in private hospitals, and ensuring appropriate standards are maintained;

The provision of occupational health nursing services to assist in ensuring high standards of occupational health, including consultation with industry and Government departments;

The provision of domiciliary nursing services in rural areas;

Participating in orientation, staff training, and on-going education programmes; contributing to the education of nursing students and medical students, and other trainees in health fields; speaking in public groups on the role of the public health nursing service in the community;

The provision of support services for civil defence agencies;

Promotion of public health through prevention work, the education of the public, and consultation with community groups, Government departments, and other relevant agencies;

Ensuring appropriate planning and management of public health nursing services (including services performed by health assistants) in accordance with Government policy.

The provision of such other nursing services as may be required in accordance with Government policy.

#### *Food Act 1981*

Functions—The promotion and conservation of health in relation to food by the supervision of compliance with the Food Act 1981, the Food Hygiene Regulations 1974, the Food Regulations 1984, and the Dietary Supplements Regulations 1985, insofar as it is carried out by employees of an area health board, by ensuring that all persons on whom obligations are imposed by the said Act and regulations meet those obligations, and otherwise comply with the said Act and regulations.

#### *Social Security Act 1964, Part II*

Functions—The promotion and conservation of health, in the following respects:

Routine management of the dental benefits programme in accordance with the Social Security Act 1964, Part II, and the Social Security (Dental Benefits) Regulations, 1983;

The provision of advice and assistance to members of the public with respect to the benefits provided under the Social Security Act 1964, Part II, and the regulations made thereunder.

#### *Toxic Substances Act 1979*

Functions—The promotion and conservation of health in relation to toxic substances by the supervision of compliance with the Toxic Substances Act 1979 and the Toxic Substances Regulations 1983, insofar as it is carried out by employees of an area health board, by ensuring that all persons on whom obligations are imposed by the said Act and regulations meet those obligations and otherwise comply with the said Act and regulations.

### **Part B**

#### *Delegation Conditions*

1. Except as provided in clause 2 of these conditions, nothing in this delegation shall confer on the Taranaki Area Health Board (in this part called "the board") the function of instituting proceedings for alleged offences against any of the Acts or regulations referred to in Part A of the Schedule in this delegation.

2. The board shall have the function of instituting proceedings for alleged offences against the Food Act 1981, the Food Hygiene Regulations 1974, the Food Regulations 1984, the Dietary Supplements Regulations 1985. Where the board requires the services of counsel with respect to any proceedings so instituted it shall instruct the Crown Solicitor in the area health district to represent the board in the proceedings.

3. Where, in the view of the board, offences against any of the Acts or regulations referred to in Part A of the Schedule to this delegation (other than the Food Act 1981, the Food Hygiene Regulations 1985) have occurred, the board shall inform the Department of Health, to enable prosecution of the alleged offender at the instance of an officer of the department to be considered.

### Local Government Act 1974

#### Ohakune Borough — Raetihi Borough — Waimarino County Union Order 1987

#### ORDER IN COUNCIL

At Wellington this 14th day of December 1987

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 36 of the Local Government Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order:

#### Order

**1. Title and commencement**—(1) This order may be cited as the Ohakune Borough — Raetihi Borough — Waimarino County Union Order 1987.

(2) This order shall come into force on the day after the day on which the Returning Officer declares the result of the election or the 1st day of April 1988, whichever shall be the later.

(3) Those provisions of this order necessary:

(1) to provide for the first election of members of the District Council; and

(2) to provide for the appointment of the Principal Administrative Officer, pursuant to clause 7 of this order.

shall come into force on the date of the making of this order.

**2. Constitution**—(1) The districts of Ohakune Borough, Raetihi Borough, and Waimarino County are hereby united into one district to be known as the "Waimarino District" (hereinafter referred to as the "united district").

(2) The Ohakune Borough Council, Raetihi Borough Council and the Waimarino County Council (hereinafter referred to as "the uniting authorities") are hereby dissolved.

(3) A council for the united district to be known as the "Waimarino District Council" (hereinafter referred to as "the district council") is hereby constituted.

**3. Wards**—The united district is hereby divided into five wards as follows:

The Ohakune Ward, comprising the area of the former Ohakune Borough;

The Raetihi Ward, comprising the area of the former Raetihi Borough;

The Manganui Ward, comprising the area described in the First Schedule to this scheme;

The Karioi Ward, comprising the area described in the Second Schedule to this scheme;

The Hukaroa Ward, comprising the area described in the Third Schedule to this scheme.

**4. First Election of District Council**—(1) The first general election of the district council shall be held on the 19th day of March 1988.

(2) For the purposes of arranging the first election of the district council the Principal Administrative Officer and the Returning Officer for the united district shall be such person as is appointed Principal Administrative Officer pursuant to clause 7 (2) of this order.

(3) The first general election of the district council shall be conducted by postal vote.

(4) The Local Elections and Polls Act 1976, the Local Government Act 1974 and the Local Government (Electoral and Survey) Regulations 1986 shall, subject to any necessary modifications, apply in respect of the holding of the first general election of the district council as if any reference therein to an election to fill an extraordinary vacancy were a reference to the first election of the members of the district council.

Provided that the Returning Officer shall, not less than 56 clear days before the 19th day of March 1988, give notice of the election of members of the district council to be held on that date and of such other matters as are required by section 11 of the Local Elections and Polls Act 1976.

**5. Membership of Council**—The district council shall comprise a Mayor to be elected by the electors of the district as a whole, and 11 members elected as follows:

Three members to be elected by the electors of the Ohakune Ward;

Three members to be elected by the electors of the Raetihi Ward;

Two members to be elected by the electors of the Manganui Ward;

Two members to be elected by the electors of the Karioi Ward;

One member to be elected by the electors of the Hukaroa Ward.

**6. First Meeting of Council**—The first meeting of the district council shall be convened by the person holding the office of the Principal Administrative Officer appointed pursuant to clause 7 (2) of this order.

**7. Mayor and Principal Administrative Officer**—(1) The Mayor of the district council shall have and may exercise the

duties, powers and functions of the Chairmen and Mayors of the uniting authorities;

(2) The Principal Administrative Officer of the district council shall be appointed jointly by the uniting authorities and shall have and may exercise the duties, powers and functions of the Principal Administrative Officers of the uniting authorities.

**8. Wanganui United Council**—(1) The district council shall appoint two members to the Wanganui United Council.

(2) The member appointed by the former Waimarino County Council and the member appointed jointly by the Ohakune Borough Council and the Raetihi Borough Council to the Wanganui United Council shall continue in office until such time as successors are appointed.

**9. Finance**—Notwithstanding anything in this order, for a period of not less than six years nor more than nine years, as the district council may by special order determine, the united district shall for the purposes of subclause (2) of this clause be divided into three divisions as follows:

(1) The Rural Financial Division, comprising the area of the former Waimarino County;

(2) The Ohakune Financial Division, comprising the area of the former Ohakune Borough; and

(3) The Raetihi Financial Division, comprising the area of the former Raetihi Borough.

(2) For a period of one year or such longer period as the district council may by special order determine, the administrative costs of the district council shall be allocated as follows:

The Rural Financial Division shall pay 43%.

The Ohakune Financial Division shall pay 37%.

The Raetihi Financial Division shall pay 20%.

(3) The special funds of the uniting authorities shall be expended only for the purpose for which they were set aside.

(4) All loan liabilities existing at the date of the union shall continue to be secured against the areas over which they were secured as at that date.

**10. Transfer of Responsibilities**—Except as otherwise provided in this order, the district council, in respect of the districts of the uniting authorities:

(1) Shall have and may exercise and be responsible for all the powers, duties, acts of authority and functions which were previously exercised or which would have been so exercised by the former authorities;

(2) Shall have and may exercise and be responsible for all liabilities, obligations, engagements and contracts which previously were, or which would have been, the responsibility of the uniting authorities;

(3) Shall have and may exercise and be responsible for all actions, suits, and proceedings pending by or against the uniting authorities, or which would have been the responsibility of the uniting authorities;

(4) Shall succeed to the bylaws which are in force in the districts of the uniting authorities and which are applicable to the district council's circumstances and, until revoked or altered by the district council, every such bylaw shall remain in force in the area in which it was in force immediately before the union; and every bylaw which cannot be restricted to the area in which it was in force immediately before the union or which is not applicable to the district council's circumstances shall be deemed inapplicable and revoked by the union;

(5) Shall succeed to all rates and levies, and other money payable to the former authorities.

(6) Shall succeed to the valuation rolls, electoral rolls, and rate records in force in the districts of the uniting authorities, and these shall remain in force in the united district until such rolls or records are made by the district council, and until that time Part IX of the Rating Act 1967 shall apply as if the united

district was the district of a special purpose authority and the areas from which it was formed were constituent districts.

**11. Petroleum Tax**—For the purpose of Part XI of the Local Government Act 1974 the district council shall be the successor of the uniting authorities.

**12. Town and Country Planning**—The district planning schemes, and scheme statements, and codes of ordinance in force in the respective districts of the uniting authorities shall be deemed to be the district planning scheme, and scheme statement, and code of ordinances of the united district, and the district council shall not be required forthwith to prepare a new district scheme for the whole of its district.

**13. Vesting of Property**—All property, real and personal, vested in the corporations of the districts of uniting authorities shall, subject to all existing encumbrances, vest in the corporation of the district council.

**14. Title to Property**—For the purposes of clause 13 of this order any reference, (expressed or implied) to "the Waimarino County Council" or "the Ohakune Borough Council" or "the Raetihi Borough Council" in any instrument or other document whatever, or in any entry or record made on any register in relation to any instrument or other document whatever shall, unless the context otherwise requires, be read as a reference to the Waimarino District Council.

**15. Creditors**—Subject to section 37F of the Local Government Act 1974, the rights or interests of creditors of any district affected by this order shall not be affected.

## Northland Regional Council Constitution Order 1987

PAUL REEVES, Governor-General  
ORDER IN COUNCIL

At Wellington this 14th day of December 1987

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 36 of the Local Government Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order:

### Order

**1. Title and Commencement**—(1) This order may be cited as the Northland Regional Council Constitution Order 1987.

(2) This order shall come into force on the day after the Returning Officer, pursuant to the Local Elections and Polls Act 1976, declares the result of the election of members to be held on 12 March 1988, or the 1st day of April 1988, whichever shall be the later.

(3) Those provisions of this order necessary to provide for the first election of the members of the Regional Council shall come into force on the date of the making of this order.

**2. Constitution**—(1) There is hereby constituted a Northland Regional Council (hereinafter referred to as "the Regional Council") which shall be the council for the Northland Region.

(2) The Northland Region shall be that Region constituted by clause 2 of the Northland Region Constitution Order 1979 and comprising the constituent districts of:

- The County of Mangonui;
- The Borough of Kaitaia;
- The County of Whangaroa;
- The County of Hokianga;
- The Borough of Kaikohe;
- The County of Bay of Islands;
- The County of Whangarei;
- The Town District of Hikurangi;
- The City of Whangarei;
- The County of Hobson;
- The Borough of Dargaville;
- The County of Otamatea.

(3) The Northland Region Constitution Order 1979 is hereby amended by revoking clauses 3 to 9 thereof.

**3. Northland United Council**—(1) The functions of the Northland United Council are hereby transferred to the Regional Council.

(2) The Northland United Council is hereby dissolved.

**4. Northland Catchment Commission**—(1) The functions of the Northland Catchment Commission are hereby transferred to the Regional Council.

(2) The Northland Catchment Commission is hereby dissolved.

(3) Subject to the provisions of this order and the Local Government Act 1974, the Regional Council shall have all the powers, rights, functions and duties of a Catchment Board constituted under the Soil Conservation and Rivers Control

Act 1941 and a Regional Water Board constituted under the Soil Conservation Act 1967.

**5. Membership of Council**—(1) The Regional Council shall consist of 12 members of whom:

(1) Two shall be elected by the electors of the Mangonui Constituency, comprising the districts of Mangonui County, Kaitaia Borough and Whangaroa County;

(2) One shall be elected by the electors of the Hokianga Constituency, comprising the districts of Hokianga County and Kaikohe Borough;

(3) Two shall be elected by the electors of the Bay of Islands Constituency, comprising the district of Bay of Islands County;

(4) Two shall be elected by the electors of the Whangarei Rural Constituency, comprising the districts of Whangarei County and Hikurangi Town District;

(5) Three shall be elected by the electors of the Whangarei Urban Constituency, comprising the district of Whangarei City;

(6) Two shall be elected by the electors of the Hobson Constituency, comprising the districts of Hobson County, Dargaville Borough, and Otamatea County.

(2) For the purposes of section 82 (2) of the Local Government Act 1974, in the case of those constituencies comprising two or more constituent districts the constituent authority of the first named district shall be the principal authority.

**6. First Election of Regional Council**—(1) The first general election of the Regional Council shall be held on the 12th day of March 1988.

(2) For the purposes of arranging the first election of the Regional Council the Returning Officer for the region shall be the Secretary of the Northland Catchment Commission.

(3) The first general election of the Regional Council shall be conducted by postal vote.

(4) The Local Elections and Polls Act 1976, the Local Government Act 1974 and the Local Government (Electoral and Survey) Regulations 1986 shall, subject to any necessary modifications, apply in respect of the holding of the first general election of the Regional Council as if any reference therein to an election to fill an extraordinary vacancy were a reference to the first election of the members of the Regional Council:

Provided that the Returning Officer shall, not less than 56 clear days before the 12th day of March 1988, give notice of the election of members of the Regional Council to be held on that date and of such other matters as are required by section 11 of the Local Elections and Polls Act 1976.

**7. First Meeting of Regional Council**—(1) The first meeting of the Regional Council shall be held not later than 15 April 1988.

(2) The Secretary of the former Northland Catchment Commission shall convene the first meeting of the Regional Council and shall preside at that meeting until the election of a Chairman.

**8. Chairman and Principal Administrative Officer**—

(1) The Chairman of the Regional Council shall have and may exercise the duties, powers and functions of the Chairmen of the Northland United Council and the Northland Catchment Commission.

(2) The Principal Officer of the Regional Council shall have and may exercise the duties, powers and functions of the Principal Administrative Officers of the Northland United Council and the Northland Catchment Commission.

(3) Until the Regional Council appoints a Principal Officer the duties of the Principal Officer shall be undertaken by the Chief Executive Officer of the former Northland Catchment Commission and Regional Water Board.

**9. Transfer of Responsibilities**—Except as otherwise provided in this order, the Regional Council, in respect of the Northland United Council and the Northland Catchment Commission, hereinafter referred to as the "former authorities":

(1) Shall have and may exercise and be responsible for all the powers, duties, acts of authority and functions which were previously exercised or which would have been so exercised by the former authorities;

(2) Shall have and may exercise and be responsible for all liabilities, obligations, engagements and contracts which previously were, or which would have been, the responsibility of the former authorities;

(3) Shall have and may exercise and be responsible for all actions, suits, and proceedings pending by or against the former authorities, or which would have been the responsibility of the former authorities;

(4) Shall succeed to the bylaws of the former authorities which are applicable to the Regional Council's circumstances and, until revoked or altered by the Regional Council, every such bylaw shall remain in force; and every bylaw which is not applicable to the Regional Council's circumstances shall be deemed inapplicable and revoked;

(5) Shall succeed to all rates and levies, and other money payable to the former authorities.

**10. Out-District**—For the purposes of the Soil Conservation and Rivers Control Act 1941 and the Water and Soil Conservation Act 1967, that part of the Northland Catchment Area lying outside the Northland Region shall be an out-district under the jurisdiction of the Regional Council.

**11. Committees**—Subject to section 104 of the Local Government Act 1974, section 6 of the Town and Country Planning Act 1977, section 28 of the Civil Defence Act 1983, and clause 12 of this order, the Regional Council may appoint such committees as it thinks fit.

**12. Water and Soil Committee**—(1) The Regional Council shall appoint and maintain a committee to be known as "the Water and Soil Committee" or by such other name as the Regional Council may decide.

(2) Subject to section 105 of the Local Government Act 1974, the Regional Council may delegate to that committee any of its functions, rights, powers, and duties under the Soil Conservation and Rivers Control Act 1941 and the Water and Soil Conservation Act 1967 and any other matters relating to water and soil management that may from time to time arise.

(3) In addition to such persons as the Regional Council may from time to time appoint to that committee pursuant to section 104 of the Local Government Act 1974, the Regional Council shall appoint to the committee such persons, not exceeding three in number, who may from time to time be nominated by the Minister of Works and Development.

(4) The provisions of section 44 of the Soil Conservation and Rivers Control Act 1941 and section 7 of the Soil Conservation and Rivers Control Act 1948 shall, with the appropriate modifications, apply to any person appointed to the Water and Soil Committee pursuant to subclause (3) of this clause.

**13. Rating**—(1) Subject to the provisions of section 133 of the Local Government Act 1974, the system of rating in the region shall be a capital value system.

(2) The Hikurangi Swamp Major Scheme Rating District and the Hikurangi Swamp Drainage District shall enure as if they had been constituted by the Regional Council.

**14. Accounts**—(1) The accounts of the Regional Council shall be kept in accordance with the provisions of the Local Government (United Council and Regional Council) Accounting Regulations 1980.

**15. Vesting of Property**—All property, real and personal,

vested in the Northland United Council and the Northland Catchment Commission shall, subject to all existing encumbrances, be vested in the Regional Council.

**16. Title to Property**—For the purpose of clause 15 of this order any reference, expressed or implied, to “The Northland Catchment Commission” in any instrument or other document whatsoever, or in any entry or record made on any register in relation to any instrument or other document whatever shall, unless the context otherwise requires, be read as a reference to the Northland Regional Council.

**17. Creditors**—Subject to section 37F of the Local Government Act 1974, the rights or interests of creditors of any local authority affected by this scheme shall not be affected.

## Indecent Publications Act 1963

Decision No. 26/87.

### Before the Indecent Publications Tribunal

### Decision

These two publications were commercially imported by parcels post at Hamilton in late June 1986. The books were seized by the Collector of Customs in Hamilton on 1 July 1986 and the Importer subsequently disputed forfeiture. The Comptroller of Customs has advised the Tribunal that due to an administrative error no further action was taken in respect of these publications until July 1987, when the books were submitted to the Tribunal prior to the commencement of condemnation proceedings pursuant to the Customs Act 1986.

### *Sex Stars' Favourite Positions*

This is a soft-cover publication which proclaims on its back cover the contents to be:

“AT LAST! For the first time ever in one book! In exclusive, photographs—famous sex stars illustrate the sexual positions they prefer most! In blue movies, they're directed, but in these never-before-published pictures, they do what they want to do, how they want to do it!”



The Tribunal is satisfied that there is no honesty of purpose in this publication and that it is intended to exploit prurient interest and that there is no significant intent to provide, for example, a sex educational aspect in the publication. The publication consists almost entirely of photographs of male and female models engaged in sexual activity of various kinds. The publication is clearly in contravention of the guidelines expressed in Decisions 1053 and 1054 of March 1983 in that there are excessive depictions of intimacy between male and female models of a kind which could not claim for itself the cover of being educational or therapeutic. The Tribunal is satisfied that this publication is injurious to the public good and classifies it as unconditionally indecent.

#### *Acts of Love Part II*

This soft-cover publication expresses its purpose on the front cover as being:

"EROTIC USES OF SEX DEVICES to enhance all positions of the sex act. EXPLICIT PHOTOGRAPHS AND DRAWINGS that boldly illustrate 65 special acts of love."

In the course of a two page introduction the manual, if that is what it pretends to be, states:

"Three couples were chosen whose attitudes were in line with what we had in mind. Liberated from stereotyped behaviour roles, our three couples were not bound by tradition when it came to sensual pleasures. Guided only by the principle of mutual consent, they were willing to assume any sexual position or use any device that would prove pleasurable and harmless. We wanted to see what would happen if we made the entire spectrum of sexual aids and adult toys available to our couples—Would they use them? Would they enjoy them?"

The Tribunal is unanimously in agreement that there is no honesty of purpose in this publication, that it is designed, as is the previous publication *Sex Stars' Favourite Positions*, solely to attract the interest of the prurient and is clearly, in the Tribunal's view, injurious to the public good. The publication does not claim (nor could it justifiably do so) that it is intended as a serious sexual educational magazine, nor is it a magazine which might come within the guidelines set out in respect of sexual manuscripts which might be available to counsellors for therapeutic counselling. The Tribunal classifies this publication as unconditionally indecent.

#### **Decision**

These publications were privately imported by parcels post at Hamilton and seized by the Collector of Customs in Hamilton

on 15 May 1987. The Importer has subsequently disputed forfeiture and the magazines have been referred to the Tribunal prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

*Private Pleasures of John Holmes; Campfire; Submissive Suck-Off; Kake 16, Sex on the Train; Kake 25, Postal Rape*

The *Private Pleasures of John Holmes, Campfire* and *Submissive Suck-Off* can only be described as explicit hardcore homosexual pornography. The predominant purpose in the production of these magazines is clearly to display multiple sexual activity between males, including explicit oral and anal sex, and the Tribunal is satisfied that each of these publications is injurious to the public good, and accordingly classifies each of them as unconditionally indecent. The publications *Kake 16, Sex on the Train, Kake 25, and Postal Rape* consist of a series of drawings, one per page which outline a story sequence. Many of the drawings in the magazines portray explicit male homosexual acts including oral and anal sex, and there are some features of sado-masochistic activities also portrayed. The Tribunal is satisfied that these two publications are injurious to the public good, and classifies each as unconditionally indecent.

*Zeus 2, The Top and Bottom of One Man's Leather Fantasy; Zeus Presents Val Martin, Leo Stone*

Both of these magazines place an emphasis on leatherware and bondage of a type that the Tribunal has previously found unconditionally indecent. For example, as in Decision 1/87 of 6 January 1987 relating to the publication *Fancy No. 1*. The material in each of these publications is obviously aimed at the male homosexual market, but the displays of bondage and violence as between males represent in the Tribunal's clear view a real and patent danger to the public good, as was expressed in Decision No. 1/87. The Tribunal accordingly classifies both of these publications as unconditionally indecent.

#### *Odyssey Number One*

This publication features single male models, and although there is some suggestion in the posed photographs of bondage, there is no actual restraint shown. The Tribunal is satisfied that the material portrayed in this publication would be injurious to the younger reader, and accordingly classifies it as indecent in the hands of persons under the age of 18 years.

### Decision

These publications were sample copies imported by Waverley International Ltd. The publications were seized by the Collector of Customs and the Importer has subsequently disputed forfeiture. The publications have been referred to the Tribunal prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

*Blueboy*, November 1980, January 1981 and February 1981

These publications, which are soft-cover magazines, have previously been referred to the Tribunal and in Decision No. 1065 of 7 June 1983 and 2/84 of December 1983 the Tribunal found previous issues to be unconditionally indecent. In the course of Decision No. 1065 the Tribunal said:

"There is little or no text, and whilst they contain no explicit homosexual scenes, there is a general emphasis on the display of genitalia. There is a lack of any redeeming feature, and these were also suggested as being injurious to the public good and therefore indecent."

Those decisions were of course written prior to the passing of the Homosexual Law Reform Act, and homosexual material at that time, if it illustrated, supported or promoted homosexual activity of a kind which was at that time a criminal offence in New Zealand, was classified indecent for that reason alone by the Tribunal.

These magazines are quite clearly directed towards the male homosexual reader. Each of the magazines contains a large number of photographs of males, many of them shown nude and with emphasis on the genitalia, and in some of the magazines a small number of photographs showing two or more males in various stages of intimacy. The written material contains a small amount of what may be termed serious writing of interest to a wider range of readers, but the bulk of the written material is clearly written for the homosexual reader and consists largely of graphic accounts of sexual encounters between males. The November 1980 issue contains a series of photographs under the title "Bronk" which portrays sexual activities between three men. Those portrayals go well past what might be called the borderline in depicting sexual activity, whether that activity be heterosexual or homosexual.

The Tribunal is satisfied that that issue is injurious to the public good and classifies it as unconditionally indecent.

The January '81 and February '81 issues, although containing some advertisements and some material which the Tribunal finds borderline, are classified by the Tribunal as indecent in the hands of persons under the age of 18 years.

*50+ Plus* No. 8

This publication is a picture book of nude or partly nude females with a particular emphasis on large breasts. There is no text and the remainder of the publication is made up of advertisements for other magazines and videos. Because of the photographic emphasis on the genitalia, the Tribunal classifies this publication as indecent in the hands of persons under the age of 18 years.

*Velvet*, Vol. 10, No. 1

This publication is a soft-cover pornographic magazine and the principal content is of photographs of single female nudes with particular emphasis on posing the models so as to display their genital regions. There is a significant photographic content of sexual activities between men and women. This magazine comes very close to being in a category of hardcore pornography, and the Tribunal is satisfied that it is injurious to the public good and classifies it as unconditionally indecent.

*Torso*, Vol. 2, No. 4; *Honcho*, Vol. 2, No. 13; *Playguy*, Vol. 4, No. 4; *Mandate*, Vol. 3, No. 33.

These four soft-covered magazines are aimed at the male homosexual market, although they vary somewhat in their content. The magazine *Mandate* contains a considerable number of serious articles of a non-sexual nature. The posed

nude photographs lack many of the objectionable features of some other magazines, and there is far less emphasis on the genital area than can be found in many of those other magazines. The Tribunal finds that an age restriction is all that is required in respect of this publication, as it would, in the Tribunal's view, be injurious to younger persons. Accordingly, the Tribunal classifies *Mandate*, Vol. 3, No. 33 as indecent in the hands of persons under the age of 16 years.

*Playguy*, Vol. 4, No. 4 is very similar in content to *Mandate*, and the Tribunal likewise finds in respect of this publication that an age restriction is all that is required and classifies it accordingly as indecent in the hands of persons under the age of 16 years.

*Honcho*, Vol. 2, No. 13 and *Torso*, Vol. 2, No. 4 contain what the Tribunal finds to be more explicit and more injurious material for younger readers than is contained in *Mandate* and *Playguy*, and accordingly classifies those two publications as being indecent in the hands of persons under the age of 18 years.

*Seventh Innings Sex*, *Political Passions*, *Wife's Wild Ways*, *Hung Stud*

These four publications are paperbacks of each approximately 180 pages in length. These books cannot be said to have any real story line, and we agree with the Comptroller of Customs in his submissions that they are really only a cheap vehicle for a collection of explicit sexual episodes.

The Tribunal is unanimous that the sexual content of these publications is such that they present sex in a purely salacious way and without any artistic merit in the books to otherwise balance what are the unfavourable features. The Tribunal is unanimous that each of these books is injurious to the public good and classifies each as unconditionally indecent.

### Decision

*Fiesta* and *Knave* Publications

These publications were imported by Waverley Publications in Auckland in or about December 1986. The publications were released in error by Customs and subsequently sold to Progressive Mail Order in Hamilton and that company very responsibly requested that they be submitted to the Tribunal for decision and classification. A seizure notice was accordingly issued by the Comptroller of Customs on 11

February 1987 and the books submitted to the Tribunal for classification and decision.

Other issues of *Knave* and *Fiesta* were previously considered by the Tribunal, and were the subject of a decision which went to appeal before the full court of the High Court in Wellington. The full court in its decision referred the publications back to the Tribunal for further consideration, and a date for the hearing of that matter has yet to be determined with counsel for the publishers. Prior to the Tribunal hearing on 11 September 1987 application was made by the New Zealand solicitors for the English publishers and the New Zealand importers and distributors that the hearing in respect of these particular publications should be deferred and be heard conjointly with the publications which were referred back to the Tribunal by the full court. The Tribunal accepts that it would be pointless to deal with these particular publications separate from the other publications, and accordingly the decision on these matters is deferred until the further hearing of the Tribunal.

*Club International*, Vol. 15, Nos. 8, 9 and 10

These publications have been referred to the Tribunal by the Comptroller of Customs for classification and decision, and the record does not show through which port or on behalf of which Importer these publications came to notice. In his submission to the Tribunal on behalf of the Comptroller of Customs, Mr Wotherspoon pointed out that the magazine *Club International* had been classified unconditionally indecent in the Tribunal's Decision No. 876. Mr Wotherspoon submitted to the Tribunal that these books are predominantly concerned with the prurient and lewd aspects of sex, as can be seen by the contrived positions of the models and the repetitious portrayal of the female pelvic area. Mr Wotherspoon submitted that the magazines contain material of a kind which justified some form of age restriction. The Comptroller of Customs has also through Mr Wotherspoon submitted to the Tribunal that a serial restriction be imposed under the provisions of section 15A of the Indecent Publications Act 1963.

The magazines consist principally of portfolios of photographs of various models largely undressed. The magazines also contain interviews and indepth studies of individuals, readers' letters and commentaries by some of the models in the portfolios about their sexual activities and fantasies.

The Tribunal agrees with the submission of the Comptroller of Customs and classifies each of these magazines as indecent in the hands of persons under the age of 18 years. The Tribunal agrees with the submission on behalf of the Comptroller of Customs that this is an appropriate publication to receive a Serial Restriction Order in terms of the provisions of section 15A of the Indecent Publications Act 1963 and orders accordingly.

*Men Only*, Vol. 51, Nos. 4, 8, 9 and 10

The record does not show how these particular publications came before the Comptroller of Customs, but they have been referred to the Tribunal for classification and decision. In the submission of Mr Wotherspoon on behalf of the Comptroller, he points out that *Men Only* publications have been submitted to the Tribunal on numerous occasions resulting in Decisions 876, 1034, 1041 and 24/84. In Decision 24/84 the Tribunal imposed a Restriction Order under section 15A of the Indecent Publications Act declaring the publications as unconditionally indecent for a period of 2 years. That Serial Restriction Order took effect from December 1984 and concluded in December 1986. Mr Wotherspoon pointed out to the Tribunal that these publications, although similar to the issues classed as unconditionally indecent by the Tribunal in the past, lack the multiple model lesbian scenes which were of particular concern to the Tribunal on the previous occasions when these publications were considered.

The Tribunal does express its concern that many of the

photographs in these issues depict naked females in contrived and unnatural posing, with emphasis on the genitalia.

The Tribunal reaches the unanimous decision that these particular issues should be classified as indecent in the hands of persons under the age of 18 years, as they contain material which could well be injurious to the younger reader.

*Sexual Positions* by Hans Richter

This publication was privately imported through Christchurch Airfreight on 29 November 1986. It was seized by the Collector of Customs and the Importer has subsequently disputed forfeiture. The publication has been submitted to the Tribunal for classification and decision prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966. The importer, Mr Highley, owns a bookshop in Dunedin, and he informed the Tribunal that he visits Australia to purchase copies of magazines for resale in New Zealand and he also has sent to him either solicited or unsolicited magazines from his Australian suppliers. These particular publications, having been imported by Mr Highley, were at his request referred to the Tribunal for classification and again he is to be commended for his responsible attitude to these matters.

*Sexual Positions* was first submitted to the Tribunal on 11 March 1980, and in Decision No. 945 it was classified as unconditionally indecent. The Tribunal, in its decision, stated that the author had, in its view, no other motive than that of promoting sexual practices. The publication lacked, in the view of the Tribunal in that decision, honesty of purpose.

The publication contains an almost equal content of photographs and text.

The Tribunal is satisfied that this publication cannot justifiably be granted a limited distribution classification as being a serious manual in respect of sexual techniques or for therapeutic use. The Tribunal is satisfied that the publication lacks any honesty of purpose and believes that it is simply intended as a commercial venture to attract the interest of the prurient. The Tribunal believes that the publication is injurious to the public good and classifies it as unconditionally indecent.

*Centurians Latex Annual*, Vol. 1, *The Whole Catalogue of Trainers and Gags*, *Discipline Helmets*, *TV Dream Fantasies* Collection 1 and 2.

These publications were privately imported through Parcels Post, Auckland in March and April 1986. The publications were seized by the Collector of Customs, and the importer has subsequently disputed forfeiture. The publications have been referred to the Tribunal prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

The Comptroller of Customs, in his submission through Mr Wotherspoon, invites the Tribunal to consider that the publications are similar in content to other bondage magazines which have been classified as unconditionally indecent by the Tribunal in earlier decisions. The Tribunal is in unanimous agreement with that submission. *The Trainers and Gags Catalogue*, *Discipline Helmets* and *Latex Annual* publications all contain various forms of sexual activity in which bondage and rubber fetishism play a predominant part. As was said in Decision No. 933 in respect of similar publications:

"The motive for all these publications is to excite a perverse—and indeed perverted—sexual interest through fantasies of sexual violence. Although the editors and publishers write of 'bondage literature' as though it is a serious genre, it is obvious that there is a particularly vicious kind of depravity in arousing fantasies that depend on the violation of human-beings reduced to the level of objects."

*TV Dream Fantasies* Collections 1 and 2 are a presentation of short stories by various authors most, if not all, of which deal with transvestism, bondage and female domination. The dominant effect as a whole of all of these publications is to

appeal to the prurient. They certainly cannot claim for themselves any literary or other merit. The Tribunal unanimously classifies these publications as unconditionally indecent.

- (v) The lights to indicate a right hand turn shall be fitted near the right side of the vehicle and those to indicate a left hand turn near the left side of the vehicle;
- (vi) A visible device shall be fitted so that the driver, when in the driving position is readily aware of the failure to function, of one or more of the direction indicator lamps.

Provided that the light showing to the front may be incorporated in the side-light assembly of the vehicle and the light showing to the rear may be incorporated in the tail-light assembly, subject to the power of the side light or tail light, as

the case may be, not exceeding 7 watts, and subject to bulbs in the flashing lamps having either bulbs or electric filaments separate from those used for the side light or tail light, as the case may be.
