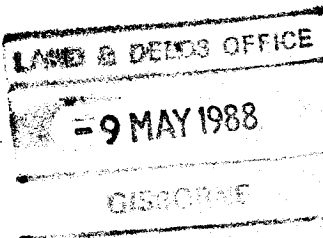

Category 1

Category 3
