1988/89 Global Tariff Quota Tendering No. 1—Call for Tenders 1988

Pursuant to section 120 (5) of the Customs Act 1966, the Comptroller of Customs, acting under the delegated authority is calling tenders for Global Tariff Quota for grape wine of an FOB value less than \$2.00 per litre.

Guide notes to Global Tariff Quota Tendering are set out below.

Tenders must be addressed to the Collector of Customs, P.O.

Box 66, Nelson. Attention: Mr T. Heine or delivered by hand to the Fourth Floor, 241 Hardy Street, Nelson. Tenders should reach the office of the Collector of Customs no later than 4 p.m. on Thursday, 16 June 1988. Envelopes must be marked "Global Tariff Quota Tender No. 1".

NOTES

1. Tenderers are advised that Tariff Quota Allocations issued under this call for tenders will be for the importation of grape wine classified under tariff headings 2204 and 2205 (See further on for schedule of relevant tariff items).

2. Tenderers should be conversant with the various statutes and regulations governing the importation and sale of wine.

Guide to Tariff Quota Tendering

1. Tenderers are to express their bids as an amount per litre (e.g., \$1.00 per litre) even though the quotas will be issued on a value basis.

2. Quotas will be allocated to the successful tenderers on the basis of the number of tariff quota allocation sizes. The successful tenderers will receive a duty concession, issued under Reference 99 of Part II of the Customs Tariff, for Tariff headings 2204 and 2205 which will reduce the rate of duty down to the level of the bid plus the relevant rate set out in the New Zealand Tariff. The relevant rates set out in the tariff are:

Example: A bid of \$1.00 per litre under T.I. 2205.10.29 would mean the concession rate would be \$2.66 per litre plus 22.5% of the Customs value.

Who Can Bid

Tenders may be submitted by any person or enterprise domiciled in New Zealand.

Tendering Format

1. Tenders are to be made by letter.
2. The following information must be given:
 - (a) Name and address of tenderer;
 - (b) Number of units tendered;
 - (c) Amount per litre of the bid.

Advice and Publication

1. Following the closure of the tenders, bids will be publicly opened in the office of the Collector of Customs in Nelson, in the presence of a Justice of the Peace.

2. Successful tenderers will receive a Global Tariff Quota Allocation which will show the C.I.F. value of the wine which may be imported and the concession rate of duty applicable.

3. Unsuccessful tenderers will be notified by letter.

4. The name and allocation of all tenderers successful and invalid, and the amount of the bid in each case will be published in the *Gazette* as soon as possible after the opening of the tenders.

Education**Education Act 1964**

This notice replaces the Taranaki Polytechnic Notice 1988 which was published in the *New Zealand Gazette* 19 May 1988, No. 85, page 2077.

The Taranaki Polytechnic Notice 1988

Pursuant to section 69 of the Education Act 1964, the Minister of Education gives the following notice.

Notice

1. (1) This notice may be cited as the Taranaki Polytechnic Notice 1988.

(2) This notice shall come into force on the date of its publication in the *Gazette*.

2. There shall be a board of governors, to be known as the Council of the Taranaki Polytechnic, which shall control the Taranaki Polytechnic.

3. The Council of the Taranaki Polytechnic shall be constituted as follows:

(a) Two members elected by the governing bodies of secondary schools in the provincial district of Taranaki, 1 to represent the governing bodies of Inglewood and Waitara secondary schools and all secondary schools within the New Plymouth city boundary and 1 to represent the governing bodies of all other secondary schools in the provincial district of Taranaki including the Taranaki Education Board.

(b) Two members appointed by the Taranaki Local Bodies Association.

(c) Two members elected by the associations of employers in local industries situated within the provincial district of Taranaki.

(d) Two members elected by the associations of employees in local industries situated within the provincial district of Taranaki.

(e) One member appointed by the Federated Farmers of New Zealand (Inc.) (Taranaki provincial district).

(f) One member elected by the Taranaki Branch of the New Zealand Society of Accountants and the Taranaki Branch of the New Zealand Institute of Management.

(g) One member appointed by the Taranaki Branch of the New Zealand Institution of Engineers.

(h) The Director-General of Education or his nominee.

(i) One member who shall be the Principal of the Taranaki Polytechnic.

(j) One member who shall represent the staff of the Taranaki Polytechnic, and who shall be elected by the full-time

employees of the council, and who shall be employed by the council.

(k) One member to represent health services interests who shall be elected by various health services representatives on the Polytechnic Nursing Advisory Committee.

(l) One member who shall represent Maori people in Taranaki and who shall be appointed by the Taranaki Maori Trust Board.

(m) One member who shall represent the students of the Taranaki Polytechnic and who shall be appointed to a term of office of 1 year by the Executive Committee of the Polytechnic Students' Association.

(n) Not more than 3 members may be co-opted by the council itself, if and when it thinks fit.

4. (1) Subject to the provisions of this clause and the provisions of paragraph (k) of clause 3 of this notice, the members of the Council of the Taranaki Polytechnic shall hold office for a term of 3 years, but may, from time to time, be reappointed or re-elected.

(2) Except in the case of a casual vacancy, every member shall hold office until the 31st day of May in the third year after the year of his appointment or election, and if, on the 31st day of May, the appointment or election, of his successor has not been notified to the council he shall continue to hold office until the date on which that appointment or election is notified.

(3) If any member dies, or resigns his office by writing under his hand addressed to the council or the chairman or the secretary thereof, or is absent without leave from the meetings of the council for 3 consecutive months, or while holding office becomes for any reason ineligible to remain a member, the casual vacancy so created shall be filled, as soon as practicable thereafter, by the appointment or election of a member in the manners in which the vacating member was appointed or elected, and the member appointed or elected to fill the vacancy shall hold office for the residue of the term of office of the member whom he replaces.

(4) The powers of the council shall not be affected by any vacancy in the membership thereof.

5. The Taranaki Polytechnic Notice 1976 is hereby revoked.

Decision

These publications were privately imported through the port of Whangarei and subsequently seized by the Collector of Customs in Whangarei. The importer has subsequently disputed forfeiture and the publications have therefore been referred to the Tribunal prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

Glory Hole Gang; *Gay Action*; *Country Fair*; *Centurian Book 1*

These publications are explicit male homosexual magazines consisting principally of photographs without text although gay action has a limited written content. All of the magazines, with the exception of *Centurian*, depict both oral and anal sex, although in *Centurian* there is one implicit photograph of anal

sex. The Tribunal is satisfied that these publications equate in their explicit portrayal and presentation of sexual acts with the range of hardcore heterosexual magazines which have previously been classified as unconditionally indecent in many Tribunal decisions. The Tribunal accordingly classifies these particular publications as unconditionally indecent.

Prisoner of Lust

This publication is a magazine which contains numerous photographs of males engaging in simulated acts of sex, including oral sex and anal sex. The feature of the publication which causes considerable concern to the Tribunal is the depiction of both bondage and sado-masochism. The Tribunal is satisfied that this publication is injurious to the public good and classifies it as unconditionally indecent.

Foxhunt 2

This publication consists of a series of photographs of nude or semi-nude single male models. A number of the models depicted in the book are of males in a state of erection. The Tribunal is satisfied that this book would be injurious to younger readers, and accordingly classifies this book as indecent in the hands of persons under the age of 18 years.

Decision

These publications were privately imported through Christchurch Airport in the importer's personal baggage on 18 April 1987. The publications were seized because it was considered that they were outside the guidelines which the Tribunal has set in relation to indecent publications. The importer has disputed forfeiture of the goods and they have been referred to the Tribunal prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

Punished, Vol. 1, No. 1; *Kinky Sex 421*; *Sir Bizarre*, No. 39

These publications consist entirely of photographic sequences of nude or partially clad males and females, with considerable emphasis on the genitalia. The magazine portrays sexual encounters in pictorial form with explicit photographs showing sexual intercourse, sodomy and oral sex, some of it with a bondage theme. The little written material contained in the publications relates almost entirely to a description of a series of sexual adventures. The Tribunal is satisfied that these publications are injurious to the public good and classifies each as unconditionally indecent.

Slaves of Anal Sex

This publication, as its name implies, concentrates on the depiction of anal sex. The Tribunal considers this publication to be in the hardcore pornography range and is satisfied that it

would be injurious to the public good. The Tribunal classifies this publication as unconditionally indecent.

Reflections, Vol. 7, No. 3; *Diana*, Vol. 1, No. 3

These two publications concentrate on the bondage and sado-masochism aspects of sexual relationships. As is stated by the Tribunal in Decision 1/87 of 6 January 1987, "the Tribunal is unanimous that such displays of bondage and violence against both male and female represent a real and patent danger to the public of a kind that is clearly injurious to the public good." The Tribunal classifies both of these publications as unconditionally indecent.

Decision

These publications were commercially imported at Auckland in October 1987 and subsequently seized by the Collector of Customs at Auckland. The importer, Lawrence Publishing Co. of NZ Ltd., has disputed forfeiture of the publications and they have been referred to the Tribunal by the Comptroller prior to commencement of condemnation proceedings pursuant to the Customs Act 1966. All of these magazines are clearly directed at the male homosexual market and are principally magazines containing photographs of male models in a variety of poses. The great majority of the photographs are of a single model, but in some of the publications, in particular *Advocate Men*, multiple model scenes are displayed.

Mr Wotherspoon, on behalf of the Comptroller, expressed concern as to some of the bondage and excessive intimacy scenes as portrayed in *Advocate Men*, and the Tribunal gave very careful consideration to the particular publications which caused concern, and although those publications were indeed borderline the Tribunal has on this occasion been prepared to classify all of the *Advocate Men* publications as indecent in the hands of persons under the age of 18 years. The remaining publications, namely *Colt*, *Olympus* and *Spurs*, consist in the main of photographs of single male models in a variety of poses and there is very little text accompanying those photographs. The Tribunal is satisfied that these publications could be injurious to persons under the age of 18 years and accordingly classifies each as indecent in the hands of persons under the age of 18 years.

That which concerned the Tribunal in respect of all of these publications, and in fact the great majority of the publications dealing with homosexual males, is the lack of any editorial or other comment about matters relating to safe sex. The Tribunal considers that as AIDS is such a major problem throughout the world and, in particular, amongst the homosexual males in the community, that there is an obligation on the part of publishers producing magazines for the male homosexual market to provide some practical comment and advice on the matter of safe sex.

The Comptroller of Customs, through Mr Wotherspoon, invited the Tribunal to give a serial restriction order under section 15A of the Indecent Publications Act, but the Tribunal is not prepared at this stage to make such an order.

Decision

These publications were commercially imported by mail at Hamilton and seized by the Collector of Customs at Hamilton. The importer has subsequently disputed forfeiture and the publications have been referred to the Tribunal for classification and decision prior to the commencement and condemnation proceedings pursuant to the Customs Act 1966.

These publications, which are in the magazine format, contain a mixture of photographs and text. The common theme of these publications is one of corporal punishment with an

emphasis on the caning and spanking of school girls. A similar publication came before the Tribunal in Decision 12/86 of 13 November 1986, when the Tribunal considered the publication in question, *Victorian Erotica*, Volume 1, No. 1, *Spanking Special*, to be unconditionally indecent as containing the element of violence against females and particularly young females.

For exactly the same reasons are expressed in Decision 12/86 the Tribunal is unanimous that these publications are injurious to the public good and classifies each as unconditionally indecent.
