#### Environmental Impact Report Notified

##### Maui Stage II Development

The Parliamentary Commissioner for the Environment has received an Environmental Impact Report (EIR) on the Maui Stage II Development proposal for audit and investigation. The EIR was prepared by Shell BP and Todd Oil Services Ltd., on behalf of Maui Development Ltd., in accordance with the Government's Environmental Protection and Enhancement Procedures.

The Commissioner's audit and investigation will have regard to the Environment Act 1986. Upon completion it will be referred to the Minister of Energy as well as being presented to the House of Representatives.
