Local Government Act 1974 Harbours Act 1950 Christchurch Harbour Order 1968

Christchurch City Bylaw No. 120A (1988)—Estuary and Foreshore

In pursuance of the powers vested in it by the Local Government Act 1974, the Harbours Act 1950, and the Christchurch Harbour Order 1968, the Christchurch City Council makes this bylaw.

- 1. Title and Commencement:
- (1) This bylaw may be cited as the Christchurch City Bylaw No. 120A (1988) Estuary and Foreshore and shall be read together with and deemed part of the Christchurch City Bylaw No. 120 (1982) Estuary and Foreshore (hereafter referred to as the principal bylaw).
- (2) This bylaw shall come into force on the day it is approved by the Ministers of Conservation and Transport jointly, by notice in the *Gazette*.

2. Definition:

Clause 4 of the principal bylaw is altered by inserting, after the definition of the term "Warden", the following definition:

""Wet-bike' means for the purposes of clauses 15 and 17A a machine capable of travelling over water propelled by power produced from its own engine and which is principally designed to be ridden:

- (a) on skis; or
- (b) by the use of movable control column."
- 3. Nuisance by use and obstruction:

Clause 15 (a) of the principal bylaw is altered by inserting, after the word "any" the words "or wet-bike".

4. New clause inserted

The principal bylaw is altered by inserting, after clause 17, the following clause:

- "17A Wet-bikes
- (a) No person shall operate, navigate or manoeuvre a wetbike within 30 metres of any person bathing or using a surfboard not being a person in any access lane or impeding the use of any access lane in breach of the provisions of section 13 of this bylaw.
- (b) No person shall propel or navigate a wet-bike, the engine of which causes unreasonable noise by reason of:
 - (i) the lack of a silencing device; or
 - (ii) the disrepair of the engine.
- (c) No person shall cause unreasonable noise by accelerating or racing the engine of a wet-bike while the wet-bike is stationary.
- (d) Notwithstanding any other clause in this bylaw no

person shall propel or navigate a wet-bike between the hours of 7.45 p.m. and 8 a.m. in that area of coastal water under the control of the council seawards to a distance of 200 yards measured from the water's edge southwards of an extension of the centre line of Burgess Street to a line extended due east from a point having as its origin the northern-most point of Whitewash Head."

(e) Nothing in clause 1 relating to the use of the District Scheme for the measurement of noise levels shall apply to this clause.

The resolution to make this bylaw was passed by the Christchurch City Council at an ordinary meeting of the council held on the 15th day of February 1988, which resolution was confirmed at a subsequent meeting of the council held on the 21st day of March 1988.

The Common Seal of the Christchurch City Council was affixed in accordance with the special order made by the council on the 23rd day of March 1988.

Electrical Wiring Regulations 1976

Electrical Apparatus Which May Constitute an Electrical Hazard

This notice is subsequent to the public notice in the *New Zealand Gazette*, No. 12 of 11 March 1965, page 319.

1. The apparatus described below may, in my opinion, constitute an electrical hazard.

Description: Three pin flat pin type 10 amp plugs constructed from moulded thermoplastic material in two parts, the two parts being held together in a manner allowing separation without the use of a tool.

- 2. The possible electrical hazard is similar to that arising from the prohibited two-piece rubber plugs that have been the cause of fatal electrical accidents in New Zealand. The cover portion over the terminals of these thermoplastic plugs is intended to be secured to the body portion by being of tight fit when pressed into position but with age, damage or elevated ambient temperature the cover is considered to become sufficiently loose that it could be easily removed and thus expose live terminals.
- 3. The plugs also fail to comply with the following requirements of New Zealand Standard Specification 198:1967 3 pin flat pin plugs, plug-sockets, tap-ons and cord extension sockets with 10 amp 250 volt (maximum) rating:

Clause 4—Materials and Construction.

Clause 11—Identification of contact pins.

Compliance with NZSS 198 is a statutory requirement for such plugs.

- 4. These plugs are likely to be found connected to the flexible cord of portable appliances imported into New Zealand.
- 5. All persons who have purchased appliances fitted with the above-mentioned plugs should arrange for the plugs to be replaced with ones of a safe type immediately and destroy the unsafe ones.
- 6. Every person who sells or offers for sale any apparatus which in the opinion of the Secretary of Energy constitutes or may constitute an electrical hazard commits an offence and shall be liable on summary of conviction to a fine not exceeding \$200.00.

Customs Import Prohibition (Chlorofluorocarbons) Order 1988

The Customs Import Prohibition (Chlorofluorocarbons) Order 1988

Since 1 July 1988, to give effect to New Zealand's obligations under the Montreal Protocol on Substances that Deplete the Ozone Layer, the importation of substances specified in the Customs Import Prohibition (Chlorofluorocarbons) Order have been prohibited except with the consent of the Minister of Trade and Industry and subject to such conditions as he thinks fit. Applicants for consent to import chlorofluorocarbons may be made to the Department of Trade and Industry.

Clean Air Act 1972

Notice of Intention to Amend the Clean Air Zone (Christchurch) Order 1977

Notice is hereby given that the Christchurch City Council has made an application to the Minister of Health, pursuant to section 12 of the Clean Air Act 1972, to amend the Clean Air Zone (Christchurch) Order 1977 in the following manner:

"1. Clause 4 of the above order is amended by inserting after sub-clause 2 (a) the following subclause:

(2B) The exemptions from section 15 of the Act specified in subclause (1) of this clause and the exemption from section 16 (1) of the Act specified in subclause (2) of this clause shall not apply from the 1st day of January 1992.

2. Clause 5 of the above order is amended by revoking subclause 2 (a) of clause 5F and renaming subclause (2) (b)

and subclause (2) (c) as subclause (2) (a) and (2) (b) respectively.

The general effect of the amendments would be to apply to provisions of the clean air zone to all premises from 1 January 1992 and require that only approved appliances and approved fuels are permitted to be installed and used in premises to which the order applies.

A copy of the application may be inspected at the City Health Department, Fourth Floor, Civic Offices, 163 Tuam Street, between the hours of 8.30 a.m. and 4.30 p.m., Monday to Friday, during a period of 6 weeks from 20 July 1988.

Within the said period any person who will be affected by the amendment may, by notice in writing to the Minister of Health, and supplying a copy of the notice to the local authority, object to the recommendation.
