#### Fisheries Act 1983

##### Consent to Barclays Bank NZ Ltd. to Hold 40 percent of Paua Individual Transferable Quota in Central Area (Notice No. 4465)

Pursuant to section 28w (4) of the Fisheries Act 1983, and after consultation with the New Zealand Fishing Industry Board, I hereby consent to Barclays Bank New Zealand Ltd. holding not more than 40 percent of the individual transferable quota for the Central quota management area in respect of paua, upon and subject to the following conditions:

- (a) that it has advanced monies to the quota holder from whom it acquires the ITQ or the quota holder has guaranteed to repay monies advanced by the bank to a third party;
- (b) the ITQ is subsequently leased or subleased back to the quota holder; and
- (c) the quota holder has the right, having complied with the terms of the lease or sublease hereinbefore referred to and with the terms of any other instrument between Barclays and the quota holder relating to the ITQ to obtain the reversionary interest in that ITQ held by Barclays;
- (d) Barclays will not take and will not authorise any other person on its behalf to take the fish to which the ITQ relates other than by transferring or leasing or subleasing the ITQ to a person authorised to acquire the ITQ under the Fisheries Act 1983.

### Conservation

#### Wild Animal Control Act 1977

##### Notification of Prohibition on Hunting or Killing Sambar Deer in all North Island Except Manawatu and Wanganui Areas

Pursuant to section 8 (3) of the Wild Animal Control Act 1977, the Minister of Conservation declares, that, Sambar

deer (*Cervus unicolor*) shall not be hunted or killed or had in possession by any person (other than an employee of the Department of Conservation duly authorised to do so) in the specified area described in the Schedule hereto.

The prohibition shall be for a period of 3 years commencing on 1 October 1988 and expiring on 31 September 1991.

This notice replaces the notice dated 23 December 1986 concerning Sambar deer which was published in the *New Zealand Gazette*, 15 January 1987, page 28.

All the North Island excluding the following area:

All that land contained within a boundary described by the true right bank of the Otaki River from its mouth to the S.H. 1. bridge then along S.H. 1 to the junction of S.H. 1 and S.H. 57; then along S.H. 57 to its junction with S.H. 3 then along S.H. 3 to Sanson then along S.H. 1 to the Rangitikei River; then along the true left bank of the Rangitikei River to the junction of the Rangitikei and Hautapu Rivers; then along the true left bank of the Hautapu River; then along the true left bank of the Hautapu River to where S.H. 1. crosses the river; from this point along a straight line to the junction of the Waitotara River and the Makakaho Stream; from this point along the true left bank of the Waitotara River to its mouth then south along the coastline to the Otaki River mouth.

### Notification of Specified Area for Recreational Hunting of Sambar Deer in Manawatu and Wanganui Areas

Pursuant to section 8(4) of the Wild Animal Control Act 1977, the Minister of Conservation hereby declares that, for the purpose of recreational hunting, Sambar deer (*Cervus unicolor*) may be hunted in the specified area described in the Schedule hereto, subject to the conditions which apply to the specified area. This notice applies from 1 October 1988.

#### Conditions Applying to Specified Area

1. All persons wishing to hunt or kill Sambar deer must hold a current firearms licence and must provide the licence number when applying for a hunting licence except that bow hunters need only provide proof of identity.

2. The hunting season for Sambar deer in 1988 shall comprise the 5 consecutive weekends commencing on 8 October 1988, that is 8-9, 15-16, 22-23, 29-30 October, and 5-6 November 1988.

Each year thereafter the season shall be for 6 consecutive weekends beginning with the third calendar weekend in August.

3. The hunting or killing of Sambar deer within the specified area may only be authorised by a licence issued by the Director-General of Conservation.

4. Applicants for licences must nominate the property on which they have permission to hunt and provide the name of the occupier.

5. Licences shall be valid only when countersigned by the land owner or occupier for those properties nominated. If permission to hunt on other properties is obtained, licence holders must have their licences countersigned in advance of hunting.

6. Licences are not transferable between individual hunters.

7. A limit of one Sambar deer per hunter may be taken during the entire hunting season.

8. The use of a dog, vehicle, vessel, aircraft, artificial light or beater while hunting Sambar deer is prohibited.

9. No person shall hunt Sambar deer with a firearm of a

calibre smaller than 6.5 mm (.264"), with a cartridge case less than 51 mm (2.008") in length and with a projectile weight less than 130 grains. The use of smooth bore weapons and black powder propellant is prohibited. A list of approved cartridge types will be available at all Department of Conservation offices within the specified area.

10. Bow hunters must use a hunting bow with a minimum peak draw weight of 22.5 kilograms and broad head arrows comprising no less than 2 cutting edges. The arrow head shall be unbarbed and the distance between opposing cutting edges at the widest part shall not be less than 25 mm (1"). The use of arrows with any poison, explosive, or other chemical substance on, or in, the head or shaft is prohibited.

11. Shooting is allowed only on specified days which shall be noted on the licence and during the hours from 6 a.m. to 6.30 p.m. inclusive.

12. Game tags must be attached to the Sambar immediately they are secured. Unused tags must be returned with licence returns at the end of the hunting season.

13. The sale of Sambar deer or their by-products is prohibited.

14. All successful hunters must check their bag through a monitoring point specified in the licence and provide autopsy and other data as required in the licence. A full list of monitoring points and the roster for their staffing will be attached to all licences on issue.

15. Any wounded deer must be located and dispatched humanely. Wounded deer which cannot be located by the hunter must be reported to the monitoring point as soon as possible.

16. The licence shall include the following matters:

(a) The times and the rights of the holder to enter, remain on, and use the specified area or part thereof, except that nothing in any licence shall entitle the holder to enter upon any land without the consent of the occupier.

(b) Conditions as to the methods of taking Sambar deer, and the number, type and sex of Sambar deer that may be taken by any licence holder.

(c) The period or conditions under which it remains valid, but shall also provide that it may be revoked at any time at the discretion of the Director-General of Conservation.

(d) The fee paid by the licensee is a condition of the grant of the licence.

17. No person shall act in contravention of any authorisation or condition stated upon a licence to hunt in the specified area or other lawful direction issued by the Director-General of Conservation in respect to wild animal control within the specified area.

**Forestry****Forest Disease Control Regulations 1967****Declaration of Infected Area**

Pursuant to regulation 4 of the Forest Disease Control Regulations 1967, I, Timothy Robert Cutler, Acting Secretary of Forestry, Wellington, with the approval of the Minister of

Forestry, hereby declare the area described in the Schedule hereto to be an infected area in respect of the insect described as a species of Eucalyptus Gall Insect.

**Schedule**

All that area in Wellington, the Hutt Valley, Horowhenua and south west Manawatu, bounded to the south and west by the coast, and to the north by the Rangitikei River from the coast to where it intersects State Highway No. 3 and south-eastwards to the intersection of the Kairanga-Bunnythorpe Road, then following the Bunnythorpe Road to Ashhurst to State Highway No. 3 and to a point where State Highway No. 3 crosses the Manawatu River. The eastern boundary is a line from this point southwards to Turakirae Head on the south coast.

*Notes:*

1. This declaration shall come into effect upon first publication in a newspaper circulated in the infected area.

2. It is an offence to remove any live plant material (including nursery tree stocks, leaf material, branches, logs, or firewood), from the infected area, if such are of any Eucalyptus botryoides or E.saligna, E.grandis, E.deanei and E.robusta until further notice. Nurseries may be permitted to move tree stocks from the infected area on application to the Regional Manager, Ministry of Forestry, Palmerston North.

3. The infected area may be generally and roughly described as Wellington, the Hutt Valley, Horowhenua and south west Manawatu.

**Forest and Rural Fires Act 1977****The Rural Fire Districts Revision Order 1988**

ORDER IN COUNCIL

At Wellington this 30th day of May 1988

Present:

THE RIGHT HON. DAVID LANGE PRESIDING IN COUNCIL

Pursuant to the Forest and Rural Fires Act 1977, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order:

**Order**

1. (1) This order may be cited as the Rural Fire Districts Revision Order 1988.

(2) This order shall come into force on the 28th day after its notification in the *New Zealand Gazette*.

2. (1) The order constituting the Esk Rural Fire District made on the 11th day of November 1963 (a) (hereinafter, in this clause, together with all amendments thereto, referred to as the principal order) is hereby amended by revoking clause 7 of the principal order, and substituting the following clause:

"7. The period between the 1st day of October in any one year and the 30th day of September in the following year (both days inclusive) is hereby declared to be a restricted fire season in the district."

(2) The principal order is hereby amended by revoking clause 10 of the principal order and substituting the following clause:

"MEMBERS

The committee shall consist of seven members as follows:

(a) Three persons appointed by New Zealand Timberlands Ltd. by writing signed on behalf of that company by one director and one secretary thereof;

(b) Three persons appointed by Carter Holt Harvey Forests Ltd. by writing signed on behalf of that company by one director and one secretary thereof; and

(c) one representative of the Hawke's Bay County Council."

(3) This clause shall be read together and be deemed part of the principal order.

3. (1) The order constituting the Marlborough North Rural Fire District made on the 29th day of October 1979 (b) (hereinafter, in this clause together with all amendments thereto, referred to as the principal order) is hereby amended by revoking clause 6 of the principal order and substituting the following clause:

"6. The Marlborough North Rural Fire District shall be administered for the purposes of the said Act by a committee consisting of ten members two of whom represent the Department of Conservation, and one member each representing the Nelson/Marlborough Parks and Reserves Board, the New Zealand Forestry Corporation Ltd. (appointed in writing signed on behalf of that company by one director and the secretary thereof), the Marlborough County Council, the Marlborough Forest Owners Association, the Federated Farmers of New Zealand (this representative shall have territorial interests in the Marlborough North Rural Fire District), New Zealand Fire Services Commission, Marlborough Catchment Board, respectively, and a member of the Residents and Ratepayers Associations within the Marlborough North Rural Fire District, from its inception the said committee to be known as the Marlborough North Rural Fire Committee."

(2) This clause shall be read together with and be deemed part of the principal order.

4. (1) The order constituting the Hunua Rural Fire District made on the 10th day of November 1948 (c) (hereinafter, in this clause together with all amendments thereto, referred to as the principal order) is hereby amended by revoking wherever they occur the words: "and doth hereby specify the period between the first day of October in any one year and the thirtieth day of April in the following year (both days inclusive) as a restricted fire season in the said district;"

(2) This clause shall be read together with and be deemed part of the principal order.

5. (1) In this clause, unless the context otherwise requires, "district" means the Lake Taupo Rural Fire District, the Poutu Rural Fire District, the Kaingaroa Rural Fire District, the Rotoehu Rural Fire District, and the Golden Downs Rural Fire District.

(2) Every reference, in any Order in Council listed in the First Schedule hereto, to the Minister of Forestry shall be read as a reference to the New Zealand Forestry Corporation Ltd., and the fire authority for each district is deemed to be the New Zealand Forestry Corporation Ltd.

Pursuant to section 36 of the Local Government Act 1974, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following order:

#### Order

**1. Title and Commencement**—(1) This order may be cited as the Taupo County - Taumarunui County Boundary Alteration Order 1988.

(2) This order shall come into force on the day of its making.

**2. Boundaries of Taumarunui County and Taupo County Altered**—The boundaries of the district of Taumarunui County and the district of Taupo County are hereby altered by excluding from the district of Taumarunui County and including in the district of Taupo County the area described in the Schedule hereto (hereinafter referred to in this order as "the said area").

**3. Riding boundaries**—The boundary of the Tongariro Riding of Taupo County is hereby altered to include the said area.

**4. Chairman and principal administrative officer**—The chairman and principal administrative officer of the Taupo County Council shall have and may exercise the duties, powers, and functions of the chairman and principal administrative officer of the Taumarunui County Council in respect of the said area.

**5. Transfer of responsibilities and other matters**—The Taupo County Council in respect of the said area:

- (a) Shall have and may exercise and be responsible for all the powers, duties, acts of authority, and functions which were previously exercised, or which would have been so exercised, by the Taumarunui County Council;
- (b) Shall have and may exercise and be responsible for all liabilities, obligations, engagements, and contracts which previously were, or which would have been, the responsibility of the Taumarunui County Council;
- (c) Shall have and may exercise and be responsible for all actions, suits, and proceedings pending by or against, or which would have been the responsibility of, the Taumarunui County Council;
- (d) Shall succeed to the bylaws which are in force and which are applicable to its altered circumstances and, until revoked or altered by the Taupo County Council, every such bylaw shall remain in force in the area in which it was in force immediately before the alteration of boundaries; and every bylaw which cannot be restricted to the said area shall be deemed inapplicable and revoked in respect of the said area by the alteration of boundaries;
- (e) Shall succeed to all rates or levies or other money payable to the Taumarunui County Council;
- (f) Shall succeed to the valuation rolls, electoral rolls, and rate records in force in the said area, and these shall

remain in force until such rolls or records are made by the Taupo County Council, and until that time Part XIV of the Rating Powers Act 1988 shall apply in the said area as if the district in which the said area is included was the district of a special purpose authority and the said area was a constituent district.

**6. Vesting of land**—The corporation of the Taupo County Council shall, in respect of the said area, have vested in it, subject to all existing encumbrances, all land in that area vested in the corporation of the Taumarunui County Council.

**7. Title to land**—Any reference (express or implied) to:

- (a) "The Taumarunui County Council"; or
- (b) "The Chairman, Councillors and Inhabitants of the County of Taumarunui"

in any instrument or other document whatever, or in any entry or record made on any document whatever, or in any entry or record made in any register in relation to any instrument or other document whatever, relating to any land vested in the Taupo County Council by clause 6 of this Order, shall, unless the context otherwise requires, be read as a reference to "The Taupo County Council".

**8. Creditors**—Subject to section 37F of the Local Government Act 1974, the rights or interests of creditors of any district affected by this Order shall not be affected.

**9. Apportionment of assets and liabilities**—There shall be no apportionment of assets and liabilities including loan liabilities pursuant to clause 2 of this order.

**10. Civil defence**—The operative local civil defence plan for the district of Taupo County shall apply to the said area, and shall be the only operative civil defence plan to apply in that area.

#### Schedule

All that area in the Wellington Land District, Taumarunui County, situated in Blocks V and IX, Puketi Survey District, bounded by a line commencing at a point in the middle of the mouth of the Waihi Stream and proceeding south-westerly along a right line towards Trig Station Tongariro to its intersection with the south-western boundary of Waihi Kahakaharoa 7; thence north-westerly along that boundary and the south-western boundary of Waihi Kahakaharoa 6B to the westernmost corner of that section; thence north-easterly along the south-eastern boundaries of Waihi Kahakaharoa 5, 4B, 4A, 3B2B2A and a right line across State Highway 41 to the south-eastern boundary of part Waihi Kahakaharoa 3B2 (M.L. 5316); thence north-easterly along that boundary and its production to the middle of the Waihi Stream; thence south-easterly down the middle of that stream to the point of commencement.
