Berryfruit Marketing Licensing Regulations 1983

Fixing Rates of the Berryfruit Levy (Notice No. 4468; Ag. 4/54/8)

Pursuant to regulations 18 (2) and 18 (3) of the Berryfruit Marketing Licensing Regulations 1983, having regard to the recommendations of the Berryfruit Marketing Licensing Authority, I hereby fix:

- (a) rates of 4 cents per kilogram (excluding GST) for boysenberries sold for export or processing, 2 cents per kilogram (excluding GST) for all blackcurrants sold for export or processing, 20 cents per kilogram (excluding GST) for all blueberries sold for fresh export and 4 cents per kilogram (excluding GST) for all blueberries sold for processing at which the berryfruit levy is to be paid in the year ending on 30 September 1989;
- (b) the manner of payment and collection of such levy shall be by deduction by exporters, processors, co-operatives or dealers from payments at the point of first sale of the boysenberries or blackcurrants or blueberries being levied, and forwarding to the Secretary, Berryfruit Marketing Licensing Authority, P.O. Box 10050, Wellington.

It is the intention of the Berryfruit Marketing Licensing Authority to spend the money yielded from each levy in part on administration, with the balance to be used on: promotion and market development for the boysenberry industry; research for the blackcurrant industry; and promotion and research for the blueberry industry.

Pursuant to section 4 of the Berryfruit Levy Act 1967, having regard to the recommendations of the New Zealand Berryfruit Growers' Federation (Inc), I hereby fix the rates of annual levy to be paid by berryfruit growers in respect of their gardens, to the Federation:

Electrical Wiring Regulations 1976

Specification Declared Suitable

Pursuant to the provisions of regulation 18 (3) of the Electrical Wiring Regulations 1976, the following specification is declared suitable for the purposes of those regulations.

Australian Standard

AS 3108. 1-2-3—1984 and Amendment No. 1—1986.

Approval and Test Specification - Isolating Transformers and Safety Isolating Transformers.

Part 1—General requirements.

Part 2—Supplementary Requirements—Isolating Transformers.

Part 3—Supplementary Requirements—Safety Isolating Transformers.

Declared suitable subject to the following conditions of Part 1—

1. Clause 19.1—delete Australian.
2. Clause 19.3—replace "15" with "10".
3. Clause 21.6—replace "20" with "10".

Compliance with a declared standard specification shall not preclude the need to comply with the requirements of the Electrical Wiring Regulations 1976.

Electrical Apparatus which may Constitute an Electrical Hazard

Prohibition

Pursuant to regulation 8 of the Electrical Wiring Regulations 1976, notice is hereby given that the accessory described below may in my opinion constitute an electrical hazard, and is therefore prohibited from use in New Zealand.

Description: An adaptor, being of a two-pin flat-pin to two-pin parallel or round pin non-polarised socket type.

The prohibited adaptor is that which has one or more of the following faults:

- a. Not marked with the manufacturer's name or trade mark;
- b. Not marked with the rated voltage and current;
- c. Has a clearance from pin to edge of housing of less than 9 mm as specified in NZS 198;
- d. Is made in two parts where the two halves are not adequately secured together.

The possible electrical hazards are:

a. The inadequate clearance which could result in fingers (particularly those of children) accidentally contacting live parts while the adaptor is being inserted or withdrawn from a socket outlet;

b. The two parts can easily be parted thereby exposing live parts.

Every person who sells or offers for sale any apparatus, materials or accessories which in the opinion of the Secretary of Energy constitutes or may constitute an electrical hazard commits an offence and shall be liable on summary of conviction to a fine not exceeding \$200.

British Settlements Act 1887

Officers of Government of Ross Dependency Appointed

RONALD DAVISON, Administrator of the Government

WHEREAS, by an Order in Council dated the 30th day of July 1923*, made under the British Settlements Act 1887 of the United Kingdom Parliament, the Governor-General and Commander-in-Chief of New Zealand for the time being (hereinafter called the Governor) was appointed to be the Governor of the Ross Dependency, and all the powers and authorities which by the said order were given and granted to the Governor for the time being of the Dependency were thereby vested in him:

And whereas the Governor was thereby further authorised and empowered to make all such rules and regulations as might lawfully be made by Her Majesty's authority for the peace, order, and good government of the Dependency:

And whereas, by regulations made by the Governor on the 14th day of November 1923†, it was enacted that all persons appointed by the Governor for the time being of the Dependency should have such power and authority as might be granted them in due course of law, and might be empowered to do such things as might be necessary or desirable to ensure that the laws in force in the Dependency are duly observed and complied with in every respect, and to do all things necessary or expedient for the peace, order, and good government of the Dependency, and to safeguard and preserve Her Majesty's rights and sovereignty over and in respect of the Dependency:

And whereas it is expedient that the persons hereinafter

named be appointed officers of the Government of the Dependency:

And whereas the Governor-General and Commander-in-Chief of New Zealand is for the time being absent from New Zealand, and the said Order in Council dated the 30th day of July 1923 provided for the Administrator of the Government of New Zealand to be Governor of the Dependency during any such absence:

Now, therefore, I, The Right Honourable Sir Ronald Keith Davison, the Administrator of the Government of New Zealand, and as such the Governor of the Ross Dependency, hereby appoint

David Osborne Crerar, Esquire

as an officer of the Government of the Dependency for the period beginning with the 1st day of October 1988 and ending with the close of the 28th day of February 1989 or such earlier date as he shall leave the Dependency:

And I hereby confer on the said David Osborne Crerar while he holds office all the powers and authorities that may be exercised in New Zealand by a Justice of the Peace, and also the powers and authorities that may be so exercised by a Coroner:

And I hereby also appoint

Hugh Nigel Millar, Esquire

as an officer of the Government of the Dependency for the

period beginning with the 1st day of October 1988 and ending with the close of the 31st day of October 1989 or such earlier date as he shall leave the Dependency:

And I hereby confer on the said Hugh Nigel Millar while he holds office all the powers and authorities that may be exercised in New Zealand by a Justice of the Peace, and also all the powers and authorities that may be exercised by a Coroner:

The said David Osborne Crerar and Hugh Nigel Millar to exercise their functions at such places within the Dependency as may be directed by the officer for the time being appointed as an officer of the Government of the Dependency in whom is vested the general executive and administrative authority in preserving Her Majesty's rights and sovereignty and the laws and regulations in force in the Dependency.

As witness the hand of His Excellency the Administrator of the Government as the Governor of the Ross Dependency, this 20th day of September 1988.

Franklin Electric Power Board Electricity Supply Licence 1988

I, David John Butcher, Minister of Energy, acting pursuant to section 20 of the Electricity Act 1968, hereby licence Franklin Electric Power Board, hereinafter called the Electrical Supply Authority, to supply electricity, and to lay, construct, put up, place and use all electric lines and works which may from time to time be required for the distribution and supply of electricity within the area specified in the Schedule hereto.

This licence is issued subject to the following conditions:

Conditions

1. This licence may be cited as the Franklin Electric Power Board Electricity Supply Licence 1988.
2. The Electrical Supply Authority shall comply with the provisions of this licence, the Electricity Act 1968 and all enactments made in amendment of or substitution for that Act, any Electrical Codes of Practice made under that Act, the Electrical Supply Regulations 1984, the Electrical Wiring Regulations 1976 and all regulations made in amendment of or substitution for any of those regulations.
3. Any notice to be given to the Electrical Supply Authority shall be sufficient if sent by registered post letter to the offices of the Electrical Supply Authority.
4. Any notice to be given on the part of the Minister of Energy shall be sufficient if given in writing signed by the Minister or by any persons acting under the authority of the Minister.
5. Any notice to be given to the Minister of Energy shall be sufficient if given in writing to or sent by registered post letter addressed to the Secretary of Energy, Ministry of Energy, Wellington.
6. This licence shall come into force on the 30th day of June 1988 and shall continue in force until the 31st day of March 2009 unless it is sooner lawfully determined in accordance with clauses 7 or 8 hereof.
7. The Governor-General in Council may, pursuant to section 22 of the Electricity Act 1968, cancel this licence if the Electrical Supply Authority is in breach of the provisions contained in clause 2 of these conditions.
8. This licence may be cancelled by the Minister of Energy at the request of or with the consent of the Electrical Supply Authority.
9. At the expiry or cancellation of this licence, the Electrical Supply Authority shall, as required by notice in writing by the Minister of Energy, remove all buildings, poles and other erections and all transmission lines, plant and other machinery and other removable equipment authorised by the licence to be erected, installed or provided and if, within 12 months after being so required the Electrical Supply Authority fails or neglects to remove the same, then the same shall, without payment of any compensation vest in and become the property of the Crown and it shall be lawful for any person authorised by the Minister of Energy in that behalf, subject to compliance with section 15A of the Electricity Act 1968, to enter upon any land or premises and take possession of and remove the same or any part thereof.
10. Nothing contained in the licence, either expressly or by implication shall be deemed to authorise the Electrical Supply Authority to erect, construct or maintain any lines or works except subject to such conditions (not inconsistent with this licence) as may from time to time be lawfully imposed by any local authority within the district of which any such lines or works may be situated.
11. The systems of supply shall be as described in paragraphs (a), (b), (c), (d), (e) and (f) of regulation 13 of the Electrical Supply Regulations 1984.
12. The Electrical Supply Authority shall, six months prior to the expiry of the term of this licence provided in clause 6 herein, make written application to the Minister of Energy for the granting of a new licence.

1. This notice may be cited as the Hastings City Boundary Definition Notice 1988.
