Customs Act 1966: Anti-Dumping Duty Review

On 26 January 1988, the Minister of Customs gave notice of a final determination of dumping being found against Comalco Aluminium Ltd. of Australia and Austral Bronze Crane Copper Ltd. of Australia in respect of certain unworked aluminium sheet, plate and coil.

Included in the final determination was the product "ALCLAD" coil, Alloy 3004, Temper H34, manufactured and exported to New Zealand by Comalco Aluminium Ltd. of Australia.

In terms of section 186L (5) of the Customs Act 1966 a review investigation has been conducted.

Pursuant to the provisions of section 186L (6) of the Customs Act 1966, notice is hereby given that the anti-dumping duty applicable to the product "ALCLAD" in terms of section 186L (1) will be suspended until further notice.
