### **Electricity Act 1968**

### Taupo Electricity Ltd. Electricity Supply Licence 1988

I, David John Butcher, Minister of Energy, acting pursuant to section 20 of the Electricity Act 1968, hereby licence Taupo Electricity Ltd., a wholly owned subsidiary of the Taupo Borough Council, pursuant to the Taupo Borough Council Empowering Act 1987, hereinafter called the Electrical Supply Authority to supply electricity, and to lay, construct, put up, place and use all electric lines and works which may from time to time be required for the distribution and supply of electricity within the area specified in the Schedule hereto.

This licence is in addition to that issued to the Taupo Borough Council on 20 March 1985\* and is issued subject to the following conditions:

#### **Conditions**

- 1. This licence may be cited as the Taupo Electricity Ltd. Electricity Supply Licence 1988.
- 2. The Electrical Supply Authority shall comply with the provisions of this licence, the Electricity Act 1968 and all enactments made in amendment of or substitution for that Act, any Electrical Codes of Practice made under that Act, the Electrical Supply Regulations 1984, the Electrical Wiring Regulations 1976 and all regulations made in amendment of or substitution for any of those regulations.
- 3. Any notice to be given to the Electrical Supply Authority shall be sufficient if sent by registered post letter to the offices of the Electrical Supply Authority or sent by tele facsimile or delivered by hand to that registered office. Such notice if sent by post will be deemed to have been received by the Electrical Supply Authority on the third day after the date of posting.
- 4. Any notice to be given on the part of the Minister of Energy shall be sufficient if given in writing signed by the Minister or by any persons acting under the authority of the Minister.
- 5. Any notice to be given to the Minister of Energy shall be sufficient if given in writing to or sent by registered post letter addressed to the Secretary of Energy, Ministry of Energy, Wellington.
- 6. This licence shall come into force on the 1st day of October 1988 and shall continue in force until the 31st day of March 2009 unless it is sooner lawfully determined in accordance with clauses 7, 8, 9 or 11 hereof.
- 7. The Governor-General in Council may, pursuant to section 22 of the Electricity Act 1968, cancel this licence if the Electrical Supply Authority is:
  - (a) In breach of the provisions contained in clauses 2, 9 or 11 of these conditions; and/or
  - (b) Placed in receivership or goes into liquidation in terms of the Companies Act 1955.
- 8. This licence may be cancelled by the Minister of Energy at the request of or with the consent of the Electrical Supply Authority.
- 9. The shares of Electrical Supply Authority shall, subject to clause 11 of these conditions, remain wholly owned by the Taupo Borough Council or its successor, the Taupo District Council.
- 10. On the date of the coming into force of this licence, the Electrical Supply Authority shall deposit with the Minister documents stating the following:
  - (a) The total number and type of shares.
  - (b) The name of the owner, the type and number of shares of each individual shareholder.

- 11. Any change in:
  - (a) The total number of the shares; or
  - (b) The type of any or all of the shares; or
  - (c) The ownership of any or all of the shares,

shall require the prior consent of the Minister. The Minister in granting such a consent may set any conditions as he deems proper.

- 12. At the expiry or cancellation of this licence, the Electrical Supply Authority shall as required by notice in writing by the Minister of Energy remove all buildings, poles and other erections and all transmission lines, plant and other machinery and other removable equipment authorised by the licence to be erected, installed or provided and if within 12 months after being so required the Electrical Supply Authority fails or neglects to remove the same, then the same shall, without payment of any compensation vest in and become the property of the Crown and it shall be lawful for any person authorised by the Minister of Energy in that behalf, subject to compliance with section 15A of the Electricity Act 1968 to enter upon any land or premises and take possession of and remove the same or any part thereof.
- 13. Nothing contained in the licence, either expressly or by implication shall be deemed to authorise the Electrical Supply Authority to erect, construct or maintain any lines or works except subject to such conditions (not inconsistent with this licence) as may from time to time be lawfully imposed by any local authority within the district of which any such lines or works may be situated.
- 14. The systems of supply shall be as described in paragraphs (a), (b), (c), (d), (e), (f) and (j) of regulation 13 of the Electrical Supply Regulations 1984. The system of supply authorised under paragraph (j) aforesaid shall be a single-conductor earth-return system of 11 000 volts between conductor and earth, and the use thereof shall be subject to such terms and conditions as are from time to time laid down by the Secretary of Energy.
- 15. The Electrical Supply Authority shall, 6 months prior to the expiry of the term of this licence provided in clause 6 herein, make written application to the Minister of Energy for the granting of a new licence.

### Schedule

### Area of Supply

All that area in the South Auckland, Hawke's Bay and Wellington Land Districts commencing at the confluence of the Okaia Stream with the northern shore of Lake Taupo in Block XVI, Marotiri S.D. and proceeding generally northerly up the middle of that stream to the western boundary of Whangamata Block, thence generally northerly along that boundary and the western boundary of Tatua West Block to the southern boundary of Block IX, Atiamuri S.D.; thence easterly along the southern boundaries of said Block IX and Blocks X and XI, Atiamuri S.D. to the western side of State Highway No. 1; thence generally southerly, along that western side to a point in line with the southern boundary of Tatua East No. 2 Block; thence along that right line to and along that boundary to the eastern boundary of part Tatua East No. 3A Block; thence generally southerly along that boundary to the southern boundary of Lot 2, D.P. 16198; thence south-easterly along that boundary to the north-western boundary of Tutukau West B Block; thence generally south-westerly along that boundary and generally southerly along the western boundaries of the aforementioned block to the westernmost extremity of part Tutukau East B6 Block; thence southeasterly along the south-western boundary of that block to and along a right line across Tutukau Road to the northernmost extremity of part Te Hukui Block; thence generally southerly along the western boundaries of that block to the western boundary of Section 1, Block VI, Tatua S.D.; thence generally south-westerly, south-easterly and north-easterly along the

western, southern and eastern boundaries to the southern boundary of part Tahorakuri No. 3 Block; thence southeasterly along that boundary to its easternmost point; thence due east to the western boundary of Block V, Takapau S.D.; thence southerly and easterly along the western and southern boundaries of said Block V, and the southern boundaries of Blocks VI and VII, Takapau S.D. to and southerly along a right line between Trig Waimahunga Block III, Takapau S.D.; and Trig Waiti Lookout in Block X, Takapau S.D., and its production to the southern boundary of Block XIV, Takapau S.D.; thence easterly along the southern boundaries of said Block XIV and Block XV, Takapau S.D. to and southerly along the western boundary of Block IV, Otukotara S.D. to and easterly along the southern boundary of said Block IV and the southern boundaries of Blocks I, II and III, Heruiwi S.D. to and southerly along a right line between Trig F, Tiritiri, Block III, Heruiwi S.D. and Trig B, Pukeroa, Block XI, Heruiwi S.D. to said Trig B; thence south-easterly along a right line to Trig Te Taumutu, Block XVI, Heruiwi S.D. being a point on the south-eastern watershed of the Rangitaiki River; thence generally southerly along that watershed to the northernmost corner of Pohokura No. 1 Block; thence southerly down the western boundaries of the last-mentioned block to the southwestern corner of that block; thence westerly along the southern boundaries of Block XIII, Mangahopai West Survey District, Blocks XVI, XV, XI and XIV, Runanga Survey District and the production of the last-mentioned boundary to the middle of the Waipunga River; thence generally southerly down the middle of that river to the western boundary of Block VII, Tarawera Survey District; thence southerly along the said boundary and the western boundary of Block XI, aforesaid to the north-eastern boundary of part Tarawera No. 8; thence north-westerly along that boundary, and again north-westerly, south-westerly and south-easterly along the north-eastern, north-western and south-western boundaries of Tarawera 10A, including the crossing of the northern end of the Omarowa Roadway, to a point in line with the middle of a tributary of Toropapa Stream; thence south-westerly to and up the middle of that tributary to the southern boundary of Block X, Tarawera S.D., approximately 201 metres east of the southwestern corner of that block; thence westerly along that block boundary and the southern boundary of Block IX, Tarawera S.D., to the eastern boundary of Wharetoto No. 1; thence southerly and westerly generally along the eastern and generally southern boundary of No. 1 aforesaid and the lastmentioned boundary produced to the middle of the Mohaka River; thence southerly along the middle of that river to a right line from Trig 65A in Block XXI, Kaweka S.D. and passing through Trig 68A in Block XIII, Kaweka S.D.; thence along that right line to Trig 65A aforesaid; thence westerly along a right line to Trig 26 (Tawake Tohunga), in Block XII, Mangamaire S.D. and northerly along a right line to Trig Ahipaepae in Block XIV, Waitahanui Survey District; thence north-westerly along a right line to a point on the western boundary of Block V, Waitahanui S.D., approximately 1005 metres south of the southern boundary of Block I, Waitahanui S.D.; thence northerly along the western boundaries of said Block V and said Block I to the shore of Lake Taupo; thence generally northerly and easterly along said shore to the point of commencement.

The said area being more particularly shown outlined in black on the plan numbered NZE 2075 (sheets 1 to 11) deposited in the offices of the Ministry of Energy at Wellington.

### Video Recordings Act 1987

### Video Recordings Board of Review

### Inches

- 1. A review was sought of the Video Recordings Authority's classification of the video *Inches* by the Society for the Promotion of Community Standards (the applicant) pursuant to section 36 of the Video Recordings Act 1987 (the Act).
- 2. The Video Recordings Board of Review (the board) has reexamined the video in accordance with section 48 of the Act. The board reached its decision without having to consult with the applicant or the authority.
- 3. The video tells the story of what Doug, the central character of the video film, does following the breakdown of his 3-year old homosexual relationship with Lee. He seeks solace in a casual encounter with a hitchhiker, a visit to the "Bull-Pen" (a night club for homosexual males), and in an interlude with Tony the photographer. Tony's exhibition of photographs provocatively named *Inches* gives title to the film.
- 4. A large part of the video concentrates visually on male genitalia and anal areas. The dialogue contains some coarse language and is difficult to hear. None of it is memorable. The plot of the video is a thin disguise for the portrayal of explicit sexual activities of homosexual males. The film begins with a prolonged masturbation sequence by Doug on the bed, while Lee his partner masturbates in the shower. It progresses from masturbation to ejaculation, to fellatio, anal exploration and licking and anal intercourse to a scene in the night club where one man urinates on another's naked body. The scenes are detailed and prolonged. Some are filmed as if they are part of Doug's dreams or nightmares where Lee is portrayed as sexually servicing a group. Others portray in detail sexual activities between pairs. The scene in the night club which is called the "Bull-Pen" portrays anonymous multiple and random sexual activity.

The film is entirely homosexual. No woman is seen during its running. Only one female voice is briefly heard in a background song.

- 5. The board considers that:
  - (a) The dominant effect of the video is the depiction of homosexual sexual activities for private viewing by homosexual males.
  - (b) The video recording has little or no artistic, social or cultural merit. It attempts to comment upon the desirability of long-term loving relationships between pairs of homosexual males in contrast to the undesirability of short term fleeting encounters.

- (c) The video recording is likely to be viewed by adult homosexual males and adult heterosexuals who are curious about homosexual activities.
- (d) The board finds that the video contains no cruelty, horror, violence or crime. The video does not denigrate any class of persons. The explicit sexual acts displayed are between consenting adults. There are caring sequences and an underlying concern is expressed to establish caring relationships.
- (e) The particular purpose for which the video is to be used was agreed by the board to be entertainment.
- 6. The board considers that because sexual preference and orientation is established earlier in life the video would not damage the sexuality of anyone if it was labelled R 18. It was thought that heterosexual viewers would regard much of the film as alien.

However, the board expresses great concern over two matters:

(i) The scenes of explicit sexual activity shown in the video are seen as unsafe by today's standards. There is a rising public awareness of the dangers of indulging in sexual intercourse with more than one partner without taking prophylactic measures. The visual portrayal of acts which are part of people's life-style may not be indecent, but the problem of sexually transmitted diseases including AIDS adds a whole new dimension.

The board is aware that prophylactics are freely available to adults. If videos such as *Inches* which show sexually explicit scenes are to be available for adult viewing then it ought to be able to be assumed that adults will take proper precautions. Despite this, the board sees value in some sort of health warning being issued with the video. It has recently reviewed a video which began with a promotion for safe sex and which recommended that condoms be used. The board is aware that neither it nor the authority has the power to make additions to videos by issuing health warnings. The board sees this as a deficiency in the Act which should be remedied.

(ii) If the video *Inches* can be seen to have any social message at all the message is about permanent caring relationships. The bar scene in the "Bull-Pen" negates the message. The scene portrays multiple anonymous random sexual encounters in a semi-public place. No precautions are taken against disease. No adverse comment is made about the deviant and dangerous practices that are taking place. The board found the scenes in the "Bull-Pen" to be indecent.

If certain cuts were made in the bar scene sequence the board unanimously agrees that it would classify the video to be indecent in the hands of persons under the age of 18 years with the description CONTAINS EXPLICIT SEXUAL MATERIAL.

7. The board is of the unanimous view that without the cuts and for the reasons outlined above that the video *Inches* is injurious to the public good and should be classified as indecent.

### Video Recordings Board of Review

### **Hot Rackets**

- 1. A review was sought of the Video Recordings Authority's classification of the video *Hot Rackets* by the Society for the Promotion of Community Standards (the applicant) pursuant to section 36 of the Video Recordings Act 1987 (the Act).
- 2. The Video Recordings Board of Review (the board) has reexamined the video in accordance with section 38 of the Act. The board reached its decision without having to consult with the applicant or the authority.
- 3. The plot is about a married couple Liz and Herb Adam whose marriage does not appear to be sexually satisfactory. Herb, the husband spends a lot of time at a tennis club and Liz goes to the club to see what the attraction is. She finds more sexual activity than tennis at the club. The activities of Liz and Herb's maid and the chauffeur provide a sub-plot for the sexual fantasies portrayed. In the opening scene of the film the maid services Herb in the shower after he has been rejected by his wife. While Liz and Herb are at the tennis club indulging in sexual activities the maid and the chauffeur engage in similar activities at home and in a greenhouse on the way home from the supermarket.
- 4. The plot is no more than a flimsy vehicle for detailed and prolonged displays of various types of sexual activity. Apart from a lesbian sequence between Liz and Kelly, the tennis club's masseuse, and a brief close-up of Liz masturbating using a vibrator, the activities depicted are on a one man/one woman basis. There is one scene at the end of the film which shows group sexual activity at a swimming pool party. The activities portrayed include fellatio, cunnilingus, vaginal sex, and vaginal sex with rear entry. There is a brief scene where a man ejaculates over a woman's face. When ejaculation takes place for the most part it is portrayed as being over a woman's belly.

In some of the scenes there are crude attempts at humour where the camera shows breasts and penises popping out of clothing during tennis games. Some of the action is farcical and much of it is silly.

The dialogue contains course language and often is difficult to hear. The sound track is of poor quality and in places drowned out by noise of a jacuzzi, a generator in the greenhouse and an aeroplane.

- 5. The board considers that:
  - (a) The dominant effect of the video is a sexual fantasy which attempts to titillate heterosexual viewers.
  - (b) The video recording has no artistic, social or cultural merit.
  - (c) The video recording is likely to be viewed by adults.
  - (d) The board finds that the video contains no bondage, horror, violence or crime. The explicit sexual acts displayed are between consenting adults. The video contains offensive language.

There is a particular scene which the board regards as extremely cruel. The maid and the chauffeur are shown having sexual intercourse in a greenhouse. A blind man approaches and thinks they are in trouble or pain. He fumbles around outside the glass and finally manages to enter the greenhouse. He trips and collides with the naked chauffeur and then with the naked maid. She strips him

- and performs an act of oral sex. The blind man in climax calls out "I can see". The board regards the cruel mockery of a person's disability in this manner as being beyond merely tasteless. It is indecent.
- (e) The board agrees that the particular purpose for which the video is to be used is private viewing for entertainment.
- (f) The board considers that parts of the video could denigrate women by reinforcing sexual stereotyping attitudes that the role of women is to sexually service the male. In one scene a young woman is paid for sex. The masseuse is depicted as working full time at giving sexual satisfaction. The maid who dresses in a short frilly uniform reminiscent of the French farce has the principal role of sexually servicing the men in her life.
- 6. Once again the board is aware of the public health concerns. The public is becoming more conscious of sexually transmitted diseases and in particular AIDS. When sexual activities with multiple partners take place the danger increases. There was not a condom in sight in this video.

The board is aware that prophylactics are freely available to adults. If videos such as *Hot Rackets* which show sexually explicit scenes are to be available for adult viewing then it ought to be able to be assumed that adults will take proper precautions. Despite this, the board sees value in some sort of health warning being issued with the video. It has recently reviewed a video which began with a promotion for safe sex and which recommended that condoms be used. The board is aware that neither it nor the authority has the power to make additions to videos by issuing health warnings. The board sees this as a deficiency in the Act which should be remedied.

- 7. The board considers that if certain cuts were made in the scene that takes place in the greenhouse with the blind man it would classify the video to be indecent in the hands of persons under the age of 18 years with the description CONTAINS EXPLICIT SEXUAL MATERIAL.
- 8. The board is of the unanimous view that without the cuts and for the reasons outlined above that the video *Hot Rackets* is injurious to the public good and should be classified as indecent.
