(2) This notice shall come into force on the 2nd day of January 1988. 2. Exchange rates - Where under any provisions of the Customs Act 1966 any amount which is required to be taken into account for the purpose of assessing duty or any other purpose is not an amount in New Zealand currency,

the amount to be so taken into account shall be the equivalent in New Zealand currency of that amount ascertained in accordance with the rate of exchange which is available from your nearest Customs office.

3. Revocation - The Customs Exchange Rates Notice (No. 26) 1988, published in the New Zealand Gazette, Customs Edition No. 208, dated 6th December 1988, on page 5209 is hereby revoked.
4. Publication - The next Customs Exchange Rate Notice will be published in

the New Zealand Gazette, Customs Edition on 17 January 1989.
