#### **Marine Farming Act 1971**

Declaring Areas in Mahurangi Harbour Not Available for Marine Farming Leasing or Licensing (Notice No. 4916)

Pursuant to section 4 of the Marine Farming Act 1971, the Minister of Fisheries has made the following determination.

- 1. That the notice entitled "Declaring Areas in Mahurangi Harbour Not Available for Marine Farming Leases or Licences" (Notice No. 2697, Ag. 9/5/K) of the 7th day of October 1981 appearing in the New Zealand Gazette, No. 122 of the 22nd day of October 1981 at page 2917 is hereby revoked.
- 2. That the notice entitled "Declaring Areas in Mahurangi Harbour Not Available for Marine Farming Leases or Licences" (Notice No. 4134) of the 27th day of July 1987 appearing in the New Zealand Gazette, No. 128 of the 6th day of August 1987 at page 3726 is hereby revoked.
- 3. That the area described in the First Schedule hereto shall not be available for marine farming leases and licenses.
- 4. That the area described in the Second Schedule hereto is suitable for marine farming but shall not be available for leasing or licensing.

The determination shall come into effect on the date of publication of this notice and shall remain in effect until such time as it is revoked.

All that area of seabed and water in the Mahurangi Harbour identified as "cleansing area" and coloured yellow on plan No. MAF 194 and as shown marked A on S.O. Plan 61368.

The plan No. MAF 194 is lodged in the office of the Fisheries Management Division at the Head Office of the Minister of Agriculture and Fisheries in Wellington and the regional office in Auckland.

#### **Broadcasting Act 1989**

# Statement of Government Policy Relating to Broadcasting

To the Secretary of Commerce.

Whereas the provisions of the Broadcasting Act 1989 that provide for the removal of certain controls on who may

broadcast programmes come into force on the 1st day of July 1989:

And whereas the Government has announced that it intends to introduce in the House of Representatives a Radiocommunications Bill providing for the creation of property rights in the use of the radio spectrum, and enabling the allocation of those rights by the Crown:

And whereas the Government considers that it is desirable that there be a smooth transition from the present system to the system proposed to be established under the Radiocommunications Bill:

Now therefore I, David John Butcher, Minister of Commerce, acting pursuant to regulation 13 of the Radio Regulations 1987, hereby give you notice that it is part of the policy of the Government in relation to broadcasting—

- (a) That, subject to paragraph (d) of this notice, the allocation of radio frequencies for the establishment of new continuous television broadcasting services (other than in compliance with section 95 of the Broadcasting Act 1989) should in all cases be provided for under the policies to be implemented under the proposed Radiocommunications Bill; and
- (b) That, subject to paragraph (e) of this notice, the allocation of radio frequencies for the establishment of new continuous sound radio broadcasting services (other than in compliance with section 95 of the Broadcasting Act 1989) should be provided for under the policies to be implemented under the proposed Radiocommunications Bill in all cases where the demand for frequencies for the new services is likely to exceed the availability of such frequencies; and
- (c) That radio apparatus licences should continue to be granted, on a short term basis with no right of renewal, where unused frequencies are available, to allow for uses of the radio spectrum that, under the Broadcasting Act 1976, would have been provided for by the granting by the Broadcasting Tribunal of short term broadcasting authorisations under the Broadcasting Act 1976 where—
  - (i) The organisation applying for the licence is a nonprofitmaking or charitable organisation and proposes to broadcast for no longer than 28 consecutive days; or
  - (ii) The organisation or person applying for the licence held a short term broadcasting authorisation during the year commencing on 1 July 1988 and ending with the close of 30 June 1989 that authorised it to provide a broadcasting service that was the same for all practical purposes as that which it proposes to provide under the radio licence it is applying for; and
- (d) That radio apparatus licences should be granted or amended to allow the television services known as TV1, TV2, and TV3 to extend the coverage of their services to areas not otherwise able adequately to receive those services; and
- (e) That subject to New Zealand's international obligations being met, radio apparatus licences may be issued for high frequency broadcasting services.

#### **Electrical Wiring Regulations 1976**

#### **Notice of Prohibition**

#### Brass Portable Table Top Lamp Fittings With a Line Cord Rotary Switch Type Dimmer Control

Pursuant to regulation 8 of the Electrical Wiring Regulations 1976, notice is hereby given that the Brass Portable Table Top Lamp Fittings described below, in my opinion constitute or may constitute an electrical hazard and are unsuitable for use in New Zealand.

#### Description:

Brass Portable Table Top Lamp Fittings (3 models—small, medium and large); with rotary switch dimmer control, Edison screw type lampholders and brass outlined petal shaped decorative glass lamp shades; one model has a tinted glass sectional shade.

#### Markings:

Made in Taiwan or (R.O.C. Taiwan) on base.

Some known faults of the three models are:

- (a) They have exposed live parts accessible to the touch. The Edison screw type lampholders are incorrectly wired. (Phase to the outer terminal in contravention to regulation 97.2).
- (b) The in line cord rotary switch type dimmer associated with the fitting, does not appear to comply with an appropriate standard.
- (c) The fittings have faults in construction such as inadequate cord anchorage; soldered joints which are not mechanically sound in the dimmer; very sharp edges in the internal wire ways with consequent damage to the conductors.

**22.1.2** Terms and conditions: The acceptance and carriage of parcels shall be in accordance with clause 20 of the General Scale of Charges except that hazardous or dangerous goods and motorcycles will not be accepted, and clauses 20.14.4 and 20.14.5 shall not apply to the carrying of parcels.

#### 22.2 Rates to be prepaid

The charges on consignments forwarded as parcels must be prepaid.

#### 22.3 Separate rates for each package

Except where otherwise provided, each parcel shall be charged for separately.

#### 22.4 Parcels consigned inter-island

The zone rates for parcels traffic consigned inter-island include the sea or air charge, whichever may apply.

#### 22.5 Dangerous goods

Dangerous goods shall not be accepted as parcels traffic.

#### 24.6 Definition of parcels zones

Zone 1: All that area of the North Island bounded to the east, north, and west by sea coast and to the south by a straight line extending from Woody Head on the west coast to the south end of Bruntwood; thence in a straight line to Bowentown on the east coast.

Zone 4: All the area of the North Island bounded to the north and east by the sea coast and by a line following the eastern boundaries of Zones 2 and 3 from Matakaoa Point to the south end of Waiouru; thence in a straight line to Cape Turnagain on the east coast.

**Zone 5:** All that area of the North Island bounded to the north by the lines following the southern boundaries of Zones 3 and 4 from the western sea coast to the southern end of Waiouru and then to Cape Turnagain; and to the east, south and west by the sea coast.





- **31.1.3** Newspapers, periodicals and advertising circulars consigned under the provisions of this instruction will be depot to depot only. Depot to door consignment will be accepted at an additional charge of \$1.60 per package.
- 31.1.4 Single copies: Single newspapers shall be conveyed, up to 250 km distance, at a uniform charge of 10 cents per copy.
- 31.1.5 Declaration: A declaration that the packages do not contain other than the articles mentioned above must be printed or plainly written alongside the address on packages thus: "Newspapers only", "Advertising Circulars only", "Periodicals only" or "Stereotype casts only" (as the case may be).

#### 31.2 Books

Books shall not be accepted for conveyance as newspapers or periodicals.

#### 31.3 Liability

The provision above relates to packages being carried at "owner's risk" subject to and in accordance with the Carriage of Goods Act 1979 and the Corporation shall not be liable for damage, delay, detention, or loss. No receipts shall be given for the packages. Should it be desired that packages be conveyed at "limited carrier's risk" the appropriate parcels rate for that risk shall be charged.

#### Clause 32. COIN, BULLION, ETC.

#### 32. COIN, BULLION, ETC.

#### **32.1 Rates**

Packages containing bank notes, bullion, gold, silver, or bronze coin shall be accepted for carriage as follows:

- 32.1.1 Packages containing bank notes, bullion, gold, or silver shall be charged double the ordinary parcels rates.
- 32.1.2 Packages containing bronze coin shall be charged ordinary parcels rates.

#### 33.2 Power cycles

- 33.2.1 Bicycles with motor propelling attachments and with total weight not exceeding 35 kilograms:
- —as 20 kilograms at double parcels rates.

- 33.2.2 Power cycles exceeding 35 kilograms in weight will not be accepted as parcels traffic.
- **33.2.3** When charged with petrol or any flammable liquid, power cycles shall not be accepted for carriage. Battery leads must be disconnected from the battery and tied back in such a manner that they cannot touch the battery terminals while in transit.

#### 33.3 Assembled, unpacked bicycles and tricycles

33.3.1 Owners risk, unpacked bicycles and tricycles shall only be accepted at "owner's risk".

#### 33.4 Packed bicycles

Bicycles or tricycles, partially or completely unassembled and packed in cases, cartons, cardboard envelopes, canvas bags, or crates shall be charged for their actual weight at parcels rates.

#### 33.5 Tricycles

Children's tricycles shall be charged as 20 kilograms per tricycle at ordinary parcels rates. Other tricycles shall be charged as 20 kilograms at double parcels rates. Minimum charge \$13.80.
