Summary of Bills Introduced

National Provident Fund Restructuring Bill

This Bill provides for the restructuring of the National Provident Fund Board, the National Provident Fund, and the existing National Provident Fund superannuation schemes and investment arrangements. The principal features of the Bill are as follows

- (a) The National Provident Fund Board, a body corporate established under the National Provident Fund Act 1950, is authorised to register a public company under the Companies Act 1955:
- (b) On a date to be appointed by the Governor-General by Order in Council, the property, rights, and liabilities of the Nationa Provident Fund Board will vest in the company:
- (c) The existing National Provident Fund schemes will, as from 1 April 1991, be closed to new members:
- (d) The company is given power to restructure the National Provident Fund by, among other things, establishing trust funds in the nature of unit trusts:

- (e) The Bill provides for the continuation of the existing National Provident Fund schemes on largely the existing terms and conditions:
- (f) The benefits provided by the existing schemes, and the repayment of money deposited before the transfer day in accordance with the existing investment arrangements, will continue to be guaranteed by the Crown:
- (g) The Bill provides for the Minister and the company to enter into a contract relating to the management of the existing schemes:
- (h) The existing National Provident Fund schemes will, as from 1 April 1991, no longer be subsidised by the Crown, except in cases where the employer is a charity. Provision is made for an increase in employer contributions to those schemes to counter the removal of the subsidy:
- (i) The National Provident Fund's monopoly over local authority superannuation business, and its privileged deposit taking arrangements, will cease as at 1 April 1991:
- (j) The National Provident Fund Department will cease to be a department of the public service.

- 1. Title and commencement—(1) This order may be cited as the Christchurch City (Reserves) Empowering Act (Ministerial Responsibility) Order 1989.
- (2) This order shall come into force on the 28th day after the date of its notification in the *Gazette*.
- 2. Amending definition of "Minister" in section 2 of Act—Section 2 of the Christchurch City (Reserves) Empowering Act 1971 is hereby amended by omitting from the definition of the

term "Minister" the word "Lands", and substituting the word "Conservation".

Explanatory Note

This notice is not part of the order, but is intended to indicate its general effect.

This order, which is made under section 65 (2) (a) of the Conservation Act 1987 and comes into force 28 days after its notification in the *Gazette*, amends the definition of the term "Minister" in section 2 of the Christchurch City (Reserves) Empowering Act 1971 so that it now means the Minister of Conservation. Formerly it meant the Minister of Lands.

The following provisions in the Act affect the Minister:

- (a) No part of Hagley Part can be appropriated to provide car parking places without the Minister's consent (section 5 (2)):
- (b) The Minister can direct the Christchurch City Council to pay into its Reserves Account sums of money in respect of road reserves, and money in that Account can be applied only in the purchase, improvement, or development of public reserves (section 11).

The effect of the order is that the Wellington Show Association Incorporated will have to obtain the consent of the Minister of Conservation if it wishes to borrow money for purposes within the scope of the Act. Formerly, the consent of the Minister of Lands was required.
