Temporary Safeguard Authorities Act 1987

Request to a Temporary Safeguard Authority to Undertake an Inquiry into the Importation of Goods

Pursuant to section 5 (1) of the Temporary Safeguard Authorities Act 1987 ("the Act"), I, David John Butcher, the Minister of Commerce, request you to undertake an inquiry into the importation of the goods specified in the Schedule to this request ("the goods") and report on the following matters:

- a. Whether the industry in relation to the goods, has suffered or is likely to suffer material injury as a result of the importation of the goods having regard to the matters set out in section 6 of the Act; and
- b. If the Industry has suffered or is likely to suffer such injury,—
 - i. Whether urgent action is necessary to protect the industry in relation to the importation of the goods; and
 - If such action is considered necessary, the nature of the protection that you consider to be appropriate in all the

circumstances, and the extent and duration of such protection.

Statement of Government Policy in Relation to Footwear Industry

Pursuant to section 6 (1) (d) of the Temporary Safeguard Authorities Act 1987, I, David John Butcher, Minister of Commerce,—

Give you notice that it is part of the policy of the Government that:

Assistance to the footwear industry, by way of quantitative restrictions and tariffs applying to imported footwear, be lowered, in accordance with the Footwear Industry Development Plan, to levels which are ultimately comparable to tariffs and quantitative restrictions applying to industries generally.

The determination of any injury and any appropriate remedies should be compatible with New Zealand's international obligations under the ANZCERTA, SPARTECA and the GATT.
