Fisheries Act 1983

The Fisheries (Coromandel Scallop Area Closed Season) Notice 1989 (No. 4941)

Pursuant to sections 85 and 86 of the Fisheries Act 1983, the Deputy Group Director, acting under authority delegated by the Director-General of Agriculture and Fisheries, and after consultation with the Director-General of Conservation and the Fishing Industry Board, hereby gives the following notice:

Notice

1. Title and commencement—This notice may be cited as the Fisheries (Coromandel Scallop Area Closed Season) Notice 1989 and shall come into effect on the 3rd day of November 1989.

2. Interpretation—In this notice, the term:

“Scallop” means the shellfish *Pecten novaezelandiae*.

“Coromandel Scallop Closed Area” means:

Area K: Being the waters enclosed by a straight line from Devils Point (at 36° 44.60'S and 175° 49.60'E), north to the point 36° 35.00'S and 175° 50.60'E, thence due east to longitude 176° 28.10'E, thence due south to latitude 36° 44.60'S and then due west back to Devils Point.

Area L: Being the waters enclosed by a straight line from Devils Point (at 36° 44.60'S and 175° 49.60'E) north to the point 36° 35.00'S and 175° 50.60'E, thence due west to mean high water mark on the Coromandel Peninsula, thence by mean high water mark in a general southerly and then easterly direction back to Devils Point.

Area R: Being the waters enclosed by a straight line from Cape Rodney (at 36° 16.70'S and 174° 49.30'E) to Te Hue Point on Little Barrier Island (at 36° 11.20'S and 175° 03.00'E), thence by mean high water to the southernmost point of Little Barrier Island (at 36° 14.00'S and 175° 06.00'E), then due south to latitude 36° 28.40'S, thence due west to longitude 174° 53.00'E, thence north to the easternmost tip of Tawharanui Peninsula (at 36° 22.20'S and 174° 52.10'E) and thence by mean high water back to Cape Rodney.

Part of Area W: Being the waters enclosed by a straight line from Thumb Point on Waiheke Island (at 36° 44.45'S and 175° 10.40'E), to Cape Colville (at 36° 28.30'S and 175° 20.60'E), thence by mean high water to Turipeka Point on the Coromandel Peninsula (at 36° 36.50'S and 175° 25.65'E), thence to the northernmost point of Motukahaua Island (at 36° 39.30'S and 175° 22.55'E), thence by straight line to the south-westernmost point of Motuoruhi Island (at 36° 44.60'S and 175° 23.80'E) and thence by straight line back to Thumb Point.

Area X: Being the waters enclosed by a straight line between Thumb Point on Waiheke Island (at 36° 44.45'S and 175° 10.40'E) and the south-westernmost point of Motuoruhi Island (at 36° 44.60'S and 175° 23.80'E), thence south to Deadmans Point (at 36° 51.20'S and 175° 24.60'E), thence west to the northern end of Second Bay on Ponui Island (at 36° 53.90'S and 175° 12.00'E), thence by mean high water to the north-easternmost point of Ponui Island (at

36° 50.20'S and 175° 12.80'E), thence north by straight line to the southernmost point of Rotoroa Island (at 36° 49.60'S and 175° 11.90'E), thence by mean high water to the northernmost point of Rotoroa Island (at 36° 48.55'S and 175° 11.80'E), thence north by straight line to the southernmost point of Pakatoa Island (at 36° 48.20'S and 175° 11.70'E), thence by mean high water to the northernmost point of Pakatoa Island (at 36° 47.60'S and 175° 11.45'E), thence by straight line to Waiheke Island (at 36° 46.80'S and 175° 11.55'E), thence by mean high water back to Thumb Point.

3. Closed season for scallops determined—There is hereby determined to be a closed season for the taking of scallops by commercial fishers within the Coromandel Scallop Closed Area commencing on the 3rd day of November 1989 and expiring with the 19th day of December 1989.

New Zealand Grown Fruit and Vegetables Regulations 1975

Standard Grade for the Export of Buttercup Squash Notice (Ag. 12/2/14; No. 4940)

This notice revokes the Standard Grade for the Export of Buttercup Squash Notice (No. 4479; Ag. 12/2/14) published in the *New Zealand Gazette*, on 1 December 1988 at page 5156.

Pursuant to regulation 13 of the *New Zealand Grown Fruit and Vegetables Regulations 1975*, the Director-General of Agriculture and Fisheries hereby gives notice that the Standard Grade for the Export of Buttercup Squash shall be set out in this notice.

Notice

1. Title—(1) This notice may be cited as the Standard Grade for the Export of Buttercup Squash Notice 1989.

(2) This notice shall come into force on the day after the date of its notification in the *New Zealand Gazette*.

2. Interpretation—Unless the context otherwise requires, terms and expressions used in this notice shall have the same meaning as in the *New Zealand Grown Fruit and Vegetables Regulations 1975*. Certain of these terms and expressions are applicable to buttercup squash;

Definition of Terms:

“Colour” means typical of the variety.

“cured” means that at the time of loading into the export sea container the squash has been held for an adequate time period to allow:

The cut surface of the stalk to dry;

The remainder of the stalk to have commenced shrivelling to a firm texture with a brown withered surface.

(Note: Adequate time period is considered to be 48 hours from time to harvest).

“Mature” means that the squash has reached a minimum maturity at harvest as indicated by:

(a) the development of prominent brown flecks on the stalk; and

(b) the development of a dull dark green colour to the skin, with the loss of a glossy sheen on the skin, and;

(c) A full orange colour in the flesh.

“Sound” means free from any progressive decay, rots, (including small shallow rots even if dry and calloused), breakdown freezing or chilling injury, damage and similar defects which may cause rapid loss of condition or rapid decay.

“Storage Defects” means decay, fungal rots, wilt or other injury as a result of storage.

“Sunburn” means injury from exposure to the sun which results in sunken white areas of damaged flesh.

“Trimmed” means the stalk is cut cleanly and is less than 20 mm long or does not protrude more than 10 mm above the shoulders of the squash.

3. Application of notice—This notice determines the standard grade for the export of buttercup squash from New Zealand.

4. Title and grade—The grade mark assigned to this standard grade shall be Grade 1 (hereinafter referred to as ‘the grade’).

5. Definition of produce—This grade applies to buttercup squash grown from varieties of *cucurbita maxima* to be supplied fresh to the customer.

Note: Buttercup squash for industrial processing is excluded from this grade providing the packages are marked accordingly.

6. Provisions concerning quality—The purpose of this standard is to define the quality requirements for buttercup squash at the dispatching stage, after preparation and packaging.

The buttercup squash must be:

Free from pests and diseases and meet any quarantine and other legal requirements of the importing country;

intact, whole;

sound—free from storage defects or any other defects which may impair their general appearance or keeping quality;

clean—free from soil, practically free of any other visible foreign matter;

free from abnormal external moisture;

free from foreign smell or taste;

mature;

trimmed;

cured;

of good quality, with similar varietal characteristics including shape and colour and without distortion due to abnormal development;

capable of withstanding handling, storage and transport, and arriving at the destination in a sound condition;

free from sunburn and scald;

buttercup squash should be shipped within 14 days of harvesting.

Skin defects which are not liable to impair the keeping qualities are permitted within the limits specified in the First Schedule to this notice.

7. Provisions concerning sizing—Sizing is determined by weight at the time of packing. The minimum size for export in bulk packs is 1.2 kg and above which should be marked Grade 1.

Note: Squash in the size range up to 1.2 kg only is permitted as a separate pack which must be marked accordingly and checked for maturity prior to export.

8. Provisions concerning tolerance—Any one package shall not contain more than 5 percent of buttercup squash by weight outside the branded size range.

9. Provisions concerning presentation—

(a) *Uniformity*—The contents of each package must be

uniform; each package must contain only buttercup squash of the same origin, variety, quality, degree of ripeness and size. The visible part of each package must be representative of the entire contents.

(b) *Packaging*—The buttercup squash must be packed in clean new packages and in such a way as to ensure that they are suitably protected.

Packages must be free of all foreign matter.

(c) *Export Bin Specifications*—All export squash are to be exported in wooden bins that meet the specifications and dimensions, as set out in the Second Schedule to this notice.

First Schedule

Allowances for Defects:

(a) *Soil bleaching (groundspot)*—No more than 15 percent of the surface area on individual squash.

(b) *Discolouration (bronzing)*—The result of exposure to the sun, where the colour of the affected area is still dominantly green the squash is acceptable. Where a brown or bronzed colour is dominant in the affected area the squash is unacceptable.

(c) *Vine marks*—The vine must not have substantially distorted the outline or shape of the squash. A vine mark must be:

(i) No deeper than 20 mm from the normal surface of the squash at the deepest point.

(ii) No wider than 20 mm at the widest point.

(iii) No longer than 100 mm.

(d) *Callousing*—Surface callousing (i.e., non-raised areas) are not to exceed 4 square cm in aggregate area. Callousing with raised areas such as “pimples” or oedema (“warts”) is not to exceed 2 square centimetres in aggregate area and 5 mm in height at any point.

(e) *Bruising-marks resulting from pressure must not:*

(i) Have broken the skin.

(ii) Exceed 2 square centimetres in aggregate area.

(f) *Cuts are not acceptable on squash.* Cuts are broken skin which may be caused by cutting (knives, secateurs) or impact on a sharp edge (stalks, timber, metal).

(g) *Dirty fruit-soil, grease, bird droppings or other foreign matter on the fruit is not acceptable.*

(h) *Shape*—The squash must be wider than it is high, and typical of the variety.

(i) *Shrinkage (weight loss)*—Shrinkage allowance of 7 percent of nett weight at the time of despatch is to be provided for.

(j) *External moisture*—All fruit are to be free of external moisture (water from washing procedures) prior to stowage for export shipment.

Second Schedule

(i) *Reefer Vessel Bins*

Fastenings

Nails or staples to be used as follows:

Nails—Ring shank, angular groove or equivalent.

Length 55 mm for all 18 mm bins

51 mm for all 15 mm bins

Number of nails Two nails per join and four where bottom side boards join base. (Total of Nails: for 18 mm bins = 182, 15 mm bins = 230)

Staples

Length Q 23—55 mm for 18 mm bins

Q 21—50 mm for 15 mm bins

Number of staples Three staples per join and six where bottom sides boards join base. Total of staples: for 18 mm bins = 273, 15 mm bins = 345

Construction—All bins must be constructed in accordance with these specifications using sound building practices, in a tight square and uniform way.

10. Provisions marking—Each package must bear the following particulars in letter grouped on the same side, legibly and indelibly marked and visible from the outside:

Identification—registered marker of grower and packing establishment and exporters' identification.

Nature of produce—kind and variety.

Country of origin—New Zealand.

Commercial specification—grade of contents.

Official control mark—inspection stamp or similar identification if applicable.

Note: Size ranges may also be included on bin labels.

Third Schedule*General Information*

The following explanatory notes do not form part of this standard grade, but are presented for the information of growers, packers and exporters.

1. It is the responsibility of the exporter to ensure the produce exported meets the legal requirements of the importing country and the specification of the importer.

2. Handling and Packing:

(a) Packing of shipping containers in the field is not acceptable.

(b) Buttercup squash should not be cut or harvested in rain or damp conditions. Full crates should be protected from inclement weather.

(c) Avoid the possibility of sunburn following cutting and during harvest. Packed crates should be protected from the sun at all times.

(d) After harvesting it is desirable to hold squash in a shaded airy place for a minimum of 48 hours prior to export packing.

(e) Squash should be harvested at optimum maturity. Over mature squash has a greater loss of colour and higher levels of post-harvest decay during and after shipping.

(f) The curing process is to be completed prior to exporting.

3. Exemptions

Exemptions to the packaging specifications or the 14 days harvesting to shipment period may be considered on receipt of a submission in writing to the New Zealand Buttercup Squash Council Incorporated.

Wool Test Certification

This "Direction on Wool Test Certification" is made by the New Zealand Wool Board (the "Board") pursuant to its authority contained in section 21 (1) of the Wool Industry Act 1977. Notice of this direction is being given as required by section 21 (5) of that Act. The direction may be amended from time to time. Any such amendments will be published in this *Gazette* or as otherwise provided by section 21.

The Board has considered various requests from the National Council of New Zealand Wool Interests Incorporated and the New Zealand Council of Wool Exporters Incorporated to have put in place a system of compulsory registration of New Zealand Wool Testing Laboratories which provide certified results/test certificates used in the sale transactions of parcels of raw wool.

For the purposes of this direction raw wool is defined as: greasy wool; wool which has been scoured, carbonised, washed or solvent degreased; scoured skin wools; washed skin wools; and slip wools. It consists of wool fibre together with

variable amounts of vegetable matter and extraneous alkali insoluble impurities, mineral matter, wool waxes, suint and moisture.

Accordingly the Board hereby directs that from 1 April 1990 no certified results/test certificates shall be supplied or displayed in connection with the offering of raw wool for sale in New Zealand or for export overseas unless both the following criteria are met:

(a) That the certified results/test certificates be issued on the basis of a test authorised by the Board and carried out according to a standard test method published by the International Wool Textile Organisation, the Standards Association of New Zealand, the American Society of Testing and Materials, or any other nationally or internationally recognised body that may be designated by the Board.

(b) That any such certified results/test certificates be issued by an authorised wool testing laboratory that is registered with the Testing Laboratory Registration Council of New Zealand (TELARC) under their registered laboratory programme. (Notification by the New Zealand Wool Board that a laboratory is authorised can only be given once TELARC registration is granted.)

Where certified results/test certificates are supplied or displayed in connection with the offering of wool for sale in New Zealand or for export overseas the Board authorises the following Sampling Procedures, Tests, Test Methods, Matching/Interlotting Standards and Certificate Format Regulations.

Notes to the Financial Statements for the Period Ended 31 March 1989

1. Statement of Accounting Policies

The Westland Bank Community Trust ("the trust") was formed on 30 May 1988 through the creation of a trust deed in compliance with the Trustee Banks Restructuring Act 1988. Under the terms of the trust deed the trust was settled with 2 000 000 \$1 fully paid shares in Westland Bank Limited representing 100 percent of the issued capital of the bank.

General Accounting Policies
