## Internal Affairs

### Flags, Emblems and Names Protection Act 1981

#### New Zealand Coat of Arms—1990 Souvenirs

1. It is announced that in connection with the 1990 Commemorations, the restrictions contained in section 13 of the Flags, Emblems and Names Protection Act 1981, governing and protecting the use of the New Zealand Coat of Arms, which normally are not permitted to be reproduced without the written authority of the Minister of Internal Affairs, will be temporarily relaxed to allow them, in accordance with the conditions set out hereunder, to be reproduced on Souvenirs and Displays especially produced or designed to commemorate 1990.

2. (a) Souvenirs are defined as articles of a permanent kind specifically designed to commemorate 1990 and identified with it by appropriate wording.

(b) Such souvenirs must:

- (i) be in good taste
- (ii) be free from advertisement
- (iii) carry no implication of Government approval
- (iv) not be used as a premium or selling aid

(c) Textiles, with the exception of wall hangings, are not regarded as souvenirs within the meaning of these rules.

(d) Containers or receptacles of merchandise may qualify as souvenirs within the meaning of these rules, provided that:

(i) they are permanent in nature, i.e. of metalware, ceramic or other semi-indestructible material and specially made for the occasion

(ii) they comply with the requirement of paragraph (a). The name of the manufacturer and content details should appear *only on the underside or interior of the container or on the stopper.*

(e) Souvenirs may be sold at any time before 1990, and until 31 December 1990.

(f) Reproductions of the New Zealand Coat of Arms may be used in schemes of decoration for 1990 commemorations, but not in any way which might imply Government approval or patronage of any firm or its products.
