# Fisheries (Species and Area Prohibition) Notice 1990, No. 4956

Pursuant to section 65 (1) of the Fisheries Act 1983, and delegations made pursuant to sections 28 and 41 of the State Sector Act 1988, the Director (Operations), MAFFish, hereby gives the following notice:

#### Notice

- 1. Title and commencement—(1) This notice may be cited as the Fisheries (Species and Area Prohibition) Notice 1990.
- (2) This notice shall come into effect on the 1st day of February 1990.
- 2. Interpretation—In this notice:
- (a) Any reference to a Quota Management Area means the appropriate Quota Management Area as defined in the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986;
- (b) The words "New Zealand fisheries waters" have the meaning ascribed thereto in the Fisheries Act 1983.
- 3. Restrictions on fishing—As from the date this notice comes into effect until the 30th day of September 1990 (hereinafter called "the period"), it shall be a condition of all

fishing permits issued or renewed during the period that the holder of the permit is prohibited from fishing in the following fisheries:

# **Education Act 1964**

# The Tertiary Education Fees (Exemptions) Notice 1990

Pursuant to section 67SA and section 94 of the Education Act 1964, section 47A of the University of Auckland Act 1961, section 47A of the University of Waikato Act 1963, section 47A of the Massey University Act 1963, section 48A of the Victoria University of Wellington Act 1961, section 48A of the University of Canterbury Act 1961, section 34A of the University of Otago Amendment Act 1961 and section 46A of the Lincoln University Act 1961, the Minister of Education hereby gives the following notice:

#### Notice

- **1. Title and commencement**—(1) This notice may be cited as the Tertiary Education Fees (Exemptions) Notice 1990.
- (2) This notice shall come into force on the date of its publication in the *Gazette*.
- **2. Interpretation**—In this notice, unless the context otherwise requires—
  - "Course commencement date" means the date determined by the council to be the commencement date of any course.
  - "Council" means the governing body of a tertiary institution and in relation to a tertiary institution means its governing body.
  - "Dependent child", in relation to any person, means a child or step-child of that person—
  - (a) who is aged under 20 years on the commencement date of that person's course; and
  - (b) to whose care and support that person is contributing.
  - "Domestic student" means a person enrolled at a tertiary institution who is a domestic student within the meaning of section 2 (1) of the Education Act 1989.
  - "Full-time, full-year course" means any course at a tertiary institution that the council for the time being determines to be a full-time, full-year course.
  - "ISCED level 3 course" means any course that the Secretary of Education for the time being determines to be an International Standard Classification of Education (ISCED) level 3 course.
  - "Parent" includes guardian and step-parent and any person acting in place of a parent.
  - "Spouse", in relation to a student, includes any person who is not legally married to that student but is living as that student's husband or wife, where—
  - (a) That student is aged at least 20 years; or
  - (b) That student is aged under 20 years and there is a dependent child of one or both of them.
  - "Tertiary institution" means an institution that is a technical institute, community college or teachers college within the meaning of the Education Act 1964, or a University within the meaning of the Universities Act 1961.
- **3. Notice not to apply to fees fixed by council**—Nothing in this notice shall apply to any person who is enrolled in a course to which clause 5 or clause 6 of the Tertiary Education Fees Notice 1990 applies.
- 4. Certain students exempted from part of fee-

- (1) Subject to clause 5 and clause 6 of this notice, the tuition fee payable by any domestic student who—
  - (a) is enrolled in any ISCED level 3 course; or
  - (b) is receiving payments under an independent circumstances grant under the Student Allowances Regulations 1988; or
  - (c) is a Ward of Court; or
  - (d) is a child under the control and custody of the Director-General of Social Welfare or any other State department or agency; or
  - (e) satisfies the council of the tertiary institution at which the student is enrolled that he or she will be aged less than 18 years during his or her course of study; or
  - (f) has any dependent children and satisfies the council that the combined taxable income in the previous financial year ending 31 March of the student and his or her spouse (if any) did not exceed \$26,832; or
  - (g) satisfies the council that-
    - (i) he or she will be aged 18 or 19 years during his or her course of study; and
    - (ii) the combined taxable income in the previous financial year ending 31 March of the student's parents did not exceed \$26,832; or
  - (h) satisfies the council that he or she, or his or her spouse,—
    - (i) has been receiving, for the 26 weeks immediately prior to the commencement of the student's course, any payment of a benefit under Part 1 of the Social Security Act 1964 (except family benefit or national superannuation) or any financial assistance under the Access Training Scheme; and
    - (ii) is not, and will not be, receiving a Training Incentive Allowance from the Department of Social Welfare during the calendar year of the student's course of study.
  - —shall be 10 percent of the tuition fee otherwise payable for that course or \$125, whichever is the greater.
- (2) Subject to clause 5 and clause 6 of this notice, the tuition fee payable by any domestic student who—
  - (a) satisfies the council of the tertiary institution at which the student is enrolled that—
    - (i) he or she will be aged 18 or 19 years during his or her course of study; and
    - (ii) the combined taxable income of the student's parents in the previous financial year ending 31 March was between \$26,832 and \$31,199; or
  - (b) has any dependent children and satisfies the council of the tertiary institution at which he or she is enrolled that the combined taxable income in the previous financial year ending 31 March of the student and his or her spouse (if any) was between \$26,832 and \$31,199—

shall be 40 percent of the tuition fee otherwise payable for that course or \$125, whichever is the greater.

- (3) Subject to clauses 5 to 7 of this notice, the tuition fee payable by any post-graduate research student who is a domestic student and who is enrolled in a masters or doctorate programme which includes a thesis or major dissertation—
  - (a) for which at least 50 percent of the overall assessment is research-based; or
- (b) for which at least 50 percent of the assessment in the year in which the student is enrolling, is research-based—shall be 40 percent of the tuition fee otherwise payable for that course or \$125, whichever is the greater.
- (4) Subject to clause 5 and clause 6 of this notice, the tuition fee payable by any domestic student who—

- (a) Satisfies the council of the tertiary institution at which the student is enrolled that—
  - (i) he or she shall be aged 18 or 19 years during his or her course of study; and
  - (ii) the combined taxable income of the student's parents in the previous financial year ending 31 March was between \$31,200 and \$35,567; or
- (b) has any dependent children and satisfies the council of the tertiary institution at which he or she is enrolled that the combined taxable income in the previous financial year ending 31 March of the student and his or her spouse (if any) was between \$31,200 and \$35,567—

shall be 70 percent of the tuition fee otherwise payable for that course or \$125, whichever is the greater.

#### 5. Calculation of student's age-

- (1) Where any domestic student will, during the student's course of study in any year, attain the age of 18 years or 20 years, the total tuition fee payable by that student shall be calculated according to the student's age—
  - (a) in the case of a domestic student enrolled in a full-year course, on the commencement date of that course and at least two other dates during that course; and
  - (b) in the case of a domestic student enrolled in a course that is less than a full year in length but which is equivalent to or more than a half-year course, on the commencement date of that course and at least one other date during that course; and
  - (c) in the case of a domestic student enrolled in less than a half-year course, on the commencement date of that course.
- (2) The dates on which a student's age is to be assessed under paragraph (a) or (b) of subclause (1) of this clause shall be determined by the council of the tertiary institution at which the student is enrolled before the course commencement date.
- 6. Parental income—For the purposes of paragraph (g) of clause 4 (1) and paragraph (a) of clause 4 (2) and clause 4 (4) of this notice—
  - (a) if a student has more than two parents, the student shall nominate the two parents who are the major contributors to the student's support, and the combined incomes of those two contributors shall be deemed to be the income of the parents of that student;
  - (b) where one or both of the parents of any student has or have more than one child who
    - (i) is enrolled in a full-time, full-year course at a tertiary institution or enrolled full-time at a secondary school; and
    - (ii) was aged at least 16 years but not more than 19 years on the commencement date of the student's course—

the combined taxable annual income of the parents of that student in the previous financial year ending 31 March shall be reduced by \$2,200 for each such additional child;

- (c) where the Council is satisfied that the estimated combined taxable income of the parents of any domestic student will be lower in the current financial year ending 31 March next, than in the previous financial year ended 31 March, the Council may in its absolute discretion treat that estimated annual income as if it were the income of the student's parents in the previous financial year.
- 7. Failure to complete post-graduate course in minimum time—The provisions of clause 4 (3) of this notice shall not apply to any post-graduate research student who fails to complete his or her course or programme in the time determined by the council concerned to be the minimum time (with allowance for part-time study) for that student to complete that course or programme.
- 8. Conjoint programmes—

- (1) For the purposes of this clause, a "conjoint course" or "conjoint programme" means a course or programme offered jointly by two tertiary institutions which requires a student who is undertaking that course or programme to be enrolled at both institutions.
- (2) No student shall be required to pay a tuition fee of more than \$1,250 in any year for any conjoint course or programme.
- **9. Fees paid before 1990**—Notwithstanding any other provision of this notice, every domestic student enrolled in a course that—
- (a) the council of the tertiary institution concerned determines to be equivalent to or less than a full-time, full-year course; and
  - (b) commenced before 1 January 1990
  - —shall, if that student has, before 1 January 1990, paid the full tuition fee fixed before that date for that course, be exempted from the payment of any further tuition fee in respect of that course.
- **10. Fees include GST**—All fees and amounts specified in this notice are inclusive of goods and services tax.

# Notice

- 1. Title and Commencement—(1) This notice may be cited as the Tertiary Education Fees Notice 1990.
- (2) This notice shall come into force on the date of its publication in the Gazette.
- $\begin{tabular}{ll} \textbf{2. Interpretation} & \textbf{--} In this notice, unless the context otherwise requires} & \textbf{--} \\ \end{tabular}$ 
  - "Council" means the governing body of a tertiary institution and in relation to a tertiary institution means its governing body.
  - "Domestic student" means a person enrolled at a tertiary institution who is a domestic student within the meaning of section 2 (1) of the Education Act 1989.
  - "Full-time, full-year course" means any course at a tertiary institution that the council for the time being determines to be a full-time, full-year course.
  - "ISCED level 9 course" means any course at a tertiary institution that the Secretary of Education for the time being determines to be an international Standard Classification of Education (ISCED) level 9 course.
  - "Tertiary institution" means an institution that is a technical institute, community college or teachers college within the meaning of the Education Act 1964, or a university within the meaning of the Universities Act 1961.
- **3. Fees include GST**—All fees and amounts specified in this notice are inclusive of goods and services tax.
- **4. Tuition Fees**—Subject to clause 5 of this notice and the Tertiary Education Fees (Exemptions) Notice 1990—
  - (a) the tuition fee for every full-time, full-year course at a tertiary institution shall be \$1,250;
  - (b) the tuition fee for every course at a tertiary institution

that the council determines to be equivalent to more than one-tenth of, but less than, a full-time, full-year course, shall be a sum that bears the same relation to \$1,250 as the council considers that course bears to a full-time, full-year course;

(c) the tuition fee for every course at a tertiary institution that the council determines to be equivalent to one-tenth of a full-time, full-year course shall be \$125.

#### 5. Certain courses exempt—

Nothing in clauses, 4, 7, 8, 9, 10 or 11 of this notice applies to any—

- (a) ISCED level 9 course;
- (b) LINK programme;
- (c) Course provided pursuant to the Access Training Scheme;
- (d) Master of Business Administration degree course at the University of Canterbury or Victoria University of Wellington;
- (e) Professional Legal Studies course administered by the Council of Legal Education.
- 6. Council may fix certain fees—The tuition fee for any
  - (a) Specified in paragraph (a), (b) or (c) of clause 5 of this Notice: or
  - (b) that the council of the tertiary institution concerned determines to be equivalent to less than one-tenth of a full-time, full-year course—

may be fixed independently.

# 7. Certain students may pay in three instalments-

- (1) The Council of a tertiary institution shall accept from any domestic student enrolled in a full-time, full-year course—
  - (a) whose tuition fee is or exceeds \$625; and
  - (b) who wishes to pay that fee by instalment-

payment of that fee in not less than three equal instalments on such dates as may be specified by the council.

- (2) The dates specified by the Council under subclause (1) of this clause shall divide the course into parts of an equal length.
- 8. Certain students may pay in two instalments—(1) The council of a tertiary institution shall accept from any domestic student—
  - (a) who is enrolled in a course or programme that the council of the tertiary institution concerned determines to be equivalent to one half or more of, but less than, a fulltime, full-year course; and
  - (b) whose tuition fee is or exceeds \$625; and
  - (c) who wishes to pay that fee by instalment
- —payment of that fee in not less than two equal instalments on such dates as may be specified by the council.
- (2) The dates specified by the council under subclause (1) of this clause shall divide the course into parts of an equal length.
- 9. Refunds—Subject to clause 10 and clause 11 of this notice, where any domestic student who has paid a tuition fee of or exceeding \$208 withdraws from all or part of the student's course on or before the 28th day after the commencement of that course, or within such other period as may be prescribed by the council before the commencement of that course, the council shall refund to the student—
  - (a) in the case of a domestic student who withdraws from all of his or her course, the tuition fee the student has paid in respect of that course; and
  - (b) in the case of a domestic student who withdraws from part of his or her course, the amount (if any) by which the tuition fee paid by that student exceeds the tuition fee payable in respect of the student's reduced course.

dialogue.

- 10. Partial refunds—Subject to clause 11 of this notice, where any domestic student who—
  - (a) is enrolled in a full-time, full-year course; and
  - (b) has paid a tuition fee of \$1,250
- —withdraws from that course before the end of the 10th week after the commencement of that course, the council shall refund to the student not less than \$834.
- 1:. Administration Expenses—The council may deduct not more than \$45 for administration expenses from any refund given under clause 9 or clause 10 of this notice.

# **Explanatory Note:**

This notice is not part of this notice but is intended to indicate its general effect.

This notice fixes standard tuition fees for courses at tertiary institutions and provides for the payment by instalment and refund of fees in certain cases. The notice also specifies certain courses where fees may be fixed independently. Where the notice neither specifies a fee nor provides that a fee may be fixed independently the fee shall be fixed by agreement between the council of the tertiary institution concerned and the Minister.
