Forest Disease Control Regulations 1967

Declaration of Infected Area

Pursuant to regulation 4 (1) of the Forest Disease Control Regulations 1967, and to a delegation from the Secretary of Forestry, I, John Tilby Lewis, an authorised forestry officer, acting with the approval of the Minister of Forestry, hereby declare the area described in the Schedule hereto, to be an infected area in respect of the disease *Scolytus multistriatus* in association with *Ceratocystis ulmi* (commonly known as Dutch Elm Disease), which attacks the *Ulmus* and *Zelkova* species (Elm family).

Any forest produce of the above species treated in accordance with written specifications of an authorised forestry officer is not affected by the above declaration. Any person wishing to make an inquiry about moving material from an Elm tree into, out of, or within the greater Auckland area, should contact the Regional Manager, Ministry of Forestry, Auckland.
