(j) satisfies the Council that—

(i) the student does not have a spouse; and

(ii) the student has one or more dependent children; and

(iii) the gross income in 1990 of the student, excluding any income earned by the student from employment and any amount received by way of any benefit under the Social Security Act 1964 during vacations or outside the period of the student's course of study, is not expected to exceed the sum of \$129.16 multiplied by the number of weeks of that student's course.”

## **Water Recreation Regulations 1979 Ministry of Transport Act 1968**

### **The Water Recreation (Kawerau River) Notice 1990**

1. Notwithstanding any other provision of this notice, no person who is permitted by any such provision to propel or navigate a small craft at a speed through the water exceeding 5 knots shall do so in any manner that is likely to endanger or unduly annoy any person who is, in, on, or using the waters or fishing, or undertaking any recreational activity in the vicinity of the small craft.

2. All persons in charge of a vessel shall adhere to and keep the provisions of all Acts and regulations not specifically exempted by this notice.

3. A suitable notice as may be approved by the Section Officer (Harbours Management), Christchurch, shall be erected at the sites deemed necessary by the Section Officer (Harbours Management).

## Broadcasting Standards Authority

### Broadcasting Act 1989

#### Decisions No. 1/90 and No. 2/90

Pursuant to section 15 (1) of the Broadcasting Act 1989, notice is hereby given that the Broadcasting Standards Authority, at its meeting in Wellington on 18/19 January, made decisions on two complaints concerning programmes broadcast on television.

In Decision No. 1/90, the Authority declined to uphold a complaint by C. R. Turner that a rugby league advertisement by Lion Red Limited breached rules on "liquor advertising". The Authority held that the advertisement was "sponsorship advertising" and, as such, not in breach of the "liquor advertising" rules.

In Decision No. 2/90, the Authority declined to uphold a complaint by Patricia Bartlett, for the Society for Promotion of Community Standards, that in broadcasting *The Nightworkers* documentary on TV1 in August 1989, Television New Zealand Limited had failed in its obligation under section 4 (1) (a) of the Act to maintain standards consistent with the observance of good taste and decency. After finding that the programme was a balanced and informative documentary, screened at an appropriate time and with appropriate censorship classification, the Authority agreed with TVNZ Limited that, within its context, the documentary was not inconsistent with the broadcaster's responsibility under section 4 (1) (a) to maintain, in its programmes and their presentation, standards consistent with the observance of good taste and decency.
