Summary of Bills Introduced

Finance Bill

This Bill affects Telecom Corporation of New Zealand Limited and the New Zealand Railways Corporation. It also amends the Telecommunications Act 1987, the Radiocommunications Act 1989, and the State-Owned Enterprises Act 1986.

Part I of the Bill relates to the application of the State-Owned Enterprises Act 1986 and other Acts to Telecom Corporation of New Zealand Limited. Part II provides for a Government guarantee of all loan and swap obligations and certain other financial obligations of the New Zealand Railways Corporation.

Part III amends: the Telecommunications Act 1987 by inserting new sections dealing with the availability of certain information by the Telecom Corporation; the Radiocommunications Act 1989 by substituting the Minister of Communications for the Minister of Commerce in respect of directions given to the Secretary of Commerce in relation to the licensing of radio apparatus; the State-Owned Enterprises Act 1986 by authorising a shareholding Minister to request the board of a State enterprise to supply information to a specified person or persons, and by providing that a state enterprise shall indemnify the Crown against any liability of the Crown to third parties in the case of a transfer of liabilities to a State enterprise.

Taxation Reform Bill

This Bill amends the Income Tax Act 1976 and the Estate and Gift Duties Act 1968.

Part I amends the Income Tax Act 1976: by adding the Cyclone Ofa Relief Trust to the list of organisations to which gifts of money qualify for a rebate of income tax; excluding from the tax exemption for local authorities the income derived by local authority trading enterprises and by port companies; amending the provisions in relation to the payment to the Commissioner of PAYE deductions and specified superannuation contribution withholding tax by employers who make PAYE deductions of less than \$50,000 per annum; amending the application of the trust taxation proposals; confirming the rates of income tax and excess retention tax for the 1989–90 year.

Part II amends the Estate and Gift Duties Act by increasing the maximum amount of the charitable succession from \$25,000 to \$100,000, and provides for an exemption from gift duty for transfers of property from the Central Waikato Power Board and Hamilton City Council to the Waikato Electricity Authority.

New Zealand Railways Corporation Restructuring Bill

This Bill provides for the restructuring of the New Zealand Railways Corporation. The Bill empowers the Minister of Finance and the Minister for State Owned Enterprises to form and register one or more companies under the Companies Act 1955. The shares in these companies are, on their incorporation, to be subscribed for by those Ministers or their nominees. A company in which all the shares are held by or on behalf of the Crown is referred to in the Bill as "a Crown transferee company". The Bill makes provision for the vesting by Order in Council in a Crown transferee company or in the Crown of railways assets and railways liabilities. The Bill applies provisions of the New Zealand Railways Corporation Act 1981 to the railways operations carried on by railway operators (as that term is defined) in the same way as those provisions apply to the existing Corporation.

1. Title and commencement—(1) This notice may be cited as the Fisheries (Cancellation of Crown Quota for Orange Roughy) Notice 1990.

(2) This notice shall come into effect on the day after the date of its notification in the *Gazette*.

2. Interpretation—In this notice any reference to a quota management area means the appropriate quota management area as defined in the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986.

3. Cancellation of Crown Holdings of Orange Roughy Quota—(1) Pursuant to section 28U (4) of the Fisheries Act 1983, the Crown holdings of 5513 tonnes of individual transferrable quota in the combined quota management area consisting of the following quota management areas is hereby cancelled:

South-east (Otago/Southland) and Sub-Antarctic combined	

(2) The total allowable catch for orange roughy in that area is accordingly reduced in the manner specified in clause 2 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 6.

3. Preparation and provision of statistics as required by the Director-General of Health, including information for the purposes of developing or monitoring programmes for the Department of Health or for the purposes of international co-operation in the field of health.

4. Promoting, undertaking and reviewing research for health planning, policy-making and service development.

5. The evaluation of the structure, process, outcome and impact of health programmes including participation in quality assurance activity.

Community Health Development

6. Facilitating community development and self-help, including the administration of the Community Health Initiatives Funding Scheme, so as to encourage health and minimise health risks.

7. The promotion and protection of healthy lifestyles through a healthy environment, healthy families and whānau, and healthy communities.

8. Developing and supporting networks of health-related agencies, groups and workers.

9. Maintaining an awareness of the activities, plans and policies of health agencies, industry and other sectors, and collaborating with them to maximise health outcomes.

10. Providing advice and assistance on environmental aspects of health, including participation in regional and district planning processes and civil defence activities, to local authorities and other organisations.

11. Assisting with planning and support of health education programmes and support for health education in schools.

12. The promotion of a high level of oral health for the whole community.

Health Standards

13. The promotion of a high standard of environmental health by the surveillance and evaluation of:

(a) Public water supplies and community water supplies, and the methods of treatment of such water supplies:

(b) All methods of the collection, conveyance, disposal and treatment of sewage and other human waste:

(c) Solid waste collection and disposal systems, and the management of such systems:

(d) Hazardous waste disposal systems and the management of such systems:

(e) The effectiveness of pest control:

(f) The noise climate:

(g) Odour emission, and other undesirable emissions, to the atmosphere:

(h) The use of chemicals in agriculture, the community and industry:

(i) Environmental working conditions, and the control of hazards at work:

(j) Occupational hearing loss:

(k) Standards of care in old peoples' homes and private hospitals:

(l) The sanitary conditions of dwellings, boarding houses, hostels, motels, camping grounds, coastal shipping vessels, and commercial vessels:

(m) The public health standards at chartered clubs and other licensed premises, childcare centres, hairdressers' premises, old peoples' homes, schools and swimming pools:

The promotion and conservation of health in relation to food by the supervision of compliance with the Food Act 1981, the Food Hygiene Regulations 1974, the Food Regulations 1984 and the Dietary Supplements Regulations 1985, insofar as it is carried out by employees of an area health board, by ensuring that all persons on whom obligations are imposed by the said Act and regulations meet those obligations, and otherwise comply with the said Act and regulations.

Medicines Act 1981

Functions:

The promotion and conservation of health in relation to medical devices, medicines and related products by the supervision of compliance with the Medicines Act 1981 and the Medicines Regulations 1984, insofar as it is carried out by employees of an area health board, by ensuring that all persons on whom obligations are imposed by the said Act and regulations meet those obligations, and otherwise comply with the said Act and regulations.

Toxic Substances Act 1979

Functions:

The promotion and conservation of health in relation to toxic substances by the supervision of compliance with the Toxic Substances Act 1979 and the Toxic Substances Regulations 1983, insofar as it is carried out by employees of an area health board, by ensuring that all persons on whom obligations are imposed by the said Act and regulations meet those obligations and otherwise comply with the said Act and regulations.

Social Security Act 1964, Part II

Functions:

The promotion and conservation of health, in the following respects:

1. Routine management of the dental benefits programme in accordance with the Social Security Act 1964, Part II, and the Social Security (Dental Benefits) Regulations 1983;

Where an area health board requires the services of counsel with respect to any proceedings so instituted it shall instruct the Crown Solicitor in the area health district to represent the board in the proceedings.

4. Where, in the view of an area health board, offences against any of the Acts or regulations referred to in Part A of the Schedule to this delegation (other than the Food Act 1981, the Food Hygiene Regulations 1974, the Food Regulations 1984, and the Dietary Supplements Regulations 1985) have occurred, the Board shall inform the Department of Health, to enable prosecution of the alleged offender at the instance of an officer of the department to be considered.
