#### Video Recordings Act 1987

#### Video Recordings Board of Review Decisions

#### Colour Climax Programme 331

1. The video recording Colour Climax Programme 331 was submitted to the Video Recordings Board of Review (the Board) by the Secretary for Internal Affairs pursuant to section 36 of the Video Recordings Act 1987 (the Act).

2. The Board has re-examined the video in accordance with section 38 of the Act. In reaching its decision it did not find it necessary to consult with any further persons.

3. The video comprises 3 scenes each of approximately 10 minutes duration. As there is no story-line and each scene depicted similar repetitious acts there appeared to be no reason for the division into separate scenes.

This is the first video which the Board has examined which has concentrated mainly on repetitious acts of urination in association with sexual activity.

The first scene "Liquid Lunch" showed five heterosexual couples enjoying lunch. Within a minute or two they were seen urinating into wine glasses, into each others mouths and over each others bodies. Interspersed with these acts a range of explicit sexual activities were shown with the sexual activity resulting, in the majority of scenes, in urination rather than ejaculation. The following two scenes "Piss Service" and "Piss Addicts" were in a similar format with the latter scene involving three couples.

4. The Board considered those matters which it is required to address under section 21 of the Act and reached the following conclusions:

- a. The dominant effect of the video is the depiction of urination within a sexual context.
- b. The video had no artistic, social or cultural merit, value or importance. Some members of the Board stressed that the association or urination with sexual acts was repugnant, insensitive and alien to their culture. The filming was of adequate quality with most of the shots filmed in close up.
- c. The video is aimed at an adult audience but given the urination theme, which is readily apparent from the outside cover, it may have more limited appeal than other sexually explicit videos.
- d. Notwithstanding the fact that the acts depicted take place between consenting adults, and in some of the scenes with great hilarity, the extensive presentation of urination out of its usual context, as a normal physiological act, and associated with pleasurable sexual activity constitutes, the Board considers, anti-social and offensive behaviour. The behaviour comprises almost the entire video.
- e. As already noted both males and females were shown urinating into each others mouths and over one anothers bodies. Even though these activities took place in a noncoercive and "fun" environment the depiction of men and

women voluntarily urinating over one another is demeaning and degrading to men and women. While this may not constitute "denigration" in the literal interpretation of the word, the Board considers it to be denigration in common parlance.

- f. The video would be used for entertainment.
- g. Even had the intermittent German spoken in the video been translated into English it would have added nothing to the video. It was easy to translate the short sentences which consisted largely of "Oo's, Oh's and Ah's".

5. In addition to the statutory requirements which the Board considered it also noted the false impressions that can be created by videos of this type to persons inexperienced in sexual activity. The fact that the scenes were portrayed in a light-hearted manner as though urination was a normal and enjoyable part of sexual activity was disquieting.

6. The Board continues to be most concerned that no safe sex instructions are included with the video particularly as multiple sex activity took place in some of the sequences. It regrets that is has no power under the Act to request additions to videos to include such instructions.

7. For the reasons outlined above the Board was unanimous that the video be classified as indecent.

#### Pain by Lana

1. The Secretary of Internal Affairs sought a review of the video Pain by Lana pursuant to section 36 of the Video Recordings Act 1987 (the Act).

2. The Video Recordings Board of Review (the Board) reexamined the video in accordance with section 38 of the Act. It did not consult with any other persons in reaching its decision.

3. The video comprised nine protracted scenes in which the male actor is subjected to varying forms of bondage and discipline. Lana performs these acts in an unemotional detached manner but during the course of the video she becomes more dominating and powerful.

The acts depicted comprised tying up the naked male actor into bizarre positions; whipping and beating with leather thongs and a cane mostly in the buttock area; affixing hook and clamp like structures into his nipples and penis which were then manipulated in a torture like manner; and brushing, pricking and prodding the penis and scrotal area.

4. The Board took into consideration the matters that it is required to pursuant to section 21 of the Act. It formed the following conclusions:

(a) The main effect of the video is the infliction of pain and humiliation on a male by a dominant woman.

(b) The video had no artistic, social or cultural merit, value or importance.

- It was extremely poorly acted, the filming was of poor quality and standard. It was difficult to see clearly what was happening in some of the sequences.
- (c) The video would have limited appeal to a predominantly adult male audience.
- (d) The Board recognises that a small percentage of males chose to obtain sexual satisfaction by being subjected to constraint, discipline and the infliction of pain. It

concluded however that the extent of the cruelty and humiliation depicted in the video and the association of such extreme cruelty with a pleasurable activity constitutes offensive behaviour.

- (e) The depiction of subjection and humiliation of a man by the cruel and dominating acts of a woman although being demeaning and degrading to men and women, could not be construed as denigrating in the literal sense of the word.
- (f) The video is designed to be used by persons who are entertained or titillated by this form of aberrant activity.
- (g) A large part of the video took place in silence. There was no background setting and little dialogue. Lana's instructions were trite and emotionless and the male's responses abject and pathetic. The soundtrack contributed little to the video due in part to the poor acting and difficulty in clearly hearing much of what was being said.

5. The Board also considered other matters raised by the video. Although the video was meant to portray one long bondage and discipline session there is no way of knowing over how long a time period the events were shot. Such videos can therefore create false impressions. For example, some of the extreme positions into which the actor was bound could be dangerous if they were emulated over long periods of time.

As already noted the Board recognises that some men choose to be subjected to bondage and discipline sessions in order to obtain sexual satisfaction. Nevertheless it is an aberrant behaviour. The Board questions the desirability of producing commercial videos of such behaviour for entertainment purposes.

*Objectives of the Trust:* To receive income and allocate such income for charitable, cultural, philanthropic, recreational and other purposes, being purposes beneficial to the community principally in the Bay of Plenty area.

Policies and Structure of the Trust: A charitable trust designed to administer capital and distribute income for charitable purposes in the Bay of Plenty area.

Activities of the Trust: This was the first full year of operation of the trust. During this time the first dividends were paid by Trust Bank New Zealand Ltd., and donations totalling \$146,075 were made by the trust to community organisations within the Bay of Plenty.

*Review of Results and Financial Position of the Trust:* Dividends of \$307,500 were received from Trust Bank New Zealand Ltd. during the year, of which \$146,075 was distributed by way of donations. The remainder has been invested for the time being, both to consolidate the trust's position and to provide an operating income. After operating costs of \$23,018, a profit of \$153,307 was transferred to the accumulated trust fund. At 31 March 1990 this fund stood at \$9,160,220.

Assets of the trust include 7.5 million shares in Trust Bank New Zealand Ltd. valued at their cost of \$9,026,000, plus term deposits and Government stock amounting to \$131,444.

Also included in the trust's assets is the initial contribution of \$7,500 to the newly formed National Disaster Relief Fund. This was subsequently reduced by donations made to the mayoral relief funds in Wanganui and Taranaki.

#### **1. Statement of Accounting Policies**

#### General Accounting Policies

The general accounting policies adopted in the preparation of these financial statements are:

#### The ASB Trusts 1990

#### Financial Statement for the Period Ended 31 March 1990

### THE ASB TRUSTS Chairperson's Report

In the second year of operation, the Trusts have increased in experience and effectiveness. Policies developed in the first year have provided a firm foundation for future growth. Together, the two Trusts have made 575 donations totalling \$13.4 million for the benefit of the people of the Auckland and Northland regions. Last year the region hosted the Commonwealth Games and the 1990 commemoration ceremonies at Waitangi. The Trusts supported both these events. The ASB Bank Community Trust granted \$2 million to participating sporting groups for equipment to be used at the Games, donated the Commonwealth Quilt, and donated \$110,000 to the Kaupapa Waka to provide tents and other equipment for the paddlers of the canoes from this region which attended Waitangi. All of those things, and the venues that were upgraded with the Trusts' help, will be useful for many years.

The work of the Trusts is almost equally divided between concern for the investment and business side of the operations, and considering applications for donations.

In my first report I referred to the duty of prudence which is required of Trustees. A degree of judgement is required which is more than conservatism. The Trustees have kept that duty in mind, both in investment policy and while considering donations. I think that caution has remained uppermost, but our actions have not been devoid of imagination. Approximately two-thirds of the Trusts' income has been donated to projects which will make a difference to the whole region.

The ASB Trusts have been in operation for only two years but it has already been necessary to reflect upon their relationship with the community and the Government. Clearly, the Trusts should assist the disadvantaged and we have also supported education, health and social service initiatives. I do not think, however, that the Trusts should take over responsibilities which belong to central or local government, nor should they habitually rush in ahead of the community to support causes or initiatives which cannot demonstrate a credible level of support from elsewhere.

Dependence is another issue. Modest help with running costs may be provided, especially to voluntary organisations, but in general the Trusts do not make donations for purposes such as salaries That would encourage a degree of dependence which could well fill every list with "regulars" and leave no room for new applicants. So far, the Trusts have preferred to support finite projects to which the applicants themselves have donated resources in terms of money and energy.

The extent of voluntary community effort in the region can be a matter of pride to us all. The Trustees are enormously encouraged by it and the ASB Trusts are usually ready, indeed eager, to respond to it.

#### TWO TRUSTS

Last year I referred to the formation of the ASB Charitable Trust in May 1989.

In order to comply with the requirements of the Inland Revenue Department, the ASB Bank Community Trust and the ASB Charitable Trust must be separate entities. Their separate identities are reflected in the structure of this report and in the accounts. The graphs illustrate their relative size (the Charitable Trust holds 75% of the aggregate capital) and their differing roles.

The Charitable Trust confines its donations to organisations which are certified as tax exempt for charitable purposes because they fall within the narrower legal definition of 'charity'. The ASB Bank Community Trust's Deed enables it to respond to organisations which are of benefit to the people of Auckland and Northland but which may not be recognised as charitable by the Inland Revenue Department. In practice this shows up in the profiles of donations - the Community Trust gives a larger proportion of its grants to recreational projects, especially those which may benefit young people.

PRESENT NEEDS AND FUTURE BENEFICIARIES

Trustees are required to balance the needs o present and future beneficiaries of each Trust. Provision has therefore been made to preserve the capital of each one, but after such provision, and meeting expenses, almost all the income has been distributed in the year in which it was earned.

EXPENSES have been held to 2.17% in the Charitable Trust and 5.37% in the other. That is equal to 2.83% for the combined Trusts.

STAFFING - the business of the Trusts is managed by six highly committed and well qualified staff. I wish to record my thanks to John Spicer, the Secretary Manager, for the professionalism and efficiency with which he administers the Trusts, and to all the staff for their support.

ALLENDALE - Hon. David Caygill, the Minister of Finance, opened the Trusts' headquarters at 50 Ponsonby Road in October 1989. The building is a practical answer to our accommodation needs. It is also beautiful. Those who need to visit it have enjoyed being there. Allendale has a 'B' classification from the Historic Places Trust.

#### PUBLIC INFORMATION

Each Trust continues to inform the public of its activities through appropriate news releases, publication of annual accounts and donations lists, and newsletters. Three newsletters were issued in the 1989-90 year. Lists of donations are released every six months.

#### DONATIONS POLICIES

The ASB Trusts distributed \$13.4 million to the Auckland/Northland region in their second year of operation. In addition \$100,000 was donated to the Cyclone Ofa appeal.

Nevertheless, it was not possible to meet all requests. Declining a request does not imply a judgement on the organisation making it; usually it reflects the fact that our resources are not endless. When considering a request, Trustees bear in mind the following matters (in descending order of priority)

- ٠ The applicant's need measured against available resources
- Applicants' ability and potential to help themselves The potential community benefit

A donation is not always disbursed as soon as it is committed. It is usually paid when the project needs it. Proof of progress is sometimes required. These timing differences between commitment and disbursement reflect the Trusts' cautious approach, and enable extra income to be earned for the benefit of a wider group of beneficiaries.

#### CONCLUSION

On 31st May the terms of appointment of four Trustees: George Hawkins, Frank Knipe, Agnes Tuisamoa and Judith Bassett expired. All were reappointed. During the year, Dame Catherine Tizard's appointment as Governor General was announced and Waari Ward-Holmes, our deputy chairman, was appointed to a Fellowship of the NZ Society of Accountants. The Trustees congratulate Dame Catherine and Mr. Ward-Holmes on these honours

I wish to add my personal thanks to all Trustees for the application of detail and the imagination which they have brought to their work. This has been a full, and I believe a positive year for the Trusts.

#### ASB BANK **COMMUNITY TRUST**

The sole asset of this Trust is its 25% shareholding in ASB Bank Limited.

Dividends of \$5.865 million and interest of \$246,000 represented a 9.19% return on average capital invested, before expenses. The relationship of the Trust, the minority shareholder, with the majority shareholder, the Commonwealth Bank of Australia, is excellent.

#### RESERVES

The dividend declared by ASB Bank Limited last year represented 40% of its profit. The remaining 60% was retained and provides an automatic reserve by adding value to the Trust's share of the asset. No further reserves have been created in the Trust's accounts.

#### DONATIONS

Every one of the 208 donations from this Trust was important to the organisation or community that received it, and also to the Trust. Media interest inevitably tends to focus on the larger donations, but the Trustees also take a lot of interest in the small ones.

The larger donations from the ASB Bank Community Trust went, in general, to museums, maraes, recreational and cultural projects. All the organisations receiving them showed evidence of substantial community support for their project before the Trust was approached for assistance.

#### ASB CHARITABLE TRUST

INVESTMENT POLICIES

Diversification of investments has been achieved by a spread of funds management, asset type, and currencies. Five fund managers have been appointed, each of whom manages \$50 million on behalf of the Trust. A lesser amount is managed by the Trust's staff. Funds are invested in cash deposits, bonds and equities, in New Zealand and off-shore

The Trust has instructed its fund managers to follow conservative investment policies, consistent with a reasonable income return.

Our investment objectives, in descending

# To preserve the capital, and increase it if possible Minimise risk

- Provide an adequate return
- Maintain appropriate liquidity

The return on capital during the ten months of this Trust's existence was 11.75% per annum, before expenses.

#### RESERVES

The market value of our investments is constantly changing. At balance date it was adverse to the extent of 3.4% of invested capital. Therefore, we have reserved a matching amount out of income as a provision for investment fluctuations. We expect this to vary each year, sometimes positive, sometimes negative. In addition, fifty per cent of the Trust's net income was transferred to capital reserve leaving \$8,438,000 available for distribution.

#### DONATIONS

The work of this Trust was primarily concerned with the support of education, health, voluntary associations who assist the disadvantaged and with projects which benefit young people in the region. The list speaks for itself. The Trust made 367

donations and nearly three-quarters of the total amount granted went to regional projects. Some of them lay the foundation for important future development — e.g. the donation to the Royal New Zealand Foundation for the Blind to build a guide dog unit at Homai. This, we hope, will go a long way towards providing mobility for people in this region who presently do not have that freedom. So, in its way, will the donation to assist the work of the Phobic Trust. One of the largest donations in the list went to Odyssey House, an organisation with a long and credible track record in the treatment of drug and substance abuse. For years now Odyssey has been seeking a suitable home and it gave the Trust considerable satisfaction to be able to assist it to achieve that fundamental goal.

#### Notes to the Financial Statements FOR THE YEAR ENDED 31 MARCH, 1990.

#### STATEMENT OF ACCOUNTING POLICIES ٤.

31A JEMENT OF ACLOUNTING POLICIES The ASB Bank Community Trust ("the Trust") was formed on 30 May 1988 through the creation of a trust deed in compliance with the Trustee Banks Restructuring Act 1988. Under the terms of the trust deed the Trust was settled with 60 million \$1 fully paid ordinary shares in ASB Bank Limited representing 100% of the issued capital. Subsequently 45 million shares were sold.

#### GENERAL ACCOUNTING POLICIES

The measurement basis adopted is that of historical cost adjusted for the revaluation of certain assets. Reliance is placed on the fact that the Trust is a going concern. Accrual accounting is used to match income and expenditure.

#### PARTICULAR ACCOUNTING POLICIES

Investments are valued at the net tangible asset backing as disclosed in the latest published accounts. Any

revaluation difference is transferred to an investment revaluation reserve Fixed Assets

Fixed Assets are valued at cost less accumulated depreciation.

Depreciation Office equipment and furniture are depreciated on a diminishing value basis

Taxatio

Taxation includes both current and deferred tax. Deferred tax is calculated using the liability method.

Dividends Dividends are recognised as income when they are received by the Trust

Donations

Donations are accounted for as they are distributed or committed to be distributed to eligible organisations as Domains are accounted to as they are used built or committee to be used more than the second and approved by the Trustees except that where donations approved are payable over a number of accounting periods the future donations payable are accounted for in the year in which they are paid. **Changes in Accounting Policies** 

Changes in Accounting Policies Formerly investments were included at their value on the date they were received pursuant to the Trustee Banks Restructuring Act 1988. The method of valuing investments has been changed and they are now included at their net tangible asset backing as disclosed in the latest available published accounts of the investee company. The Trustees consider that this method more fairly reflects the underlying value of the investment. The effect of this is to increase the value of the investment in 1989 by \$117,282,000 and to reduce the capital gain on sale by \$87,961,000 in 1990.
