Meat Export Control Act 1921-22

Meat Board Levy on Stock Slaughtered

Pursuant to section 13 (3) of the Meat Export Control Act 1921-22, notice is given that the New Zealand Meat Producers Board hereby fixes the rates of levy to be paid on each head of stock slaughtered on licensed premises (except

on stock slaughtered on licensed premises in the Chatham Islands) as follows:

Except that a nil rate of levy will apply to any stock the carcasses of which are wholly condemned for any reason following slaughter.

These rates of levy will come into effect from and inclusive of the 1st day of October 1990 and apply during the 1990–91 meat season and subsequently until such time as new levy rates are fixed and come into force.

Notice of Review of Need for Continued Imposition of Anti-Dumping Duty on Hog Bristle Paint Brushes from China

I, David John Butcher, Minister of Commerce, hereby give notice that, pursuant to section 19 (3) of the Dumping and Countervailing Duties Act 1988 and section 186L (5) of the Customs Act 1966 (as inserted by section 2 (1) of the Customs Amendment Act (No. 3) 1987), I shall review the need for the continued imposition of the anti-dumping duty on the goods described in the Schedule hereto, which duty was imposed by the Minister of Customs by notice, dated 31 May 1988, published in the *Gazette* of 2 June 1988.

Schedule

Description of Goods Subject to Review of the Need for the Continued Imposition of Anti-Dumping Duty

The goods subject to this notice are:

Hog bristle paint brushes for household or industrial use being classified within tariff item 9603.40.00.01F of the Tariff of New Zealand when exported from the People's Republic of China by the China National Native Produce and Annual By-product Import Export Corporation and entered for home consumption in New Zealand on or after 14 March 1988.

Revocation of Notice Imposing Anti-Dumping Duty and Countervailing Duty in Respect of Certain Catamarans Imported From Australia

In accordance with section 19 (1) and section 19 (3) (a) of the Dumping and Countervailing Duties Act 1988, and pursuant to section 186L (4) of Part VA of the Customs Act 1966 (as inserted by section 2 (1) of the Customs Amendment Act (No. 3) 1987, the Minister of Commerce gives the following notice.

Notice

1. Title—(1) This notice may be cited as the Revocation of Notice Imposing Anti-Dumping Duty and Countervailing Duty in Respect of Certain Catamarans From Australia.

(2) This notice shall come into force on the day after the date on which it is published in the *Gazette*.

2. Revocation of notice imposing duty—The notice given by the Minister of Customs entitled "Final Determination Pursuant to section 186K of the Customs Act 1966" dated 2 March 1988 and published in the *Gazette* of 4 March 1988 ("the principal notice") is hereby revoked and the duties imposed by the principal notice shall cease to be payable.

3. Reason for revocation—The reason for the revocation of the principal notice is:

(a) In relation to the imposition of anti-dumping duty, that section 16 of the Dumping and Countervailing Duties Amendment Act 1990, with effect from the 1st day of July 1990, effectively terminated any action in relation to the continuation, completion, determination, and enforcement of any investigation into any alleged dumping initiated under section 186H of the Customs Act 1966 (as inserted by section 2 (1) of the Customs Amendment Act (No. 3) 1987) in respect of goods of Australian origin; and

(b) In relation to the imposition of countervailing duty, that a review of the continued need for the imposition of the duty was carried out and it was found that there is now no New Zealand industry in relation to the catamarans described in the principal notice, thus the importation into New Zealand from Australia of the catamarans described in the principal notice no longer causes or is likely to cause material injury to an industry in New Zealand.

Publisher: Linx Publications, Wellington.

Decision

New Zealand Swing Club Linx Magazine, International Issue No. 2, came before the Tribunal as a result of a bookseller in a provincial city being granted leave by the Minister of Justice to submit that issue of the publication to the Tribunal for classification under the Indecent Publications Act 1963.

P. M. Bartlett, the director for the Society for the Promotion of Community Standards Inc., was similarly granted leave by the Minister of Justice to submit the remaining 3 issues of the publication *Linx* to the Tribunal for classification.

The matters were originally set down for hearing at Wellington on 28 November 1989, but as there was no appearance on behalf of the bookseller who had been granted permission to bring before the Tribunal, *Linx Magazine*, International Issue No. 2, that matter was adjourned to the present sitting to enable that person to have the opportunity of either making representations in person or in writing. In respect of the remaining 3 publications a written submission was presented to the Tribunal by the Rev. Gordon Dempsey, the representative of the Society for the Promotion of Community Standards Inc. and the society sought an unconditionally indecent classification and a serial restriction order confirming that classification in terms of section 15A of the Act.

Under questioning by the members of the Tribunal, Rev. Dempsey advised the Tribunal of the result of the *National Business Review* research poll and a copy of the report on the poll was provided to the Tribunal. When further questioned by the Tribunal, Rev. Dempsey referred the Tribunal to its earlier decision 1007 which he submitted should be followed in this case, as that decision he submitted sets out very cogent reasons why the type of promiscuous sex advocated by this publication is not only injurious to the public good, but dangerous to the community.

After the formal hearing the Tribunal members met to consider the classification for the 3 publications presented for classification by the society. The Tribunal members did not at that subsequent discussion have the opportunity to consider the lengthy decision No. 1007 and accordingly this application was adjourned part heard until the next sitting of the Tribunal on 20 February 1990. Because of the possibility that further submissions would be presented to the Tribunal by the bookseller referred to in this decision all matters in relation to *Linx* magazine were accordingly adjourned to be further considered at the sitting on 20 February 1990. In the meantime the Tribunal members had read further material provided and they were in a position at the conclusion of the sitting to reach a decision on the classification of all 4 magazines *Linx* magazine is allegedly a contact magazine giving New Zealanders the opportunity of having advertisements included in the magazine to make contact with others for a variety of purposes, many of them clearly of a sexual nature. The advertisements represent slightly less than one-third of the total content, the remainder includes a number of letters from subscribers, a number of cartoons which in most cases are quite crude, photographs of partly clad and naked females and in some cases males, short articles, fantasy essays and other written material, all of which is of a sexual nature. The magazine is very similar in content if not in production to a number of similar contact magazines which come into New Zealand from Australia and the United Kingdom and some other countries.

This publication is published in New Zealand and has apparently been freely available through a significant number of outlets. Had it not been for that fact, at least 1 member of the Tribunal would have classified these publications as unconditionally indecent. In the magazines there are several photographs of males and females engaged in acts of sexual intimacy. They are of a kind which but for other considerations I shall shortly mention, might well have resulted in these particular issues being classified as unconditionally indecent.

The Indecent Publications Act 1963 creates in sections 21 and 22 a significant number of offences and many of those offences carry a maximum sentence of imprisonment. In the event of the majority of the Tribunal finding that these particular publications are indecent it would effectively create a liability of conviction and punishment for a very large number of people throughout New Zealand. In the end result a

consideration of that prospect was unnecessary as the majority of the Tribunal were prepared to grant to these particular magazines an age restriction classification with certain conditions. I would however draw to the attention of the publishers, distributors, vendors and would be purchasers of future volumes that there remains a possibility that future volumes if they do publish explicit photos of couples engaged in sexual intimacy may be found to be unconditionally indecent in terms of the legislation under which we act and classify it accordingly.

Decision 1007 related to a publication *Key* magazine No. 6, also published in New Zealand, a magazine very similar in its format to that of *Linx*, but it would seem from the judgment without the same amount of explicit photographic material as is contained in *Linx*. That case was argued before the Tribunal by an inspector from the legal section of the New Zealand Police and by counsel for 1 of the retail outlets. In addition written submissions were presented by the publisher and further written submissions were supplied by a clinical psychologist. In a very careful and considered decision of 12 pages the Tribunal reached a conclusion in respect of that particular publication that it should be classified as unconditionally indecent. I do not propose to explore in this decision the reasons for that Tribunal arriving at that particular decision, but simply note that the decision is available to publishers, distributors and retailers.

The leave of the Minister for a person to submit any book to the Tribunal is not lightly given and in my view the society acted quite properly in seeking such leave and in prosecuting the matter before use.

For the reasons expressed in this decision the Tribunal classifies each of these publications as indecent in the hands of persons under the age of 18 years and orders that all such publications shall be shrink wrapped.

Decision

Although there was no appearance by or on behalf of the importer he provided for the Tribunal a lengthy and well presented written submission which the Tribunal read and took into account in considering these publications.

It may not generally be known that the Tribunal has the powers of a commission of inquiry and those powers are given to the Tribunal subject to certain conditions by virtue of section 7 of the Indecent Publications Act 1963.

This particular application was one which required the Tribunal to use those powers and to seek from other parties advice in relation to the possible effects of the availability of these publications within New Zealand. That advice has been

received and considered by the Tribunal which is now in a position to classify the material.

These publications were privately imported through parcels post Auckland on 27 November 1989. The publications having been seized by the Collector of Customs the importer disputed forfeiture and the publications were referred to the Tribunal for classification prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

The publications which are both in magazine form provide engineers templates and specific detailed instructions for the "home" construction of silencers and firearms. Both publications are printed by the same firm in the United States and both contain warnings that the manufacture of the items mentioned therein could be against United States law.

The Comptroller through the submission of Mr Wotherspoon pointed out to the Tribunal that similar publications have previously been considered by the Tribunal and some of them have received an unconditionally indecent classification because of the possibility that they might either lead or assist members of the public to become involved in criminal offending.

As a result of the inquiries made by the Tribunal and its consideration of the submissions made by both the Comptroller of Customs and the importer it finds and classifies the publication *Home Workshop Silencers 1* not indecent.

The other publication is not in quite the same category for to convert the Ruger 1022 rifle to automatic fire capability would result in the creation of a "restricted weapon" within the meaning of the Arms Act 1983 and a person carrying out the conversion has committed the offence of being in possession of a restricted weapon without some lawful, proper and sufficient purpose in terms of section 45 of that Act. It is clear to the Tribunal however that there are a significant number of arms dealers, collectors and firearms enthusiasts who for purely professional and interest reasons would like to have the opportunity to include this book in their libraries and the Tribunal sees no reason why they should not at least have the opportunity to do so. The Tribunal is satisfied that the importer of these particular items comes within that category and the publications will accordingly be returned to him and he will not be required to obtain the pre-requisite authority for possession of these books which other persons who desire to possess them will in future need to obtain.

In terms of section 10 (b) of the Indecent Publications Act 1963 the Tribunal classifies the *Ruger 1022 Exotic Weapons System* publication is indecent in the hands of all persons other than registered firearm dealers, genuine collectors of firearms and firearms enthusiasts. Those persons other than firearms dealers wishing to obtain possession of this publication will require a certificate from the nearest arms officer that they are persons coming within the limited restricted class as set out in this decision.

This publication was privately imported through Auckland parcels post on or about 19 October 1989. The publication having been seized by the Collector of Customs the importer subsequently disputed forfeiture and the publication was referred to the Tribunal for classification prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

The Tribunal was not able to reach an immediate decision following the hearing on 20 February 1990 as several of the members of the Tribunal had not had the opportunity of reading the publication. All members having now read the publication, the Tribunal is in a position to reach a decision on its classification.

High Times is a magazine which promotes the home cultivation and use of marijuana. It is a well prepared and well presented publication and contains a great deal of information about different species of marijuana or cannabis and it is of interest to note that the editors do not claim for that substance that its use is without danger. The publication is one which advocates the legalisation of the growing and use of marijuana or cannabis and quite clearly is one dedicated towards promoting the free use of that drug.

In a submission to the Tribunal the Comptroller of Customs represented by Mr Wotherspoon points out that the cultivation and use of this drug is an offence against the Misuse of Drugs Act 1977 and directed the Tribunal's attention to its recent decision No. 23/89 in which the Tribunal considered a publication relating to the growing and use of Psilocybin (a magic mushroom grower's guide) in which the Tribunal classified that publication as unconditionally indecent as it was one which advocated or incited actions which are unlawful in this country.

For the same reasons as expressed in decision No. 23/89 the Tribunal classifies this publication as unconditionally indecent.

Although there was no appearance by or on behalf of the importer at the hearing of the Tribunal the Tribunal received and considered a written submission provided by the importer and attached to that submission were a number of exhibits which were likewise read and considered by the Tribunal.

When this publication originally came before the Tribunal at its sitting on 20 February 1990 a final decision could not be reached by the members as a number of the members had not had the opportunity to consider the publication in any depth. Since that time all members have read the publication and the Tribunal is now in a position where it can bring down a classification in respect of the matter.

This publication as the name suggests gives some detailed descriptions of methods which might be employed to carry out frauds involving such areas as travel, business takeovers, credit cards, real estate and the like. A significant number of decisions issued by the Tribunal over recent years have found that publications which advocate what would be on the face of it appear to be criminal activity are unconditionally indecent as being injurious to the public good. In respect of this publication however the Tribunal is satisfied that the material contained therein is somewhat innocuous and perhaps even long out of date and there seems little danger, if any, that the publication would be the basis of criminal activity by any of its readers.

The Tribunal also notes that this is a single issue importation brought into New Zealand by a private importer and we are satisfied from the evidence of that importer provided in his written submission that he has no intention to use the document for any criminal purpose. The Tribunal accordingly classifies this publication as not indecent.

Decision

Although there was no appearance by or on behalf of the importer the Tribunal had received and considered a short submission from that person. The publication was privately imported through parcel post Auckland on 11 January 1990. The publication having been seized by the Collector of Customs the importer subsequently disputed forfeiture and the publication was referred to the Tribunal for classification prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

As pointed out by Mr Wotherspoon on behalf of the Comptroller of Customs an attempt had been made by the person sending the publication to disguise the actual content by placing it inside the pages of another magazine of a completely innocuous nature.

The magazine features a single male model in various poses and various stages of undress. The Tribunal members were all in agreement that the production was of a very high standard

and the photographs were beautifully presented in terms of their technical production and many of them would be classified as top quality art.

That feature of the magazine which caused the Comptroller of Customs to refer the matter to the Tribunal is that the model is in some of the photographs, although the genitalia has been deliberately obscured, in the process of masturbation and in one photo ejaculation is depicted.

Over the past 2 or 3 years the Tribunal has on a number of occasions had witnesses appear and also received written evidence from others advocating a restricted classification in respect of magazines depicting a single male model either holding or manipulating his penis in a pose of masturbation and those witnesses and those persons making submissions have directed the Tribunal's attention to what they perceive as a very real urgent need for the male homosexual community to have available to it magazines of this kind as against magazines illustrating anal intercourse. In a number of decisions over that same period the Tribunal has classified as unconditionally indecent magazines which depict male masturbation and ejaculation but it is fair to say that some of those decisions have been borderline and have almost invariably been reached because there has been little else about the publication which in any way might ameliorate the rather gross and crude presentation shown in the photographs.

In reaching a conclusion that this particular magazine should be classified as indecent in the hands of persons under the age of 18 years the Tribunal has taken into account a number of factors including:

1. That the publication is a high-quality production and would be quite obviously a very expensive magazine to purchase.
2. That the majority of the photographs depict a nude model in artistic poses which do not have sexual overtones.
3. That in those photographs which might otherwise be objectionable there has been a deliberate attempt by the publisher to mask the genital region.
4. That this is a one-off importation and not a commercial venture.

Insofar as that final matter is concerned, the Tribunal acknowledges that there is nothing to prevent the commercial importation of this magazine but even if that were a factor in this particular case it would not affect the Tribunal's ultimate decision to classify the book as it does as indecent in the hands of persons under the age of 18 years.

Customs at Auckland and the Auckland City Public Libraries has subsequently disputed forfeiture.

The Comptroller in his submission to the Tribunal states that the publication is an informative book containing detailed information on the various methods of birth control. The only reason why the Comptroller sees this book as requiring a classification from the Tribunal is because of the requirements of the Contraception, Sterilisation and Abortion Act 1977, the provisions of which may require a ruling that the publication is indecent in the hands of persons under the age of 16 years.

I have taken the opportunity to discuss this publication with the other members of the Tribunal and all are agreed that the publication is a professional one and that the only reason why an age restriction would be required is because of the inclusion of advice on contraception. An interim restriction order is accordingly made classifying this publication as indecent in the hands of persons under the age of 16 years.

During the course of the hearing of the Tribunal at Wellington on 23 May 1990, I took the opportunity of discussing this publication with the other members of the Tribunal and all members agree that in due course this publication should be given a classification as indecent in the hands of persons under the age of 16 years.

I am satisfied that an age restriction on this present interim application is justified and accordingly I issue a section 14A restriction order declaring this publication to be indecent in the hands of persons under the age of 16 years.

Decision

This publication comes before the Tribunal as the result of the laying of an information CRN9085021306 in the District Court, Wellington on 23 November 1989 against the person named therein as defendant alleging that he did on the 7th day of July 1989 at Wellington have in his possession for sale an indecent document namely *Foxy Magazine*, a charge laid under the provisions of section 21 (1) (a) of the Indecent Publications Act 1963. The information has endorsed on it that the Attorney-General has given leave to the police to prosecute the defendant for the offence set out in the information.

On 23 March 1990 the publication, the subject of the prosecution in the Wellington District Court, was referred to the Tribunal in terms of section 12 (1) of the Indecent Publications Act 1963 to determine the question as to whether the publication is indecent within the meaning of the Act or is indecent in the hands of persons under a specified age or is indecent unless its circulation is restricted to specified persons or classes of persons or unless used for a particular purpose as the case may be.

The Tribunal was advised by an officer of the Tribunal that advice had been received from both the police and counsel representing the defendant that neither the police nor the defendant would be represented at the hearing before the Tribunal, the matter simply being left for determination by the Tribunal in terms of the Indecent Publications Act 1963.

The publication is in magazine form and is a glossy 71-page production. There are 6 pages of photographs of advertisers or in some cases photographs of their genitalia. Many of the photographs are unobjectionable being of clothed persons in normal poses. Other photographs are of naked or partly clad male or female persons in pose positions accentuating their genitalia. Two photographs in a section between pages 36 and 37 show in the 1 case a male and a female person in the act of sexual intercourse and in the other 2 female persons in the act of oral intercourse. On the inside of the back cover of the magazine there is a photograph of the trunk and upper legs of a female person showing her holding a vibrator against her vagina.

Within the magazine appear approximately 15 pages of advertisements many of which are of persons seeking parties for a variety of sexual activities whilst a considerable number of others are within the category of simple lonely hearts advertisements.

The remainder of the magazine is of written material covering a great variety of topics. Under a heading "Cancer & Aids Are A Piece of Cake To Heal And Prevent" there follows 12 pages dealing with a great variety of medical subjects and although it is not possible on a careful reading of all of that material to say precisely what the author is setting out to achieve, the theme appears to be one that most illnesses and diseases are readily treatable by vitamins or by some simple processes. The remainder of the magazine is filled up with a pot pourri of paragraphs most of which deal with women or children and in particular those persons in relation to their sexuality. There are a number of other paragraphs throughout the publication which defy any rational categorisation and all of this is preceded by an editorial on page 2 by the editor indicating that this is a first production of the magazine which informs the

reader, amongst other things, that the editor is working on a book and also a thesis on Aids.

The whole tenor of the magazine is weird and disturbing but that of course is insufficient to classify it as either indecent or the subject for a restrictive classification. From a reading of the magazine one gains a very clear impression that it is all the work of one person and it is hard to escape the conclusion that that person is suffering from some major psychiatric malfunction or disorder.

In terms of section 11 of the Act the Tribunal is required to take into consideration in determining or classifying the character of the publication a number of different matters and I proceed now to consider those:

(a) The Dominant Effect of the Book

It is quite obvious that the writer of the publication is concerned about society's attitudes towards sexual matters and sexuality. The book has strong overtones of being anti-women and there are many paragraphs which indicate that the writer blames the attitude of women for sex crimes against women and children. The dominant effect of the book is an anti-societal thesis.

(b) The Literary or Artistic Merit or the Medical, Legal, Political, Social or Scientific Character or Importance of the Book

The book is totally lacking in any literary merit and the prose often presents itself as being the product of a disturbed mind. No claim for any artistic merit could possibly be made for the book. The section which I have earlier referred to dealing with cancer and Aids and other medical problems again appears to be the product of either a disturbed mind or at best a piece of nonsense writing of a most distasteful kind. The book is totally devoid of any of the other aspects of character or importance referred to in the section.

(c) Classes of Persons and Age Groups to Whom the Book is Likely to be Published, etc.

It is difficult for the Tribunal members to believe that the book would have anything but the very narrowest of appeal and we seriously doubt that sales would cover the cost of production. The publication is probably aimed at older readers and clearly the intention of the advertising section is to enable people to meet people with similar sexual objectives.

(d) The Price

The cover of the book shows this to be \$15 and again we can only think that those who are mentally disturbed would be prepared to pay out \$15 in order to read the contents.

(e) The Likelihood of Corruption to Any Person Reading the Book, etc.

It would seem that only persons who are already warped in their attitudes towards society would find any comfort from reading the publication and we seriously doubt whether the author would be able to persuade otherwise normal people to accept and adopt his philosophies.

(f) Has the Book an Honest Purpose

As I have indicated in this decision, the publication appears to be the product of a disturbed mind and if that in fact be the case, then the person may have in his own view an honest purpose for publishing this very strange magazine, but there is certainly nothing of the "honest purpose and an honest thread of thought" of the kind which Parliament clearly intended the Tribunal to take into account when considering matters of this kind.

In considering the total content of the production, the Tribunal has no difficulty in reaching a conclusion that it is a magazine which is injurious to the public good and the photographs of a sexual nature would by themselves have been sufficient for the Tribunal to have come to that conclusion. When those photographs are taken together with the total context, it is

impossible to avoid a classification of unconditionally indecent and the Tribunal answers the question in the reference that the classification of *Foxy Magazine* is unconditionally indecent.

That aspect of the publication which caused the Tribunal some concern and resulted in the delay in the issue of this decision was a multiple model picture scenario of a sexual encounter in a garage between a male and a female. In the end result the Tribunal reached the conclusion that there was nothing explicit in that particular display of a kind which would be injurious to older readers although it is satisfied that the material in general would be injurious to younger readers.

The Tribunal classifies this publication as indecent in the hands of persons under the age of 18 years.

Decision

This publication was a sample copy imported through the port of Hamilton by airmail in July 1986. The publication having been seized by the Collector of Customs, the importer disputed forfeiture and the publication was referred to the Tribunal for classification.

The publication has been produced ostensibly as a sex manual. It is said to be the work of a Walter Braun, M.D., Professor Emeritus of the University of Breslau, it also has an introduction by a W. F. Robie, M.D..

The Tribunal is far from satisfied that this particular publication is a genuine sex manual and the nature of the photographs, and particularly the responses of the models displayed, do no reflect the very high standards which one would normally anticipate from a professionally composed medical production. The Tribunal accordingly is satisfied that this particular publication lacks honesty of purpose and is also satisfied that as it is injurious to the public good it can only be classified as unconditionally indecent.

Decision

All of these publications were imported by Gordon and Gotch NZ Ltd. as commercial importations and they were referred, by the importer, to the Comptroller of Customs with a request that they be placed before the Tribunal for 2 purposes:

1. For the granting of interim restriction orders in respect of each publication in terms of section 14A of the Indecent Publications Act 1963; and
2. The making of serial publication orders in terms of section 15A of the Indecent Publications Act 1963 in respect of each publication or series of publications.

All of the *Penthouse* publications, the subject of these present applications, are presently subject to serial restriction orders classifying them as indecent in the hands of persons under the age of 18 years and those serial restriction orders remain current until 28 July 1990. The *Men Only* and related publications from that publisher were previously subject to a serial restriction order classifying them as indecent in the hands of persons under the age of 18 years, but those serial orders lapsed on 17 May 1990. The *Knave* and *Fiesta* publications, including the *Knave* and *Fiesta Specials*, were likewise the subject of a serial restriction order classifying them as indecent in the hands of persons under the age of 18 years and those orders expired on 29 April 1990.

Although the interim restriction orders are matters which fall to be dealt with by me as chairman of the Tribunal, all of the publications in question were in fact considered by all of the members of the Tribunal at the sitting of the Tribunal on 23 May 1990. Mr Wotherspoon on behalf of the Comptroller of Customs, advised the Tribunal that the Comptroller had considered all the publications in question and he submitted that it was appropriate that each publication should be the subject of an interim restriction order classifying them as indecent in the hands of persons under the age of 18 years. Mr Wotherspoon further submitted that the Tribunal as a whole should then consider each of the publications in terms of a request for a serial restriction order made by Mr Ellis, on behalf of the importer and distributor, and in that regard the Comptroller of Customs supported a classification of indecent in the hands of persons under the age of 18 years for each of those publications.

In terms of the interim restriction order application I am satisfied that it is appropriate that such orders be made and accordingly in respect of all the above titles, an interim restriction order is made and each of those publications is classified as indecent in the hands of persons under the age of 18 years.

Insofar as the substantive application for a serial restriction order before the Tribunal as a whole is concerned, the Tribunal

is satisfied that in each case, each of those publications, either under its principle title or under its collection or one-off titles, should be granted a serial restriction order classifying each as indecent in the hands of persons under the age of 18 years.

Decision

These publications were sample copies imported through the port of Auckland by parcel post in July 1986. The publications having been seized by the Collector of Customs, the importer subsequently disputed forfeiture and they were referred to the Tribunal prior to the commencement of condemnation proceedings pursuant to the Customs Act 1966.

Glamour Girl, Issue 3, is a collection of photographs of naked and semi-naked female models, but some of these models are photographed in poses which are clearly designed to draw attention to genitalia. The Tribunal is satisfied that this publication would be injurious to younger readers and classifies it as indecent in the hands of persons under the age of 18 years.

Park Lane, Vol. 1, No. 2, is also in magazine format but includes a considerable amount of material the bulk of which is of a sexual nature. The remainder is chiefly of single female models, most of whom are posed in a position to accentuate their genitalia. The Tribunal is satisfied that that publication is injurious to younger readers and classifies it as indecent in the hands of persons under the age of 18 years.

Ann Summers Guide to Better Sex is similar in format to a number of productions by Ann Summers which have been the subject of decision by the Tribunal. The Tribunal agrees with the Comptroller of Customs in the submission advanced at the time, when this matter came before it, that although it is a lightweight text and tends to concentrate more on photographs to convey its message, it does not contain anything blatantly offensive and warrants an age restriction only. The publication is accordingly classified as indecent in the hands of persons under the age of 18 years.

Since these publications were referred to the Tribunal, the publication *101 Sex Positions* has come before the Tribunal for classification. The Tribunal is satisfied that this publication lacks honesty of purpose in respect of the theme a valid and serious sex manual and it contains material which the Tribunal's view is injurious to the public good. The Tribunal classifies this publication as unconditionally indecent.

Supplementary Decision

This sample copy was imported through the port of Dunedin in October 1984 and was referred to the Tribunal at the request of the importer for a decision as to its indecency. At the original hearing there was no appearance by the importing company nor was there any representation made in writing by it or on its behalf. The publication was one of a number of books which were before the Tribunal at that time and in respect of the other publications decision was delivered in No. 6/85 on 25 July 1985. In that decision the following is recorded in respect of this present publication:

"*The Victorian Imagination, a Sampler.* The remaining publication, *The Victorian Imagination, a Sampler*, is a book which in our opinion falls into a difficult category. Some investigations which we have carried out suggest to us that the material reproduced might be genuine Victorian literature. The authenticity of the material is very much a matter which could determine the classification given to this publication. The Tribunal has the powers of a commission of inquiry which enables it to obtain further evidence in relation to a particular matter. In this case the Tribunal believes that it is important that expert evidence be obtained as to whether or not the material in this publication is genuine Victorian literature. Upon receipt and consideration of that expert opinion the Tribunal will reach a final determination as to this publication. The application in respect of it has been adjourned."

Following that decision the publication was referred to a specialist academic in the area of Victorian writing. The expert in question reported to the Tribunal on 14 August 1985 with a very helpful and professional consideration of the issues which were of concern to the Tribunal. The members of the Tribunal, at that time, having considered that report, decided on a special category of classification for the publication but unfortunately that issue was never finally dealt with.

The Tribunal accepts that the book has both literary and historical value and that it should be made available to those working in the area of Victorian literature, history or social studies.

The Tribunal accordingly classifies this publication as indecent in the hands of all persons other than those whose professional or academic studies extend into the fields of Victorian literature, history or social studies.
