Government Notices**Agriculture and Fisheries****Animal Remedies Act 1967****Licenses Issued Under the Animal Remedies Act 1967 (Notice No. 5080; Ag. 154)**

Pursuant to sections 21 (6) 26A and 28 (3) of the Animal Remedies Act 1967, the Registrar of the Animal Remedies Board hereby gives notice that licenses have been issued, reissued or revoked in the Schedules hereto;

1. The licenses for remedies listed in Schedule I are new licenses issued, not subject to conditions.
2. The licenses for remedies listed in Schedule II are new licenses issued subject to conditions:
 - (a) That the remedy shall not be sold to any other person other than a Veterinary Surgeon, or a Dealer or otherwise than pursuant to the prescription of a Veterinary Surgeon; and
 - (b) That the remedy shall not be used otherwise than by or under the supervision of a Veterinary Surgeon.
3. The remedies listed in Schedule III are provisionally licensed subject to the conditions shown in respect of them.
4. The licenses for remedies listed in Schedule IV are licenses which have lapsed or have been withdrawn by the licensee.
