Broadcasting Standards Authority—Decision No. 37/91

In decision 37/91, the Authority upheld a complaint by Mr George Ngaei of Invercargill that the broadcast by Radio New Zealand Limited of news items on 30 May 1990 breached the responsibility placed on broadcasters to deal justly and fairly with any person referred to in any programme and that the broadcast of news items on the same date and on 22 and 23 June 1990 breached the responsibility placed on broadcasters to show balance impartiality and fairness in dealing with all questions of a controversial nature and to make reasonable efforts to present significant points of view in the same period or in other programmes within the period of current interest.

Water and Soil Conservation Act 1967

The Local Water Conservation (Lake Tuakitoto) Notice 1991

1. Title and commencement—(1) This notice may be cited as the Local Water Conservation (Lake Tuakitoto) Notice 1991.

(2) This notice shall come into force on the 14th day after the date of its notification in the Gazette.

2. Interpretation—In this notice, unless the context otherwise requires:

"Act" means the Water and Soil Conservation Act 1967.

"Lake Tuakitoto" means the variable and more or less continuous body of water commonly known as Lake Tuakitoto, including Robson's Lagoon, situated at and about map reference NZMS260 H46:650370. The shoreline of the lake is defined as the variable extent of surface water, as it is observed at any particular time, whether of natural extent or whether restricted by any floodbank.

"Natural water" means natural water as defined in the Act.

3. Regionally significant features—It is hereby declared that Lake Tuakitoto provides for regionally significant recreational and wildlife habitat features.

4. Minimum lake level—The level of natural water in Lake Tuakitoto shall not be artificially lowered below 100.77 metres above datum on The Otago Regional Council gauge at the lake outlet during the period beginning 30 September in any year and ending 16 May in any following year.

5. Water rights and general authorisations—(1) Because of the regionally significant features declared in clause 3 of this notice, no water right shall be granted under section 21 of the Act, and no general authorisation shall be made under section 22 of the Act, if the effect of any such right or authorisation would be to have a significant detrimental effect on the regionally significant recreational and wildlife habitat features of Lake Tuakitoto, or if the effect of any such right or authorisation would be that the provisions of this notice cannot remain without change or variation:

Provided that the grant of water rights or the making of

general authorisations for or in connection with the drainage of land that is above 101.42 metres above datum on The Otago Regional Council gauge at the lake outlet shall not be prohibited.

(2) Nothing in this notice shall prevent the grant of water rights for the enhancement of wildlife habitats.

(3) Nothing in this notice shall prevent the renewal in substantially the same terms and conditions of any or all of the water rights or general authorisations affecting Lake Tuakitoto, current at the date of commencement of this notice.

6. Limit of notice—Nothing in this notice shall be construed as limiting the effect of the second proviso to Section 21 (1) of the Act relating to the taking or use of natural water for domestic needs, for the needs of animals, and for or in connection with fire fighting purposes.
