(4) In the waters known as:

- (a) Manganuiateao River (and its tributaries);
- (b) Retaruke River (and its tributaries);
- (c) Tokiahuru River (and its tributaries);

(d) Mangawhero River (and its tributaries) upstream from Kakatahi;

(e) Raetihi Hydro Dam;

The open season shall be from 1st of October in any year to 30th of June in the following year (both days inclusive).

(5) In the waters known as:

(a) Lake Rotorangi from the dam face to the Mangamingi ramp;

(b) Lake Ratapiko, except the inlet race as shown by signboards;

(c) Waitara River downstream from the Manganui River confluence;

(d) Waiwhakaiho River downstream from Rimu Street shown by signboards;

(e) Huatoki Stream downstream from Brois Street bridge;

(f) Stony (Hangatahua) River, Waiaua River, Mangahume River, Kaupokonui River Waingongoro River, all downstream from the State Highway No. 45 bridges;

(g) All waters south of the line from Patea to the Wanganui-Manganuioteao River confluence, to Kakatahi, and through Colliers Junction to the Boundary; the open season shall be from 1st of October in any year to the 30th of April in the following year (both days inclusive), then from the 10th of June of that following year to the 30th of September of that same year (both days inclusive).

(6) In the waters known as:

- (a) Lake Wiritoa;
- (b) Lake Pauri;

the open season shall be from the 1st of October in any year to the 12th of April in the following year (both days inclusive), and then from the 1st August to the 30th September of that year (both days inclusive).

4. Authorised Tackle-(1) No licence holder shall fish for,

take or attempt to take, any sports fish except by using a rod and running line.

(2) Notwithstanding subclause (1) of this clause, when landing a sports fish, a hand-held landing net may be used to secure or land any such fish;

(3) No licence holder shall, in fishing for sports fish, have in his control, more than one assembled rod, which shall be within 15 metres and under visual observation at all times.

(4) No licence holder shall use:---

(a) More than 2 lures or hooks.

(b) Any double or treble pointed hook, or any multiple hook assembly;

(c) Any gaff or landing hook;

(d) Any hook having a gape greater than 13mm, measured from the point of the hook to the nearest point of the shank;

(e) Any hand-line, stroke-hauling gear, spear gun, paravane, firearm, explosive, spear, net (excluding landing net), trap or any other unsportsmanlike device or gear;

(f) Any electric fishing gear, except as allowed by clause 26ZI of the Act;

(g) Any poison or any medicinal or chemical compound other than a preparation used solely to float or sink a fly or line.

5. Baits and lures—(1) No licence holder shall take sports fish unless he uses authorised baits and lures.

(2) Authorised baits and lures are:

(a) Natural and artificial; fly, insect, worm, and crustacea (excluding Koura);

(b) Artificial minnow;

(c) Fish but not any portion of fish, ova, or shellfish, provided that shellfish shell may be used in any artificial minnow.

(3) Artificial fly only shall be used at Lake Mangamahoe and Raetihi Hydro Dam.

(4) There shall be no restriction on the bait used by licence holders fishing for Perch in any pond or dam on privately owned land.

6. Minimum size to be taken—(1) No licence holder shall take, kill, or have in his possession any trout or salmon which is less than the length shown below, when measured from the tip of the nose to the notch of the tail.

(a) All waters south of the line from Patea to Wanganui-Manganuioteao River confluence to Kakatahi and through Colliers Junction to the Boundary - 20cm.

(b) All other waters: - 33cm.

(2) Every licence holder taking a sports fish which does not exceed the specified minimum length shall return it to the water immediately with the least possible injury.

7. Daily limit bag—(1) No licence holder shall on any one day take, kill or have in his possession more than 4 sportsfish of which no more than 2 shall be salmon.

(2) Where a licence holder has taken or killed 4 sportsfish in one day he shall forthwith cease fishing for the remainder of that day.

(3) Notwithstanding subclause (1) and (2) above there shall be no limit on the number of Perch taken or killed by a licence holder.

8. Virginia Lake (Wanganui)—Despite other rules in this notice, special rules apply to waters of Virginia Lake. The rules are:

(a) Only Junior licence holders may take fish;

- (b) Only 2 trout per day may be taken;
- (c) No fly casting;

(d) No fishing from the paved area in front (southeast side) of the lake.

9. Revocation—The notices published in the supplement to the *Gazette*, No. 151 of Thursday, 30th of August 1990, on pages 3209–3210 titled District Anglers (Taranaki Fish and Game Region) Notice 1990, are hereby revoked.

Specified waters: Those rivers and streams flowing into Lake Mahinerangi.

(d) Season: 1 December to 31 May

Specified waters: Lochy River: Timaru Creek: Von River and Lakes: (e) Season: 1 November to 31 May

- Specified waters: All rivers and streams flowing into all lakes in the Clutha River catchment upstream from the Clyde Dam and including the Upper Manorburn Dam NOT being waters specified in 3 (d) above.
- (f) Season: 1 October to 31 May
 - Specified waters: All other waters in the Clutha River catchment upstream from the Clyde Dam NOT specified elsewhere in clause 3.

(2) No person shall fish for, take or attempt to take, any sports fish except during an open season.

4. Closed season—(1) Fishing for sports fish is not permitted at any time in the following specified waters:

Careys Creek, within 100 metres of any part of the outer boundaries of Bartlett's salmon farm diversion structure:

Horne Creek, from Lake Wakatipu to source:

Lake Wanaka, within 150 metres of any part of the launch wharf at the township of Wanaka:

Lake Wakatipu, within the waters of Queenstown Bay bounded by a straight line drawn from the outermost point of the Tourist Park to the point where the south bank of One Mile Creek meets Lake Wakatipu:

Lake Wakatipu, within 100 metres of any part of the wharf in Black Bay (commonly known as the Walter Peak Jetty):

Mill Creek (which flows into Lake Hayes), from the Speargrass Flat Road bridge to the source:

Roxburgh Dam upstream of the posts marked "Fishing prohibited above this point" placed on each side of the Clutha River at the spillway from the Roxburgh power-house:

Waipori No. 3 Dam on the Waipori River adjacent to Waipori township:

All waters in which sports fish are held in captivity for display, hatching, or other purposes, or within a distance of 100 metres from any part of the outer boundaries of such waters

5. Authorised tackle-(1) Fishing for sports fish is not permitted except by using one rod and running line, provided that when playing a sports fish, a landing net or gaff may be used to secure or land any such fish.

(2) No person shall, when fishing for sports fish, use or be in control of, more than one assembled rod and running line at any one time.

(3) No person shall fish for sports fish unless within 15 metres of the rod being used, and with the rod under that person's visual observation.

6. Restriction on lures, baits and areas-(1) Subject to subclause (2), (3), (4), (5) and (6) of this clause, authorised lures and baits are: any natural or artificial: fly, worm, crustacean, frog, mouse, insect, minnow or fish (excluding fish ova or any portion of a fish or any shellfish mollusc, provided that the shell of any mollusc may be used in the preparation of an artificial minnow).

(2) No person when fishing for sports fish shall use-

(a) More than 2 lures or baits:

(b) Any bait or lure treated with any chemical preparation other than-

- (i) In the case of artificial fly, preparations used solely to give buoyancy to such flies: and
- (ii) In the case of natural baits, a formalin or other preservative preparation:

(c) On or in conjunction with any fly, minnow, or other lure, any single, double, or treble hook, any one hook of which has a greater distance than 13 mm between the point and the nearest part of the shank of the hook.

(d) In any waters in which only artificial fly is permitted, any wooden or plastic bubble with or without water, or weight other than the necessary weight of line to cast any artificial fly.

(3) No person when fishing for sports fish shall use any lure or bait other than natural or artificial fly in the following waters:

(a) Deans Bank, meaning that portion of the Clutha River lying downstream between a point indicated by a post landmark approximately 600 metres from the outlet of Lake Wanaka, and a point indicated by a landmark, approximately 600 metres above the bridge at Albert Town.

(b) All rivers and streams flowing into Lake Wakatipu, except the Dart River and the Rees River and their tributaries.

(c) Nevis River.

(4) Subject to subclause (5), no person when fishing for sports fish shall use any lure or bait other than artificial fly or lure in the Clutha River catchment upstream from the Clyde Dam:

(b) Lake Hayes and all streams flowing into or out of:

(6) All methods are permissible in all other waters within the region other than (3) and (4).

7. Prohibition on unauthorised fishing tackle, etc.-No person shall, when fishing for sports fish, use or be in possession or control of, or convey or cause to be conveyed to the vicinity of any place where that person is fishing or proposes to fish, any stroke-hauling or foul-hooking gear, or any spear.

8. Restrictions on use of boats-(1) No person shall fish from any boat in any of the following waters, unless the boat is securely anchored or otherwise secured, namely:

(a) That portion of the Clutha River upstream from the Clyde Dam, which terminates at the outlet launching ramp breakwater.

(b) Hawea River.

(2) No person shall fish from, or tow any lure from, any mechanically propelled boat on: Lake Dispute, Lake Hayes, Lake Johnson, Moke Lake or Reid Lake.

(3) No person shall fish from a boat on Lake Kilpatrick.

(4) Subject to subclause (5) of this clause, no person shall troll from a mechanically propelled boat within 100 metres of any person fishing from the shore.

(5) No person in fishing for sports fish shall troll from any boat in any river or stream except the Taieri River downstream from Henley Ferry bridge, and the Clutha River downstream from Balclutha.

9. Daily limit bag—(1) Except in the case of perch for which there is no daily limit, no person shall on any one day take and kill or be in possession of more than the prescribed daily limit from the following specified waters:

(b) In the case of salmon taken from the Water of Leith, 50 cm.

(c) In the case of trout or salmon taken from any other water, 25 cm.

(e) In the case of perch, no size limit.

(2) Every person taking a trout or salmon which does not exceed the specified length shall immediately return it with as little injury as possible into the water from which it was taken.

To: Neil David Cameron, Ian Campbell and Earl Hoffman, all of Tauranga:

1. Take notice that The Tauranga District Council proposes to take, under the Public Works Act 1981, your interest in the land described in the Schedule to this notice.

2. The land is required for a road and it is intended to use the land for part of the expressway to be constructed along the eastern foreshore of the Waikareao Estuary within the Tauranga Harbour, which expressway is commonly referred to as "Route P."

will be held unless you give written notice to the tribunal that you want the hearing to be held in private.

- 8. If you make an objection:
- a. You will be advised of the time and place of the hearing; and
- b. You will have the right to appear and be heard personally or to be represented by a barrister and solicitor or any other person you authorise.

9. This notice, and the right to object described above, relate to the taking of your interest in the land and not to your right to compensation. Under the Public Works Act 1981, you are entitled to full compensation, if your interest in the land is taken. If this compensation cannot be agreed between you and The Tauranga District Council, it can be determined in separate proceedings before the Land Valuation Tribunal.
