Dumping and Countervailing Duties Act 1988

Preliminary Determination: Dumping Investigation in Respect of Lead Acid Batteries from Indonesia, Korea, Malaysia, Singapore and Taiwan

Pursuant to section 12 (1) of the Dumping and Countervailing Duties Act 1988, I, Philip Burdon, Minister of Commerce, hereby give notice that I have made a preliminary determination on the basis of the information made available during the investigation that there is reasonable cause to believe that lead acid automotive batteries for the passenger motor vehicle battery market and marine applications, sourced from Indonesia, Korea, Malaysia, Singapore and Taiwan and imported or intended to be imported into New Zealand, are goods in respect of which I may direct the imposition of an anti-dumping duty in accordance with section 14 of the Dumping and Countervailing Duties Act 1988.

Pursuant to section 12 (3) of the Dumping and Countervailing Duties Act 1988, I hereby give notice of a provisional direction pursuant to section 16 (1) of the Dumping and Countervailing Duties Act 1988, that payment, in respect of the goods described above, of an anti-dumping duty at the rates shown in the Schedule, shall be secured by the Collector of Customs in accordance with Part IX of the Customs Act 1966 on those goods entered for home consumption on or after 10 September 1991.

Termination of Dumping Investigation

Pursuant to section 11 (1) of the Dumping and Countervailing Duties Act 1988, the Secretary of Commerce hereby gives notice of the termination of the dumping investigation in respect of a dumping complaint lodged by the New Zealand lead acid battery industry against imports of lead acid batteries from Thailand, as described in the Notice of Initiation of Dumping Investigation of 14 June 1991.

The Secretary is satisfied as a result of investigations carried out, that the goods from Thailand which were under investigation, being lead acid batteries imported from Anachai-Kobe Battery Co Limited (Thailand) and SCT Company Limited, are not goods in respect of which a determination may be made under the Dumping and Countervailing Duties Act 1988 for the reason that these goods are no longer imported into New Zealand. There is therefore no evidence that material injury has been or is being caused or threatened as a result of the importation from Thailand of the goods subject to the investigation.

Traffic Regulations 1976

Temporary Exemption from the Seatbelt Requirements for Specified Class of Motor Vehicles

Pursuant to regulation 90, subclause (1) of the Traffic Regulations 1976, and subject to the conditions in the attached Schedule, the Secretary for Transport hereby exempts the class of motor vehicles specified below from the requirements of regulation 78A of the Traffic Regulations 1976. This notice shall come into effect on 1 October 1991 and expire on 1 April 1992.

Specified Class

The specified class of motor vehicles is: "All motor vehicles first registered in New Zealand from 1 November 1979 to 30 September 1990 inclusive, which are fitted with seatbelts which do not comply with any standard approved for the use of seatbelts in New Zealand."

Schedule of Conditions

1. Seatbelts are fitted to all seating positions which are required to have a seatbelt, whether those seatbelts comply with any approved standard or not.
2. Any non-complying seatbelt that is fitted is in a good condition for its intended purpose, and any retractor mechanism that is fitted operates smoothly and consistently.
3. The Warrant of Fitness authority has completed a duplicate inspection sheet which identifies the seatbelt problems. One copy is to be held by the Warrant of Fitness authority with the

upper part of the form MOT VS23891. The second copy of the inspection sheet and lower part of form MOT VS23891, must be given to the person who has brought the vehicle in for inspection.

4. From 1 April 1992, all motor vehicles of the specified class must be fitted with seatbelts which meet the full requirements of the regulations, unless the particular vehicle has been given a permanent exemption.

5. Any purchaser of a vehicle in the specified class must be advised of the problem with the seatbelts, and of the need to replace them with approved seatbelts.

6. This temporary exemption does not affect any rights of legal redress. In particular rights under the Motor Vehicle Dealers Act 1975 are not affected, so that for the purposes of section 93 (2) (a) of that Act a Warrant of Fitness issued under this *Gazette* notice is not a properly issued Warrant of Fitness.

Approval of Revolving/Flashing Amber Lights for Certain Vehicles

Pursuant to regulation 67 (8) of the Traffic Regulations 1976, and a delegation from the Secretary for Transport, I, Carne Maurice Clissold, Controller Road and Traffic Standards, approve the fitting and use of one revolving or flashing amber light on any fork lift vehicle owned or operated by Wrightson Wool at Invercargill. This approval is given subject to the following conditions:

1. The vehicle shall be painted a conspicuous colour.
2. The light shall be used while slow moving or parked and unable to avoid creating a hazard in the performance of its duties.
3. The light shall be placed in such a position on the vehicle so as to ensure maximum visibility to other road users.
4. Compliances with any conditions imposed by a traffic officer.
5. All other requirements of the Traffic Regulations 1976 and Heavy Motor Vehicle Regulations 1974, including licencing and registration shall be met.
6. Maximum length of journey and return shall not exceed 5.0 kilometres.

New Zealand Game Industry Board

Game Industry Board Regulations 1985

Game Industry Levy

Pursuant to regulation 17 (3) of the Game Industry Board Regulations 1985, notice is given that the Game Industry Board hereby fixes the rate of game industry levy (which levy rates are exclusive of goods and services tax imposed by the Goods and Services Tax Act 1985) as follows:

- (a) On each deer slaughtered in deer slaughtering premises, 28 cents per kilogram hot clean carcass weight after removal of condemned parts;
- (b) On each killed game deer carcass received at a game packing house, zero cents per kilogram cold clean carcass weight after removal of condemned parts;
- (c) On each piece of antler from fallow deer received at a game packing house for processing or packing 100 cents per kilogram green weight; and
- (d) On each piece of antler from deer other than fallow deer received at a game packing house for processing or packing, 450 cents per kilogram green weight.

The levies on antler will be payable on all antler but may be rebated by the Board in the case of hard antler sold through designated pools where it is assessed by accredited graders.

A nil rate of levy will apply to any farmed deer or killed game deer carcasses which are wholly condemned for any reason following slaughter or receipt in to a game packing house.

No levy shall be payable in respect of any one farmed deer carcass or killed game deer carcass or piece of antler more than once.

These rates of levy will come into effect from and inclusive of the 1st day of October 1991 and apply during the 1991-92 game season and subsequently until such time as new levy rates are fixed and come into force.

Pursuant to regulation 17A (1) notice is given that the Game Industry Board hereby fixes the rate of additional levy payable in respect of failure to pay, or late payment of, amounts of Board levy payable on or after the 1st day of October 1991 at 10 percent of the amount of levy unpaid.

This additional levy for failure to pay or late payment may be

applied by the Board at a rate of 10 per cent on the outstanding balance following expiration of the period within which payment is required to be received by the Board, and shall be payable by the proprietor of the deer slaughtering premises or game packing house concerned.

(b) To relieve traffic pressure on the existing Kennedy Road access to and from the central business district and to improve safety by reducing traffic and pedestrian conflict.
