Public Finance Act 1959

Notice of Guarantee Under Section 59 (2) of the Public Finance Act 1989

On 28 March 1991, I gave 3 guarantees pursuant to section 59 of the Public Finance Act 1959, in favour of the lenders listed below, being subsidiary companies of the Board of Trustees of the National Provident Fund (the "Fund").
