- (iv) to do things conducive to the attainment of the above objects.

2. New Powers of Trustees

Trustees are given expanded powers:

- (i) the powers and discretions conferred on trustees under the Trustee Act 1956;
- (ii) to raise money by all lawful means;
- (iii) to operate separate trust accounts;
- (iv) to enter into co-operation and joint venture arrangements which promote the charitable objects of the trust;
- (v) to hold shares;
- (vi) to affiliate with like organisations.
- 3. Reconstitution of Board of Trustees

Amongst other things, the scheme envisages a board of up to 13 members and provides for appointment and removal of trustees, election of trustees, casual vacancies, terms of office generally of 4 years, regulates meetings of the board of trustees, regulates payment of trustees' expenses.

Provision is made limiting duty of care of trustees to that of a prudent person of business, for the purposes of section 14 (c) of the Trustee Act 1956. Trustees have specific power to negative personal liability in transacting on behalf of the trust.

The scheme allows the board to amend the trust deed by special resolution provided the charitable purposes of the trust are not affected and provides for disposal of surplus assets upon winding up.

Any person who wishes to oppose the scheme is required to give written notice of such intention to the Registrar of the

Court and the applicant and the Attorney-General not less than 7 clear days before the date stated above.
