1. TELEPHONE SERVICES

1.1 Direct-Dial-In (DDI) Service

The maximum number of DDI numbers on any trunk group between a Telecom switch and a customer network is limited to 2,000.

2.2 Promotional Calls

2.2.1 National Calls

There were four national call promotions during the quarter. The following conditions applied:

This Promotion was available to:

Those customers, with Telecom Residential and Non Residential Contracts, who
made Direct Dial National calls and calls which had to be placed by an operator.

Promotion was not available in the following cases:

- Price required calls including Permanent, Self-dialled, Operator assisted Price Required.
- Any call involving operator intervention e.g. calling card, transfer charge, extension identification service and collect calls.
- Networks other than Telecom Regional Operating Company Public Switched Telephone Networks.

The dates and prices for these national call promotions were:

- 9th and 10th of November 1991: 15¢ maximum per minute inclusive of GST.

- 23rd and 24th of November 1991: 15¢ maximum per minute inclusive of GST.

14th and 15th of December 1991: 50% of economy and night rates.

- 17th and 18th of December 1991: 2 minutes free after the first five minutes of

calling time.

2.2.2 International Calls

5th and 6th of October 1991: World Cup Rugby Special. Calls to UK \$1.84 per minute (40% off the Standard Rate).

12th to 23rd of December 1991: Western Samoa Special (Cyclone Val). Calls to Western Samoa, Economy Rate applied all day.

21st to 22nd December 1991: Christmas Special to the World. 50% off the appropriate Standard Rate for every country. Calls to Western Samoa were charged at 50% of the Economy Rate.

31 December 1991 - 50% off the Standard Rate on International toll calls to Australia and UK. The special conditions listed above for national calls applied also to these promotions.

3. NATIONAL LEASED CIRCUITS

3.1 Chatham Islands Data Service

The Chatham Islands Data Service is an analogue leased circuit service available only between the Chatham Islands and the New Zealand mainland.

Services available are three analogue/data-type services of 300 bit/s, 1200 bit/s and 2400 bit/s, and telegraph services at three speeds (50 baud, 75 baud and 100 baud). The services are known as A300, A1200 and A2400 and T50, T75 and T100 respectively (corresponding to the speeds available).

The New Zealand mainland termination point for the Chatham Islands link is Christchurch; circuits beyond Christchurch incur an additional transmission charge.

Multipoint options are not available for these services. All services offered are subject to the limitations of the statistical multiplexor and the satellite transmission system, and are dependent on meteorological conditions for availability.

Installation

Installation charges in the Chatham Islands will be based on actual costs (time and materials). Other installations will be charged the Analogue Data Services (A2) prices applying at the time of installation.

Access

Access charges cover both modem rental and access to the exchange at one end.

Access per end per month:

•	A300, A1200 and A2400	\$180.00
•	T50. T75 and T100	\$180.00

Note:

There are no distance surcharges for these services.

Transmission

Transmission charges for the link between Chatham Islands and Christchurch per month:

•	A300	\$500.00
•	A1200	\$600.00
•	A2400	\$900.00
•	T50, T75 and T100	\$500.00

Transmission charges for the link between Christchurch and the customer site per month:

Charges for all services are the same as the Analogue Data Service (A1 and A2) transmission charges.

Note:

Junction surcharges will apply where access is required between exchanges within a local calling area at the New Zealand end.

Other Charges

Alterations and all other charges will be based on time and materials associated with the work involved.

3.2 Megalink Service

3.2.1 Monthly Access Charges

 Monthly charge for the Megalink service delivery point at a customer's premises \$500.00 (This is a fixed charge regardless of the quantity and number of links ending at the service delivery point)

3.2.2 Monthly Transmission Charges

Where both ends of a Megalink circuit terminate off the same exchange, there are no transmission charges. For this purpose, Airedale Street and Mayoral Drive exchanges in Auckland, Wellington and Courtenay Place exchanges in Wellington, and Riccarton and Christchurch exchanges in Christchurch are treated as one exchange.

3.3 Digital Leased-Circuit Services

3.3.1 Digital Data Service (DDS)

Digital Data Service is available at speeds of 2.4 kbit/s, 4.8 kbit/s, 9.6 kbit/s, 19.2 kbits/s, 48 kbit/s, 64 kbit/s and 128 kbit/s digital. An analogue access option is available at speeds of 2.4 kbit/s, 4.8 kbit/s and 9.6 kbit/s. The analogue access service is provided to allow connection to the Digital Data Service, beyond the normal range of the digital network.

Note:

Initial availability of 19.2 kbit/s, 64 kbit/s and 128 kbit/s service may be restricted.

3.3.2 Installation Charges

5. DISCOUNTS

5.1 International Leased Circuits

5.1.1 Discounts

The following discounts were allowed in each case due to the high capacity requirements of the customer, the commitment to maintain the capacity for the length of the contract, and in anticipation of new tariffs from 1 January 1992.

A customer was allowed a 54.61% discount on a 320Kbit/s TASTREAM service. In addition to the above conditions, this discount was allowed because of the requirement for diversity, and a commitment by the customer to upgrade to greater capacity at a later date.

A customer was allowed a 51.74% discount on a 192Kbit/s TASTREAM service. In addition to the above conditions, this discount was allowed because of the requirement for diversity and the requirement for Auckland and Wellington terminations.

A customer was allowed a 11.9% discount on a 48Kbit/s SKYSTREAM service.

A customer was allowed a 33.1% discount on a 128Kbit/s TASTREAM service.

A customer was allowed a 20.9% discount on 2x64Kbit/s SKYSTREAM service, and up to a10% discount on a 9.6Kbit/s SKYSTREAM service.

A customer was allowed a 11.7% discount on a 256 Kbit/s SKYSTREAM service, and up to a10% discount on a 9.6Kbit/s SKYSTREAM service.

A customer was allowed a 23.4% discount on a 128Kbit/s SKYSTREAM service, a 36.1% discount on a 128Kbit/s TASTREAM service, and a 38.4% discount on a 64Kbit/s TASTREAM service.

A customer was allowed a 10.07% discount on a 64Kbit/s SKYSTREAM service.

5.1.2 "Great Mates-Special Rates"

This was a promotional campaign for trans-Tasman services. For a limited period, TASMAN 1 cable capacity between Australia and New Zealand was allowed at reduced prices, for new circuits, under term contracts of two or more years.

This offer provided an end to end trans-Tasman service between the Central Business Districts (CBD) in Auckland and Wellington, and Sydney and Melbourne. Pricing is fixed for 2 years.

Terms

The terms of the offer were as follows:

- 1. Targeted at new Bitstream/Tastream circuits only.
- 2. From 2.4-384 Kbit/s only (excluding 320 Kbit/s).
- 3. Minimum 2 year term contract.
- 4. Contracts had to be signed during the quarter.
- Capacity available on a first come, first served basis.
- 6. Customer requested RFS date had to be prior to 1 March 1992.
- 7. Standard provisioning times applied.
- 8. The customer has the option to request upgrade to TASMAN 2 when this capacity becomes available at no extra recurring or establishment cost. Upgrades will take place within the appropriate standard service provisioning and upgrade times.
- 9. Prices fixed for the term of the contract, and exchange rate fixed for 2 years and reviewed annually thereafter for longer contract terms.

5.1.3 Great Mates Special Rates Customised Service

Two "Great Mates Special Rates" customers were allowed a discount of up to 5% on the 64Kbit/s TASTREAM service. This discount was allowed due to the commitment by the customers to a longer than normal contract period.

5.2 National Leased Circuits

Pursuant to an agreement with a customer, Telecom provided an A2 analogue circuit and CPE equipment. A discount of 31% was allowed in relation to the aggregate price of all circuits. The CPE equipment had depreciated due to prior use.

Pursuant to an agreement with a customer, Telecom provided services including leased circuits, facilities management and CPE equipment. A discount of 10.4% was allowed due to the unique needs of the customer, and the substantial commercial relationship the customer has with Telecom.

A customer was allowed a 30.10% discount on the provision of an A2 analogue data circuit. This discount was allowed in order to recognize and maintain the substantial commercial relationship with the customer.

The discounts published herein may be provided to customers in addition to other discounts already published.
