Government**Summary of Bills Introduced***Civil Aviation Amendment Bill (No. 2)*

The bill establishes a stand alone Civil Aviation Authority and amends the Civil Aviation Act 1990 and certain other Acts. It repeals various sections of the principal Act and transfers the appropriate functions to the Civil Aviation Authority. These include the appointment of a Director of Civil Aviation Safety and granting the Director the power to impose conditions on the operation of aircraft or use of aeronautical products to prevent danger to persons or property. The principal Act is also amended with respect to the ability to impose levies, the sole purpose of which is to make up a shortfall in the funds of the Authority. In addition to civil aviation offence provisions, miscellaneous amendments to the principal Act include the removal of Airways Corporation's monopoly rights over area control services, approach control services and flight information services.

*Local Government (Regional Council Vacancies) Bill*

The bill empowers regional councils to determine by resolution that any extraordinary vacancy in their membership that occurs within 7 months before 10 October 1992 (being the date fixed for the next triennial general election) shall not be filled.

Sections 101zC and 707E of the Local Government Act 1974 confer a similar power, but that power may be exercised only in respect of extraordinary vacancies that occur within the 6 months before the triennial general election.

*Crown Research Institutes Bill*

The bill provides for the formation of Crown-owned companies known as Crown Research Institutes. The purpose of the companies is to undertake scientific research and to provide related services. The companies will take over the responsibilities currently performed by the various divisions of the Department of Scientific and Industrial Research, the Technology Division of the Ministry of Agriculture and Fisheries, the Forest Research Institute, and the Meteorological Service.

The structure of the Crown Research Institutes is based on the model contained in the State-Owned Enterprises Act 1986. For the purposes of establishing Crown Research Institutes, the Minister of Finance and the Minister for Crown Research Institutes are empowered to form and register under the Companies Act 1955 private companies limited by shares and to subscribe for shares in those companies. Those shares are to be held in equal shares by those Ministers. The bill also follows the State-Owned Enterprises Act 1986 model in providing for the transfer of assets and liabilities of the Crown to Crown Research Institutes.

The timetable set out in the bill for the establishment of Crown Research Institutes and the transfer of Crown assets and liabilities to them envisages that the institutes will be set up soon after 15 June 1992 and that they will be operational by 1 July 1992. On that latter date the Department of Scientific and Industrial Research will be disestablished with the repeal, by the bill, of the Scientific and Industrial Research Act 1974.

*Regulations (Miscellaneous Provisions) Bill*

The bill makes miscellaneous amendments to three Acts, the Acts and Regulations Publication Act 1989, the Legal Services Act 1991, and the Regulations (Disallowance) Act 1989.

*Marine Farming Amendment Bill*

The purpose of the bill is to enable applications that had been received under section 13 of the Marine Farming Act 1971, and which had been subsequently repealed by the Resource Management Act 1991, that sought either an extension of the term of the lease or licence or that validated (ineffectually) extensions that had been granted and registered after a lease or licence had expired, to be dealt with as if that section were still in force.

### Dumping and Countervailing Duties Act 1988

#### Initiation of Dumping Investigation: Certain Non-Leather Women's Footwear from China

Notice is hereby given that I, Alexander Hugh McPhail, Manager, Trade Remedies Group, Ministry of Commerce, acting pursuant to section 10 (1) of the Dumping and Countervailing Duties Act 1988, and under delegated authority from the Secretary of Commerce, have initiated an investigation to determine both the existence and effect of alleged dumping of the goods listed in the Schedule to this notice, being satisfied that sufficient evidence has been provided that:

- (a) The goods imported or intended to be imported into New Zealand are being dumped; and
- (b) By reason thereof material injury to an industry has been or is being caused, or is threatened.

#### Schedule

##### Country of Origin:

People's Republic of China.

##### Description of Goods Subject to Investigation:

Women's footwear with outer soles and uppers of "rubber or plastic" but excluding:

- Women's and girls shoes size 4 and below;
- Waterproof footwear;
- Sports footwear;
- Footwear with upper straps or thongs assembled to the sole by means of plugs;
- Footwear covering the ankle;
- Footwear incorporating a protective metal toe cap;
- Footwear with outer soles and uppers moulded in one piece from PVC or another plastic material or from rubber;
- Slippers.

\*The expression "rubber or plastic" includes any textile material visibly coated or covered externally with one or both of those materials.

The goods are currently classified under Tariff Item and Statistical Key 6402.99.19.09F of the Tariff of New Zealand, which classification is provided for convenience and Customs purposes only, the written description being dispositive.

### Electricity Act 1968

#### Standards for Medical Electrical Safety

This is to advise persons having an interest in electrical safety requirements for medical electrical equipment that the office of the Chief Electrical Inspector of the Ministry of Commerce is intending to adopt joint Australian/New Zealand Standards to set the safety requirements, pursuant to the Electricity Act 1968.

These standards are currently being drafted in Australia based on the *International Electrotechnical Commission Standards* for various types of medical electrical equipment by committees incorporating New Zealand representation.

Persons having an interest in the adoption of these standards are requested to register their interest with the Chief Electrical Inspectors Office.

The Chief Electrical Inspectors Office will be co-ordinating with the Standards Association of New Zealand and Standards Australia to ensure that where possible the draft standard will be available for consideration prior to promulgation to allow the introduction of variations to the International Documents.

Where variations cannot be incorporated into the text to produce joint standards, it is proposed that the variations will become part of the New Zealand Code of Practice for Electrical Safety of Apparatus and Material 1991 (NZECP: 3 1991).

The Chief Electrical Inspectors Office will endeavour to ensure that parties which have registered their interest are kept informed of progress during this work.

The formal opportunity to comment on the introduction of these standards will be available through the public comment process associated with proposed amendments to The New Zealand Code of Practice for Electrical Safety of Apparatus and Materials 1991 (NZECP: 3 1991).

Persons are further advised that both Standards Association of New Zealand and the Chief Electrical Inspectors Office have a common advisory committee on this topic. Information regarding membership of this committee for the drafting of those standards, which represents the interests of industry groups, is available from Standards Association of New Zealand or the Chief Electrical Inspectors Office.

### Social Security Act 1964

#### Direction to Director-General of Social Welfare

In the matter of section 5 (2) of the Social Security Act 1964.

To: The Director-General of Social Welfare.

I, Jennifer Mary Shipley, Minister of Social Welfare, hereby give you the following direction, pursuant to section 5 (2) of the Social Security Act 1964 ("the Act"):

1. This direction applies to any person applying for the 55 plus benefit under section 58 of the Act who—

- (a) Was aged 55 years or more on 1 April 1992; and
- (b) Was employed on 1 April 1992 under an employment contract (within the meaning of the Employment Contracts Act 1991) in writing which specified an age at which that person was required to retire; and
- (c) Pursuant to the section 15C of the Human Rights Commission Act 1977, agreed with his or her employer in writing on or after 1 April 1992 to confirm or vary the age specified in the employment contract.

2. Where a person to whom this direction applies retired, or was required to retire, on or about the age confirmed or varied by the agreement with the employer, and that age is less than the age at which the person becomes entitled to national superannuation under section 3 of the Social Welfare (Transitional Provisions) Act 1990, you shall not consider the person to be voluntarily unemployed without a good and sufficient reason if the agreement with the employer to confirm or vary the age was reached for good reason.

3. For the purposes of this direction, you shall accept as good reason for confirming a retiring age, or for varying a retiring age to a date after the age specified in the employment contract, that the employment relationship and the retiring age, in respect of the person, had been in effect for not less than 5 years, and both parties considered that their existing retirement arrangements should continue to apply.

4. You shall not accept an agreement to vary a retiring age to an age earlier than that specified in the employment contract as having been reached for good reason unless for good reason based upon the person's health or fitness to continue performing the work for which he or she was employed under the employment contract.
