The Traffic (Thames Coromandel District) Notice No. 1 1992

Pursuant to the Transport Act 1962, the Minister of Transport hereby gives the following notice:

This notice may be cited as the Traffic (Thames Coromandel District) Notice No. 1 1992.

The area and roads specified in the First Schedule are declared to be closely populated localities for the purposes of section 52 of the Transport Act 1962.

The roads specified in the Second Schedule are declared to be 70 kilometres an hour speed limit areas, pursuant to regulation 21 (2) of the Traffic Regulations 1976.

Maramarahi Road: From No. 25 State Highway (Waitakaruru to Waihi via Coromandel) to a point 300 metres measured easterly, generally, along the said road from the said State highway.
