#### Dumping and Countervailing Duties Act 1988

**Notice of Amendment to Notice of Preliminary Determination: Dumping Investigation in Respect of Certain Men's Footwear from China, Indonesia, Korea, Taiwan and Thailand**

#### Notice

**1. Title**—(1) This notice may be cited as the Preliminary Determination: Dumping Investigation (Certain Men's Footwear from China, Indonesia, Korea, Taiwan and Thailand), Amendment No. 1 and shall be read with and be part of the notice entitled "Preliminary Determination: Dumping Investigation in Respect of Certain Men's Footwear from China, Indonesia, Korea, Taiwan and Thailand", dated 15 June 1992, and published in the *Gazette* of 18 June 1992 at page 2049, (in this notice referred to as "the principal notice").

(2) This notice shall take effect from 13 August 1992.

**2. Schedule to the Principle Notice Substituted**—The principal notice is hereby amended by omitting the Schedule and substituting the new Schedule set out in the Schedule to this notice.

##### "Schedule

*Country of Origin: China, Indonesia, Korea, Taiwan and Thailand*

*Description of Goods Subject to Investigation: Men's shoes (including unisex shoes), including sports casual shoes but excluding the following categories:*

- Men's and boy's shoes, size 4 and below.
- Sports footwear;
  - (a) footwear which is designed for a sporting activity and has, or has provision for the attachment of spikes, sprigs, stops, clips, bars or the like;
  - (b) skating boots, ski boots and cross-country ski footwear, wrestling boots, boxing boots and cycling shoes.
- Slippers.
- Footwear with upper straps or thongs assembled to the sole by means of plugs.
- Footwear incorporating a protective metal toe cap.
- Footwear with outer soles of leather.
- Footwear made on a base or platform of wood.
- Footwear containing woolskin.
- Thong type products.
- Industrial safety toe type.
- Waterproof footwear with outer soles and uppers of

rubber or of plastics, the uppers of which are neither fixed to the sole nor assembled by stitching, riveting, nailing, screwing, plugging or similar processes.

### **Amount of Provisional Anti-Dumping Duty**

### **Explanatory Note:**

This note is not part of the notice but is intended to explain the reason for the amendment.

In the course of the investigation it was found that the operation of Rule 3 of the General Rules for the Interpretation of the Harmonized System meant that unisex footwear is classifiable as women's footwear. The investigation covers footwear which is unisex footwear so in order to ensure that such footwear is subject to the provisional duty imposed by the principal notice, this amendment makes it clear that unisex footwear which otherwise comes within the description of the goods described in the Schedule is subject to provisional duties.

(2) This notice shall come into force on the 28th day after the date of its publication in the *Gazette*.

**2. Interpretation**—In this notice unless the context otherwise requires—

"Institution" has the same meaning as stated in section 159 of the Education Act 1989.

**3. Certain persons to be treated as if they are not foreign students**—For the purposes of Parts XIII to XXIV of the Education Act 1989, and the Thirteenth to the Eighteenth Schedules to that Act, persons of the following class or description of persons are required to be treated as if they are not foreign students:

(a) Persons who are in New Zealand to study under an exchange scheme approved by the Government; and

(b) Persons who are in New Zealand to study under an exchange scheme approved by the Council of the institution at which the person is, or is to be, enrolled.

(a) Foreign students studying in New Zealand under an exchange programme approved by the New Zealand Government;

(b) Foreign students who are dependent children of any person who is the holder of an unexpired work permit granted under the Immigration Act 1987;

(c) Foreign students who:

(i) Were enrolled at a registered school in New Zealand before the 1st day of January 1989; and

(ii) Have been continuously enrolled at one or more such schools since that day; and

(iii) Meet the requirements of the Immigration Act 1987 for undertaking a course of study in New Zealand;

(d) Foreign students who are dependent children of any person who, during the current calendar year, last ceased to be exempt, pursuant to section 11 (1) (a) of the Immigration Act 1987, from the requirement to hold a permit under that Act;

(e) Foreign students who are dependent children of students studying in New Zealand under an exchange programme approved by the New Zealand Government.

**4. Revocation**—This notice revokes and replaces the Education (Foreign Students School Fees Exemptions) Notice 1990, published in the *Gazette* of 15 February 1990 (No. 23, page 450).

#### Trustees' Report for the Period Ended 31 March 1992

**Objectives of the Trust:** The trust's objectives are to provide financial assistance to organisations carrying on charitable, cultural, philanthropic and recreational work which is of benefit to the community, principally in the regions of South Canterbury and Mid-Canterbury.

**Policies and Structures of the Trust:** All purposes of the trust are deemed to be charitable. In general guidelines for donations are as follows:

1. Organisations which provide services for those who have been denied a quality of life enjoyed by the majority.
2. Community organisations which offer their services for the benefit or enjoyment of the public and contribute to community well being.
3. Groups which give their time and resources to helping social problems.



So that the trust will reach as many people as possible the trust will make donations under the following broad categories:

- (a) *Community Support*—including health services and care of senior citizens, infants and children.  
 (b) *Welfare and Social Services*—including services for the physically and intellectually handicapped.

The above two categories will take priority. When funds permit, applications will be accepted from youth, educational, cultural and philanthropic organisations.

The community trust comprises thirteen trustees who are representative of South Canterbury and Mid-Canterbury communities. Trustees are appointed by the Minister of Finance and reside in either Mid-Canterbury or South Canterbury. Trustees retire by rotation and during the past year the terms of office expired on 31 May 1991 for Mrs C. D. Bach, the Hon. Mrs J. Shipley, M.P., Messrs A. H. Carlton and D. B. Timpany. The Hon. Mrs J. Shipley, M.P., relinquished her role as trustee due to the pressure of other commitments. Mrs C. D. Bach was not reappointed and Messrs A. M. Carlton and D. B. Timpany were reappointed for a further term. The Minister also appointed Messrs R. B. McCully and R. J. Underdown to replace Mrs C. D. Bach and the Hon. Mrs J. Shipley, M.P.

*Activities of the Trust:* The trust met five times during the financial year pursuing the objects of the trust for the benefit of the areas we represent.

A number of our trustees attended a meeting in Christchurch in August where representatives of all Trust Bank Community Trusts had the opportunity to discuss common objectives and problems.

When the collective views of the shareholders of Trust Bank New Zealand Limited have been required, this trust has been represented by its chairperson, and when necessary by another trustee.

The specific policy guidelines for qualification for the granting of donations having been published gave groups the opportunity to decide whether an application for assistance was likely to be acceptable.

*Review of Results and Financial Position of Trust:* The main income of the trust was received by way of dividends from Trust Bank New Zealand Limited. Together with investment interest the total income for the year was \$282,969. Donations distributed totalled \$85,500 and after deducting expenditure a nett profit of \$177,491 was transferred to the trust fund.

*General:* In common with other Trust Bank Community Trusts it was agreed an independent secretary to the trust should be obtained, and Mr K. A. Churcher was appointed to this position from 1 February 1992.

We are grateful to Mr P. Mason who has been secretary since the formation of the trust for his valuable assistance in this position.

We shall, of course, continue to work closely with the local South Canterbury Trust Bank, and we look forward to our investment bringing benefit to worthwhile organisations in Mid and South Canterbury.

**Report of Chairman for the Year Ended 31 March 1992**

This is the fourth annual report of the Trust Bank Wellington Community Trust.

*Personnel:* Three new trustees were appointed by the Minister of Finance; Mr T. J. McGuinness of Paraparaumu, Mr G. Reeves, M.P. for Miramar and Mr N. Ryder-Lewis of Lower Hutt. Ms E. Tennet, M.P. for Island Bay was reappointed, but Mrs Whetu Tirikatene-Sullivan retired.

*Objective:* The trust remains committed to providing beneficial support for cultural, charitable, philanthropic and recreational organisations and groups in the Wellington community. This support is achieved with the assistance and involvement of Trust Bank Wellington Limited.

The trust operates under predetermined guidelines for the distribution of grants to community organisations and groups. For the 1991 year 512 applications were received seeking over \$5 million.

After careful consideration grants totalling \$309,214 were made to 190 local groups and organisations. The average grant was about \$1,600. The grants represent roughly 85 percent of the dividends received from Trust Bank New Zealand for the year ending 31 March 1992. A distinctive feature of this year's grants was the sum of \$50,000 awarded to Capital Discovery Place, a "hands on" science museum principally for children. It is the first such purpose built museum in New Zealand, though there are several in overseas countries. The community trust's grant is additional to a grant of \$30,000 made last year for the fitting out of the building and it absorbed the whole allocation for kindergartens, schools, playcentres and the like, which are or ought to be principally Government funded.

It was felt that the Capital Discovery Place had many facets for education, instruction and simple enjoyment and that the community trust should associate itself with its development. The grant is for 1991 only and the normal distribution will continue this year.

It is obvious that the community trust could usefully make much larger grants if funds permitted. For example, a number of excellent sponsorship opportunities to help community activities had to be foregone for lack of funds. The trust has to be chary of commitments involving regular annual or periodic payments. The trust hopes that the Trust Bank Group will continue to make expanding profits.

As the trust's income increases over time, the trust and Trust Bank Wellington expect wider opportunities for financial assistance to community groups and organisations in our region.

*Investments:* The trust's main investments remain in shares of Trust Bank New Zealand Limited. The trust's income is derived from the dividend paid by Trust Bank New Zealand Limited on these shares.

*Appreciation:* I record my appreciation to the trustees and Trust Bank Wellington for their continued commitment and support to our objectives.

This report reflects our third year of activities and I am convinced that this community trust will play an increasing role in the future development of Trust Bank Wellington and the Wellington community.
