# DISTRICT ANGLERS FISH AND GAME REGION NOTICES

#### District Anglers (Auckland/Waikato Fish and Game Region) Notice 1992

Pursuant to section 26R (3) of the Conservation Act 1987 (as amended by section 17 of the Conservation Law Reform Act 1990), the Auckland/Waikato Fish and Game Council hereby gives the following District Anglers Notice.

#### Notice

- 1. Title and commencement—This notice may be cited as the District Anglers (Auckland/Waikato Fish and Game Region) Notice 1992 and shall come into force on the 1st day of October, 1992.
- 2. Interpretation—Words and expressions in this notice which are defined in the Conservation Act 1987 or the Freshwater Fisheries Regulations 1983 shall have the meaning so defined.
- 3. Open Season—(1) There shall be an open season for fishing for sports fish from the 1st day of October in any year to the 30th day of September in the following year (both days inclusive) in the following waters—
  - (i) All lakes within the Auckland/Waikato Fish and Game Region;
  - (ii) The Wairoa River;
  - (iii) The Waihou River and its tributary, the Waimakariri Stream;
  - (iv) The Maratoto Stream, from the ford on the old Whangamata track (also known locally as the Wires Track) near the junction with the Hamuti Stream, to its confluence with the Waihou River;
  - (v) The Ohinemuri River, from the concrete bridge (known as the Victoria Street bridge on the boundary of the Waihi township) to its confluence with the Waihou River:
  - (vi) The Waitawheta Stream, from the upstream end of the public vehicle access on Franklin Road (as shown by a signpost) to its confluence with the Ohinemuri River;
  - (vii) The Waikato River;
  - (viii) The Waipa River downstream from Toa Bridge (some 16km upstream from Otorohanga) to its confluence with the Waikato River;
  - (ix) The Puniu River downstream from the Seafund Road bridge to its confluence with the Waipa River;
  - (x) The Mangawhio River between the Waikato River and the falls:
  - (xi) The Marokopa River from its junction with the Mangatuahaua Stream to its mouth;
  - (xii) The Mangaotaki River from the lower bridge (as shown by a signpost) on the Mangaotaki Road (Pio Pio), to its confluence with the Mokau River;
  - (xiii) The Wanganui River, downstream from its confluence with the Whakapapa River.
- (2) In respect to all other waters within the Auckland/Waikato Fish & Game Council region, except those specified in clauses 3(1) and 4 of this notice, there shall be an open season for fishing of sports fish from the 1st day of October in any year to the 30th day of June in the following year (both days inclusive).
- 4. Fishing in closed season prohibited—There shall be a closed season for fishing for sports fish from the 1st day of October in any year to the 30th day of September in the following year (both days inclusive) in all rivers, streams and their tributaries which flow into but not including Lake Arapuni, Lake Waipapa, Lake Karapiro and that part of the Waikato River downstream from the Maraetai Dam to above the Karapiro Dam, but does not include the following waters—

- (i) Waipapa River and tributaries;
- (ii) Mangawhio stream and tributaries;
- (iii) Waipa stream and tributaries;
- (iv) Pokaiwhenua stream and tributaries;
- (v) Waikato River.
- 5. Restrictions on methods of fishing—(1) No licence holder shall fish for, take or attempt to take, any sports fish except by using a rod and running line except a roach pole which may be used to fish for and take perch, tench and rudd.
- (2) Notwithstanding subclause (1) of this clause—
- (a) When playing a sports fish a landing net may be used to secure or land any such fish;
- (b) For keeping alive perch, tench and rudd a keep net placed so as to have the entry above the waterline may be used.
- (3) No licence holder shall have under their control more than one assembled rod and running line while fishing or taking sports fish, except that a licence holder participating in a fishing competition for perch, tench and rudd may have under his control two assembled rods and running lines, only one of which shall be used for fishing at any one time.
- (4) No licence holder shall fish for sports fish unless the licence holder remains within 15 metres of the rod being used and he has the rod under visual observation at all times while the fishing line is on or in the water being fished.
- (5) No licence holder shall, when fishing for sports fish, use or be in possession of, or be in control of, or convey or cause to be conveyed to the vicinity of any place where that licence holder is fishing or proposes to fish—
  - (i) any paravane;
  - (ii) any stroke-hauling or foul-hooking gear;
  - (iii) any spear, spear gun or similar implement;
  - (iv) subject to subclause 5(2) of this notice, no net of any description.
- **6. Lures and baits**—(1) No licence holder shall fish for sports fish with any bait or lure other than artificial fly in the following waters and all their tributaries—
  - (i) The Wairoa River from its source to the Hunua Falls;
  - (ii) The Tairua River;
  - (iii) The Kauaeranga River;
  - (iv) The Komata Stream;
  - (v) The Maratoto Stream from its source to the ford on the old Whangamata track;
  - (vi) The Kakahu Stream (north-east of Okoroire);
  - (vii) The Waipapa River upstream from the first waterfall situated approximately 0.5 km from Lake Waipapa;
  - (viii) The Mangatutu Stream from its source to the Lethbridge Road bridge;
  - (ix) The Puniu River from its source to the Bayley Road Bridge;
  - (x) The Kaniwhaniwha Stream;
  - (xi) The Ngakoaohia Stream from its source on Pirongia Mountain to the bridge on the Pirongia-Kawhia roadway;
  - (xii) The Awakino River from its source to the Mahoenui
  - (xiii) The Little Waipa Stream from its source to the Horahora Road bridge;
  - (xiv) The Waione Stream;
  - (xv) The Okauaka Stream.
- (2) No licence holder shall fish for sports fish with any bait or lure other than spoonbait, artificial minnow or artificial fly in the following waters—

- (i) The Awakino River downstream from the Mahoenui Bridge;
- (ii) The Maramataha River;
- (iii) The Ongarue River from its source to the confluence with the Waimiha Stream;
- (iv) The Waimiha Stream;
- (v) The Wanganui River from its source to its confluence with the Whakapapa River;
- (vi) The Whakapapa River and its tributaries.
- (3) Subject to subclause (1) and (2) of this clause, no licence holder shall fish for sports fish with any lure or bait other than artificial or natural fly, insect, worm, crustacea, minnow, fish excluding any fish ova or any portion of a fish or any shellfish (mollusca), in the following waters:
  - (i) All rivers and springs and streams not specified in sub clauses 1 & 2 of clause 6 and excluding the Whangamarino River and the Mangatawhiri river from the bridge on State Highway 2, to its confluence with the Waikato River:
  - (ii) Lake Moananui;
  - (iii) Lake Tomarata;
  - (iv) Lake Ototoa:
  - (v) Lake Whatihua (Thomsons Lake);
  - (vi) Lake Otamatearoa (Muirs Lake);
  - (vii) Lake Parkinson;
  - (viii) Lake Arapuni;
  - (ix) Lake Karapiro:
  - (x) Lake Waipapa.
- (4) In respect to all waters not specified above, any bait can be used, excluding any fish ova or any portion of a fish or any shellfish (mollusca).
- (5) In respect to all waters a licence holder participating in a fishing competition for rudd, perch and tench, may with the written authorization of the Manager of the Auckland/Waikato Fish and Game Council in the licence holders possession and available for production on demand, use any bait, excluding any fish ova or any portion of a fish or any shellfish (mollusca) but not otherwise.
- (6) No licence holder when fishing for sports fish shall use-
  - (a) More than 2 lures or baits
- (b) Any lead or weight attached below or so as to hang below any lure or bait.
- (c) In any water in which only artificial fly is permitted, any lead or weight other than the necessary weight of line, cast and fly, accepting that artificial fly includes any lure of feather, fur, wool or other material of any kind customarily used in the making of artificial flies, but does not include any lure in the tying of which any lead or other weight has been incorporated, unless the hook used in that lure does not exceed 20mm in length (exclusive of the eye) and the gap of the hook does not exceed 7mm and the hook is not larger than No. 8 (Redditch or old scale).
- (d) Any bait or lure treated with any medicinal or chemical preparation other than—
  - (i) In the case of artificial fly, oil used solely to give buoyancy to such flies;
  - (ii) In the case of natural baits, a formalin or other preservation preparation.
- (e) On any lure or bait a hook which has a greater distance than 14mm between the point and the nearest portion of the shank.
- (f) Use as a lure or bait any fish taken from any water other than that in which it is used as a lure or bait.

- (g) Any double or treble hook or any fixed assembly of hooks.
  - (h) Any unsportsmanlike device or method.
- **7. Daily Limit Bag**—(1) No licence holder shall on any one day take or have in his possession more than a total of 2 trout taken from the following waters—
  - (i) Awakino River.
- (2) In respect to all other waters no licence holder shall on any one day take or have in his possession, more than 5 trout or salmon.
- (3) No licence holder shall continue to use a rod and running line to take trout or salmon on any day on which he has already taken or killed a limit bag.
- (4) No licence holder shall on any one day kill more than 5 perch, tench or rudd.
- **8. Minimum size to be taken**—(1) No licence holder shall take or have in his possession any trout or salmon which does not exceed 22cm taken from the following waters—
  - (i) Lake Pupuke;
  - (ii) Lake Moananui;
  - (iii) Lake Tomarata;
  - (iv) Lake Ototoa;
  - (v) Lake Whatihua (Thomsons Lake);
  - (vi) Lake Otamatearoa (Muirs Lake);
  - (vii) Lake Parkinson;
  - (vii) The Waihou River and its tributary the Waimakariri Stream.
- (2) In respect to all other waters except those waters specified in sub clause 1 of this clause no licence holder shall take or have in his possession, any trout or salmon which does not exceed 30cm in length.
- (3) Every licence holder taking a trout or salmon which does not exceed the specified length shall immediately return it, whether it is alive or dead, with as little injury as possible, into the water from which it was taken.
- **9. Revocation**—The notice published in the supplement to *Gazette*, No. 151 of Thursday, 30th August 1990, on pages 3202–3205 titled District Anglers (Waikato Fish and Game Region) Notice 1990, and its amendment No. 1 are hereby revoked.

#### District Anglers (Taranaki Fish and Game Region) Notice 1991, Amendment No. 1.

Pursuant to section 26R (3) of the Conservation Act 1987 (as amended by section 17 of the Conservation Law Reform Act 1990), the Taranaki Fish and Game Council amends the District Anglers (Taranaki Fish & Game Region) Notice 1991, supplement to the *New Zealand Gazette*, 1991, No. 129, page 2787.

- 1. Title and commencement—(1) This amending notice may be cited as the District Anglers (Taranaki Fish and Game Region) Notice 1991, Amendment No. 1, and shall be read together with and deemed part of the District Anglers (Taranaki Fish and Game Region) Notice 1991 (hereinafter referred to as the "principal notice").
- (2) This amending notice shall come into force on the 1st day of October 1992.
- **2. Open Season**—(1) Clause 3(5)(b) of the principal notice is amended to read as: '(b) Lake Ratapiko, except the inlet race;', deleting the words "as shown by signboards".
- (2) Clause 3(5)(d) of the principal notice is amended to read

- as '(d) Waiwhakaiho River downstream from the end of Rimu Street extension;' deleting the words "shown by signboards".
- (3) Clause 3, subclause 5, is amended by inserting as paragraph (g): 'Wanganui River (excluding tributaries) downstream from the boundary;'.
- (4) Clause 3, subclause 5, paragraph (g) of the principal notice is hereby renumbered as 3(5)(h) and shall conclude at the words "to the Boundary". The remainder of clause 3(5)(g) of the principal notice is amended to read as an unnumbered paragraph, viz: "The open season shall be from 1st October in any year to the 30th April in the following year (both days inclusive), then from the 10th day of June of that following year to the 30th September of that same year (both days inclusive)."
- 3. Daily Limit Bag—(1) Subclause (3) of clause 7 of the principal notice is repealed and replaced with: 'Notwithstanding subclause (1) and (2) above no licence holder shall take or kill more than 2 trout from Lake Rotomanu, Mangamahoe, Opunake, Virginia, Pauri, Wiritoa, Namunamu, and Raetihi Hydro Dam and Dobbs Dam'.
- (2) Clause 7 of the principal notice is amended by adding as sub-clause (4): 'Notwithstanding subclause (1), (2) and (3) above there shall be no limit on the number of perch taken or killed by a licence holder.'

### District Anglers (Hawke's Bay Fish and Game Region) Notice 1990, Amendment No. 2

Pursuant to section 26R (3) of the Conservation Act 1987 (as amended by section 17 of the Conservation Law Reform Act 1990), the Hawke's Bay Fish and Game Council amends the District Anglers (Hawke's Bay Fish & Game Region) Notice 1990, supplement to the *New Zealand Gazette*, 1990, No. 151, page 3208–3209.

- 1. Title and commencement—(1) This amending notice may be cited as the District Anglers (Hawke's Bay Fish and Game Region) Notice 1990, Amendment No. 2, and shall be read together with and deemed part of the District Anglers (Hawke's Bay Fish and Game Region) Notice 1990 (hereinafter referred to as the "principal notice").
- (2) This amending notice shall come into force on the 1st day of October 1992.
- **2.** Open Season—(1) Clause 3(2)(b) of the principal notice is repealed and replaced with:
  - "(b) The Tukituki River where it passes through the Tuki Tuki Wildlife Refuge and between the junction of the Tukipo River and the Mount Herbert Road extension."

This amendment places the word "and" between "Wildlife Refuge" and "between the ...".

- (2) Clause 3(3) of the principal notice is hereby renumbered as clause 3(4).
- (3) Clause 3(4) of the principal notice is hereby renumbered as clause 3(3).

Clause 2(2) and 2(3) of this amendment present the open seasons in chronological order.

## District Anglers (Wellington Fish and Game Region) Notice 1990, Amendment No. 2

Pursuant to section 26R (3) of the Conservation Act 1987 (as amended by section 17 of the Conservation Law Reform Act 1990), the Wellington Fish and Game Council amends the District Anglers (Wellington Fish & Game Region) Notice

- 1990, supplement to the *New Zealand Gazette*, 1990, No. 151, page 3210-3211.
- 1. Title and commencement—(1) This amending notice may be cited as the District Anglers (Wellington Fish and Game Region) Notice 1990, Amendment No. 2, and shall be read together with and deemed part of the District Anglers (Wellington Fish and Game Region) Notice 1990 (hereinafter referred to as the "principal notice").
- (2) This amending notice shall come into force on the 1st day of October 1992.
- **2. Daily Bag Limit**—(1) Clause 9(1) of the principal notice is deleted and replaced with the following:
- (1) (a) No licence holder shall on any one day take, kill or have in possession more than a total of two trout or salmon taken from the following rivers (all tributaries included): Hautapu, Rangitikei (upstream of Springvale Bridge to the junction of Oturua Stream) and Wainuiomata Rivers; and all waters upstream of the boundaries of the Kaimanawa, Ruahine, Tararua and Rimutuka Conservation Parks.
- (b) Rangitikei River upstream of the confluence of Oturua Stream: one trout or salmon per day.
  - (c) All other waters: no limit.

#### District Anglers (Nelson/Marlborough Fish and Game Region) Notice 1990, Amendment No. 2

Pursuant to section 26R (3) of the Conservation Act 1987 (as amended by section 17 of the Conservation Law Reform Act 1990), the Nelson/Marlborough Fish and Game Council amends the District Anglers (Nelson/Marlborough Fish & Game Region) Notice 1990, supplement to the New Zealand Gazette, 1990, No. 151, pages 3211–3213.

- 1. Title and commencement—(1) This amending notice may be cited as the District Anglers (Nelson/Marlborough Fish and Game Region) Notice 1990, Amendment No. 2, and shall be read together with and deemed part of the District Anglers (Nelson/Marlborough Fish and Game Region) Notice 1990 (hereinafter referred to as the "principal notice").
- (2) This amending notice shall come into force on the 1st day of October 1992.
- 2. Closed Season—(1) Clause 4 (4) of the principal notice (as amended by clause 3 of Amendment No.1) is repealed and replaced with:
  - "(4) There shall be a closed season for fishing for chinook salmon (*Oncorhynchus tshawytscha*) within a radius of 300 metres from the mouth of the Kahutara River from 1 February to 30 April in the same year."
- 3. Authorised Lures and Baits—(1) Clause 6 (2) (n) of the principal notice (as amended by amendment No. 1) is repealed and replaced with:
  - "(n) Clarence River above Glen Alton Bridge but excluding Lake Tennyson;"
- **4.** Daily Limit Bag—(1) Clause 9 (2) (a) of the principal notice is repealed and replaced with:
  - "(a) Coastal rivers and their tributaries meeting the sea between and including the Awatere and Conway rivers, but excluding Lake Tennyson;"

### District Anglers (North Canterbury Fish and Game Region) Notice 1990, Amendment No. 2

Pursuant to section 26R (3) of the Conservation Act 1987 (as amended by section 17 of the Conservation Law Reform Act

- 1990), the North Canterbury Fish and Game Council amends the District Anglers (North Canterbury Fish & Game Region) Notice 1990, supplement to the *New Zealand Gazette*, 1990, No. 151, pages 3213–3215.
- 1. Title and commencement—(1) This amending notice may be cited as the District Anglers (North Canterbury Fish and Game Region) Notice 1990, Amendment No. 2, and shall be read together with and deemed part of the District Anglers (North Canterbury Fish and Game Region) Notice 1990 (hereinafter referred to as the "principal notice").
- (2) This amending notice shall come into force on the 1st day of October 1992.
- **2.** Interpretation—(1) The words "and Heron" in subclause 2 of clause 2 are deleted. Note: Lake Heron and Lake Stream are now incorporated within the Central South Island Fish and Game Region and District Anglers Notice for that region.
- (2) Clause 2, subclause 2, paragraph (a) is amended to read as:
  - '(a) The white posts on the South bank in general line with the Lake Coleridge powerhouse intake pipes on the North bank, on the Rakaia River; and '
- **3. Closed Season**—(1) Clause 4, subclause (1), paragraph (b) is amended to read as:
  - '(b) From the 1st day of March to the 30th day of April in the same year (both days inclusive) in the Rakaia River and its tributaries above the Lake Coleridge powerhouse, that point more particularly shown by white posts on the South bank in general line with the powerhouse intake pipes on the North bank, or in any tributary flowing into the Lake Coleridge tailrace as indicated by signposts installed; provided that this subclause shall not apply to any lakes draining into the Rakaia River above the point specified.'
- (2) Clause 4, subclause (1), paragraph (c) is amended by adding after "Lake Marion", '; and in the Avon River and its tributaries entering it above the Armagh Street Bridge for senior (adult) licence holders only."
- (3) Clause 4, subclause (1) paragraph (d) is repealed and replaced with:
  - '(d) From midnight on the Friday immediately preceding the first Saturday in November until midnight on the 30th day of November in the same year (both days inclusive) in any natural or artificial stream and tributary flowing into any high country lake.'
- (4) Clause 4, subclause (2), paragraph (d) of the principal notice is amended to read as:
  - '(d) The Waimakaruri River above the white posts at Woodstock, or any tributary of that part of that river or the Kowai River and its tributaries including Hacketts Creek'
- (5) Clause 4, subclause (2) of the principal notice is amended by:
  - (i) repealing paragraph (a).
  - (ii) renumbering paragraphs (b), (c) and (d) of the principal notice as paragraphs (a), (b) and (c) accordingly.
- (6) Clause 4 of the principal notice is amended by adding as a new subclause:
  - '(3) There shall be a closed season for fishing for quinnat salmon from the 1st day of February to the 30th day of April in the same year (both days inclusive) in the following waters: (a) The Glenariffe Stream upstream from points marked and signposted, which are located 160 metres downstream from the hatchery release race outfall to the road bridge above the hatchery.'
- **4.** Authorised Tackle—(1) Clause 5, subclause (4) of the principal notice is amended to read as:

- '(4) No licence holder shall fish for sports fish unless within 15 metres of the rod being used and has the rod under own visual observation.'
- (2) Clause 5, subclause (5), paragraph (c) of the principal notice is amended to read as:
  - '(c) In any water in which only artificial fly fishing is permitted, any additional lead or weight other than the necessary weight of line, cast and fly.'
- (3) Clause 5, subclause (5), paragraph (e), subparagraph (i) of the principal notice is amended to read as:
  - '(i) In the case of artificial fly substances used solely to give buoyancy to such flies.'
- (4) Clause 5, subclause (6), paragraph (b) of the principal notice is amended to read as:
  - '(b) Fish from any boat being mechanically propelled in any lakes except Lakes Ellesmere, Forsyth, Coleridge and Sumner at a distance of at least 200 metres from any person fishing from the shore.'
- (5) Clause 5, subclause (6), paragraph (c) of the principal notice is amended to read as:
  - '(c) Fish from any boat or any floatation device in any high country waters except Lakes Coleridge, Georgina, Lyndon, Pearson, Taylor, Katrine and Sumner, in which lakes any boat that is not being mechanically propelled may be used.'
- **5. Daily Limit Bag**—(1) Clause 10, subclause (2), paragraph (a) of the principal notice is amended to read as:
  - '(a) 6 sports fish taken from Lake Coleridge of which no more than 4 shall be trout.'
- (2) Clause 10, subclause (2), of the principal notice is amended by inserting a new paragraph:
  - '(d) 1 splake from Lake Letitia.'
- (3) Clause 10, subclause (4) of the principal notice is repealed.
- (4) Clause 10, subclause (5) of the principal notice is renumbered as subclause (4).

#### District Anglers (West Coast Fish and Game Region) Notice 1990, Amendment No. 2

Pursuant to section 26R (3) of the Conservation Act 1987 (as amended by section 17 of the Conservation Law Reform Act 1990), the West Coast Fish and Game Council amends the District Anglers (West Coast Fish & Game Region) Notice 1990, supplement to the *New Zealand Gazette*, 1990, No. 151, pages 3215–3216.

- 1. Title and commencement—(1) This amending notice may be cited as the District Anglers (West Coast Fish and Game Region) Notice 1990, Amendment No. 2, and shall be read together with and deemed part of the District Anglers (West Coast Fish and Game Region) Notice 1990 (hereinafter referred to as the "principal notice").
- (2) This amending notice shall come into force on the 1st day of October 1992.
- **2.** Open Season—(1) Clause 3 (2) (h) of the principal notice is amended by deleting the words "Arnold Dam" and substituting with 'Grey River confluence'.

# District Anglers (Central South Island Fish & Game Region) Notice 1992

Pursuant to section 26R (3) of the Conservation Act 1987 (as amended by section 17 of the Conservation Law Reform Act

1990), the Central South Island Fish and Game Council hereby gives the following District Anglers Notice.

#### Notice

- 1. Title and commencement—This notice may be cited as the District Anglers (Central South Island Fish and Game Region) Notice 1992 and shall come into force on the 1st day of October, 1992.
- 2. Interpretation—Words and expressions in this notice which are defined in the Conservation Act 1987 or the Freshwater Fisheries Regulations 1983 shall have the meaning so defined.

Particular note should be taken of the following definitions which are substantially extracted from the Act:

- "Fishing" means the catching, taking, or harvesting of fish; and includes any other activity which may reasonably be expected to result in the catching, taking or harvesting of fish; and also includes any operation in support of or in preparation for any activities described in this definition.
- "Taking" means fishing: and "to take" has a corresponding meaning.
- (2) In this notice-
  - (a) "Foulhook" in relation to sports fish means to take the sports fish with a hook otherwise than from within the mouth.
  - (b) "Total weight" in relation to any rod fishing shall include the weight of anything attached to the line.
- (3) In this notice all dates specified are included in the period quoted.
- 3. Open Season—(1) No licence holder shall fish for or take any sports fish except during an open season.
- (2) Subject to subclause (3) of this clause and to clause 4 of this Notice, there shall be an open season for fishing for sports fish from the 1st day of October in any one year to the 30th day of April in the following year.
- (3) There shall be an open season for fishing for sports fish:
  - (a) From the first day of October in any year to the 30th day of September in the year following in the Pukaki-Ohau, Tekapo-Pukaki, Ruataniwha-Ohau "B" and Ohau "B"-Ohau "C" hydro canals, in Lakes Aviemore, Benmore, Tekapo and Ruataniwha including Wairepo Arm and Kellands Pond, and in the Rangitata Diversion Race from the intake downstream to Rakaia River Road.
  - (b) From the 1st day of May to the 31st day of May in the same year in Lake Camp.
- **4.** Closed Season—(1) There shall be a closed season for fishing for sports fish:
  - (a) From the 1st day of October to the 30th day of November in the same year in all the waters of the Ahuriri River upstream of and including Ben Avon Stream;
  - (b) From the 1st day of October to the Friday preceding the first Saturday in November in the same year in Lakes Clearwater, Emma, Maori Lakes, Denny, Roundabout, Emily, Camp, Spider, Donn, Alexandrina, McGregor, Ohau and Middleton, or any high-country tarn, or in Deep Stream east of the bridge where it enters Lake Aviemore, or in the Ahuriri River below Ben Avon Stream, or in the Otematata and Ohau Rivers, or in the Tekapo River upstream of a line running beneath the lower powerlines across the river, or in tributaries of the said lakes, tarns and rivers.
  - (c) From the 1st day of March to the 30th day of April in the same year in the Rangitata River and its tributaries above the point known as Red Rocks Bluff, that point being more particularly shown by white posts on the river banks; and in Lake Stream, a tributary of the Rakaia River.

- (d) From the 1st day of February to the 30th day of April in the same year in the Larch Stream.
- (e) From the 1st day of October in any year to the 30th day of September in the following year—
  - In the Outlet Creek between Lake Alexandrina and Lake McGregor.
  - (ii) In any boat harbour or from either side of any mole at any boat harbour in Lake Aviemore or Lake Benmore.
  - (iii) In McKinnons Stream, a tributary to the south side of the lower Rangitata River.
  - (iv) In the area known as Troutlands Holiday Park Sanctuary at Kurow, more particularly marked by notices at the upstream and downstream boundaries.
  - (f) From the 1st day of April to the 30th day of April in the same year in Bowyers Stream, Taylors Stream, or in the South Branch of the Ashburton River and its tributaries from its source downstream to its confluence with Taylors Stream.
- (2) There shall be a closed season for fishing for salmon—
  - (a) From the 1st day of March to the 30th day of April in the same year in Lake Heron.
  - (b) From the 1st day of April to the 30th day of April in the same year in the Waitaki River between the Waitaki Dam and a line running beneath the power lines across the river at the Stonewall, or in any tributary of that part of the river.
- 5. Authorised Tackle—(1) No licence holder shall fish for or take any sports fish except by using a rod and running line.
- (2) Notwithstanding subclause (1) of this clause, when playing a sports fish, a landing net or gaff may be used to secure or land any such fish.
- (3) No licence holder shall in fishing for, or taking sports fish, use or have under their control more than one assembled rod and running line.
- (4) No licence holder shall fish for sports fish unless within 15 metres of the rod being used and has the rod under visual observation.
- (5) No licence holder when fishing for sports fish shall use:
  - (a) Subject to subclauses (6) (d) and (6) (e) of this clause, more than 2 lures or baits.
  - (b) Any lead or weight attached below or so as to hang below any lure or bait.
  - (c) In any water in which only artificial fly is permitted, any lead or weight other than the necessary weight of line, cast and fly.
  - (d) Any artificial fly having more than one hook or having a multiple hook.
  - (e) Any bait or lure treated with any medicinal or chemical preparation other than:
    - (i) In the case of artificial fly, oil used solely to give buoyancy to such flies, and
    - (ii) In the case of natural baits, a formalin or other preservative preparation.
  - (f) Any wire, either plain or twisted, except when trolling in lakes Waitaki, Aviemore, Benmore, Ohau, Pukaki, or Tekapo.
  - (g) On or in conjunction with any fly, spoonbait, minnow, or other lure any single or fixed multiple assembly of hooks any one hook of which has a greater distance than 13mm between the point and the nearest part of the shank of the hook.
  - (h) In conjunction with any spoonbait or artificial minnow, any lead or weight affixed to the trace or line at a distance of less than 38cm above the lure.
  - (i) Any unsportsmanlike device or method.

- (6) No licence holder when fishing for sports fish shall-
  - (a) Fish from any boat or other flotation device in Lakes Camp, Roundabout, Denny, Emily, Donn, Spider, or in Kellands Pond and the Wairepo Arm of Lake Ruataniwha.
  - (b) Fish from any unmoored boat or flotation device in Lakes McGregor, Middleton, Emma, Clearwater, or the Maori Lakes.
  - (c) Subject to subclauses (6) (a) and (6) (b) of this clause, fish from any boat in any other lake within 100 metres of any person fishing from the shore of that lake.
  - (d) Cast other than from the reel or retrieve other than by winding the reel, from the 1st day of January to the 30th day of April in the same year, in the Opihi River or its tributaries, when using anything other than artificial fly or natural bait, or more than one bait when any weight is attached, or more than one hook (single or multiple) or any hook with a gap greater than 13mm.
  - (e) From the 1st day of January to the 30th day of April in the same year, use in the Ashburton, Rangitata, or Orari Rivers or their tributaries, more than one lure or bait when any weight is attached or more than one hook (single or multiple), or any hook with a gap greater than 13mm.
  - (f) Cast other than from the reel, or retrieve the line other than by winding the reel, in the Ashburton, Rangitata or Orari Rivers except when—
    - (i) Using an artificial fly or natural bait (except where this is otherwise prohibited)
    - (ii) Fishing with a single hook feathered lure (the total weight of which must not exceed 28 grams) seaward of a line drawn between two poles on either side of the upstream limit of the estuarine area.
  - (g) Fish in Lake Benmore from a boat or flotation device while using natural bait.
  - (h) With any natural bait, use more than one such bait, or more than three single hooks, or two single and one triple, or any hook, with a gap greater than 9mm.
  - (7) No licence holder shall foulhook or attempt to foulhook any sports fish.

Provided it shall be a defence to the charge for any person charged with a breach of this subclause, if that person proves that he or she was attempting to take the fish by hooking it from within the mouth and any sports fish taken otherwise than by hooking it from within the mouth was returned immediately or was in the process of being returned immediately with as little injury as possible to the waters from which it was taken.

- **6.** Prohibition On Unauthorised Fishing Tackle, etc—No licence holder shall, when fishing for sports fish, use or be in possession of, or be in control of, or convey or cause to be conveyed to the vicinity of any place where that licence holder is fishing or proposes to fish, any stoke hauling or foulhooking gear, or any spear.
- **7.** Use of Nets—Subject to clause 5 (2) of this Notice, no licence holder shall use or cause to be used for taking sports fish, a net of any description:
  - Provided that it shall be a defence for any licence holder charged with a breach of this clause if that licence holder proves that he or she was netting for indigenous fish in accordance with the provisions of any regulations or notices in force on that behalf.
- 8. Prohibition on Possession or Control of Spear Gun—(1) no licence holder shall, when taking or intending to take or when in possession of, any sports fish, be in possession of or be in control of, any spear gun or pointed missile (other than a bullet) which is propelled by means of any mechanical or explosive device.

- (2) Where any licence holder is charged with an offence under subclause (1) of this clause, it shall be a defence to the charge if the defendant proves that the speargun or pointed missile in the defendant's possession or under the defendant's control was not used in the taking of the sports fish.
- (3) In this clause the term "explosive" has the same meaning as in the Explosives Act 1953.
- 9. Authorised Lures and Baits—(1) Subject to subclauses (2) and (3) of this clause and clause 5 (5) of this notice, no licence holder shall fish for sports fish with any bait or lure other than artificial or natural fly, insect, worm, crustacea, minnow, fish (excluding fish ova or any portion of a fish or any shellfish (mollusca), or uncoloured bread dough.
- (2) No licence holder when fishing for sports fish shall-
  - (a) Use any lure or bait other than artificial fly in the Hinds River or its tributaries, Ohapi Stream or its tributaries, Tengawai River or its tributaries, Hakataramea River or its tributaries, Maerewhenua River or its tributaries, Deep Stream (a tributary of Lake Aviemore), Omarama Stream upstream from the bridge on State Highway 8, Swan Lagoon, Green Lagoon, Yellow Lagoon, Watson Lagoon, Lake Poaka, Lake Merino, Lake McGregor, Maori Lakes, Lake Emily, Lake Roundabout, Lake Spider, Lake Denny, Lake Donn, or Lake Clearwater, or in the tributaries of any such lake, or any high country tarn or lagoon: Provided that a primary school pupil may fish with any lawful lure or bait in the Hinds River upstream from the Lynnford Bridge.
  - (b) Use any lure or bait other than artificial fly, artificial minnow, or spoon in the Ahuriri River or its tributaries, Ohau River or its tributaries, Twizel River or its tributaries, Frazer River or its tributaries, Otamatapaio River or it tributaries, Otematata River or its tributaries, Kakanui River upstream from Five Forks Bridge, Waihao River upstream from the Waihao Forks Bridges, tributaries of the Tekapo River, Ashburton River except from the junction of the South Ashburton and Taylors Stream downstream to its mouth and including the North Ashburton River, Rangitata River and its tributaries upstream of the point known as Red Rocks Bluff, Lake Alexandrina, Lake Camp, Lake Emma, or in Lake Mystery.
- 10. Daily Bag Limit—(1) No licence holder shall on any one day take, kill or have in possession more than 12 trout or salmon.
- (2) Notwithstanding subclause (1) of this clause no licence holder shall on any one day take or have possession of more than—
  - (a) Six sports fish from Lake Heron of which not more than 4 may be trout.
  - (b) Two salmon from any other waters within the region.
  - (c) Four sports fish from any of the following waters for which the daily bag limit is 4 fish:
    - (i) Lakes—Clearwater, Camp, Emma, Denny, Roundabout, Maori Lakes, Emily, Donn, Spider, Mystery, Alexandrina, McGregor and Ruataniwha, including Wairepo Arm and Kellands Pond:
    - (ii) Rivers—Lake Stream a tributary of the Rakaia River, South Ashburton and tributaries upstream from Blowing Point Bridge, Rangitata and tributaries upstream from the point known as Red Rocks Bluff, Macaulay, Mary Burn, Greys, Irishmans, Forks, Hopkins, Dobson, Ohau, Lower Ahuriri and tributaries, Twizel, Frazer, Lower Otematata, Deep Stream (a tributary of Lake Aviemore), Hakataramea and tributaries, Lower Maerewhenua, Waianakarua, Lower Kakanui and tributaries, and Lower Waihao and tributaries.

- (iii) Lagoons and Tarns—Wainono, Swan, Raupo, Red, Ben Avon, Horseshoe, and any other high country lagoon or tarn.
- (d) Not more than 2 sports fish from any of the following waters for which the daily limit bag is 2 fish:
  - Rivers—Jollie, Huxley, Temple, Maitland, Twizel, Frazer, Upper Ahuriri and tributaries above and including Ben Avon Stream, Ahuriri East Branch, Omarama Stream, Otamatapaio, Upper Otematata and tributaries above and including Clear Stream, Maerewhenua North and South branches, Kakanui above Clifton Falls Bridge, and the Waihao above the Waihao Forks Bridges.
- (e) Ten trout from any other waters within the Region.
- (3) No licence holder shall continue to fish for sports fish on any day on which he has already taken or killed a limit bag.
- (4) It shall be permissable to make up the difference between a lesser limit bag prescribed in one place and a higher limit bag prescribed in another place.
- 11. Minimum Size to be Taken—(1) No licence holder shall take or have in his or her possession any trout or salmon which does not exceed in length:
  - (a) 30cm from any lake, high country tarn or lagoon excluding salmon in Lake Heron for which the minimum size to be taken shall be 25cm
  - (b) 25cm from any other waters of the region.
- (2) Every licence holder taking a trout or salmon which does not exceed the specified length shall immediately return it with as little injury as possible into the water from which it was taken.
- 12. Experimental Winter Season—Subject to licence holders obtaining a permit from the Central South Island Fish and Game Council office, Lake Alexandrina shall have an open season for fishing for sports fish from the 1st day of June 1993 to the 31st day of July 1993. Permits are available on request and must be returned with the required information.
- 13. Revocation—The notice published in the supplement to the Gazette, No. 151 of Thursday, 30 August 1990 on pages 3216–3219 titled District Anglers (South Canterbury Fish and Game Region) Notice 1990, and as amended by the District Anglers (South Canterbury Fish and Game Region) Notice 1990, Amendment No. 1, is hereby revoked.

#### District Anglers (Otago Fish and Game Region) Notice 1991, Amendment No. 1

Pursuant to section 26R (3) of the Conservation Act 1987 (as inserted by section 17 of the Conservation Law Reform Act 1990), the Otago Fish and Game Council amends the District Anglers (Otago Fish and Game Region) Notice 1991, supplement to the *New Zealand Gazette*, 1991, No. 129, pages 2790–2792.

- 1. Title and commencement—(1) This amending notice may be cited as the District Anglers (Otago Fish and Game Region) Notice 1991, Amendment No. 1, and shall be read together with and deemed part of the District Anglers (Otago Fish and Game Region) Notice 1991 (hereinafter referred to as the "principal notice").
- (2) This amendment shall come into force on the 1st day of October 1992.
- 2. Open Season—(1) Clause 3 (1) (b) of the principal notice is amended by deleting the words "Clutha River, downstream from Albert Town Bridge" and substituting them with:
  - "Clutha River, except that river reach known as Deans Bank defined by a landmark post approximately 600 metres below Lake Wanaka outlet and a landmark post

- approximately 600 metres above the Albert Town bridge:".
- (2) Clause 3 (1) (b) of the principal notice is amended by adding:
  - "Dart River, downstream from the Dart River bridge:".
- (3) Clause 3 (1) (b) of the principal notice is amended by deleting: "Lake Wanaka Outlet, source of the Clutha River lying downstream between a point indicated by a post landmark on both banks approximately 600 metres from the outlet of Lake Wanaka:".
- (4) Clause 3 (1) (d) of the principal notice is amended by adding:
  - "Ross Creek Reservoir: Rossville Reservoir: Sullivans Dam: Southern Reservoir:".
- (5) Clause 3 (1) (f) of the principal notice is amended by adding:
  - "Diamond Creek: Lake Mahinerangi:".
- 3. Closed Season—Clause 4 (1) of the principal notice is amended by adding "Lake Wanaka, within 100 metres of any part of the wharf at the Wanaka Marina:".
- **4. Restriction of Lures, Baits and Areas**—(1) Clause 6 (4) of the principal notice is amended by deleting the words "Clutha River catchment upstream from the Clyde Dam" and substituting them with:
  - "(A) Clutha River catchment upstream from Lake Dunstan: (b) Ross Creek Reservoir: (c) Rossville Reservoir: (d)
  - Sullivans Dam: (e) Southern Reservoir:".
- (2) Clause 6 (5) (a) of the principal notice is amended by deleting the words "Clyde Dam wall" and substituting them with: "Lake Dunstan:".
- (3) Clause 6 (5) of the principal notice is amended by adding "(e) Lake Hawea:".
- **5. Daily Limit Bay**—(1) Clause 9 (1) (a) of the principal notice is amended by adding a further specified water: "Routeburn River:".
- (2) Clause 9 (1) (b) of the principal notice is amended by deleting clause 9 (1) (b) and substituting it with "Specified waters." "(b) Caples River; Greenstone River (including all tributaries, but excluding Lake McKellar); Lochy River (excluding the special catch and release zone); Von River and Lake; Ross Creek Reservoir, Rossville Reservoir, Wilkin River, Young River, Sullivans Dam, Southern Reservoir. Daily Limit—No more than one sports fish per day."
- **6. Minimum Size to be Taken**—Clause 10 (1) (b) of the principal notice is amended by deleting the figure "50cm" and substituting the figure "45cm".
- **7. Revocation**—Clause 11 of the principal notice is amended by deleting the figure "11" and substituting with the figure "12".
- **8. New Clause**—(1) Insert a new clause 11 to the principal notice as follows:
  - "11. Experimental Waters—(1) Young River is a fisheries experimental water and special rules apply requiring anglers to hold a permit to fish the river, and to report on their success and satisfaction.
- (2) Sullivans Dam is a fisheries experimental water and special rules apply requiring anglers to hold a permit to fish the dam and to report on their success and satisfaction."

# District Anglers (Southland Fish and Game Region) Notice 1990, Amendment No. 2

Pursuant to section 26R (3) of the Conservation Act 1987 (as amended by section 17 of the Conservation Law Reform Act

- 1990), the Southland Fish and Game Council amends the District Anglers (Southland Fish and Game Region) Notice 1990, supplement to the *New Zealand Gazette*, 1990, No. 151, pages 3221–3222.
- 1. Title and commencement—(1) This amending notice may be cited as the District Anglers (Southland Fish and Game Region) Notice 1990, Amendment No. 2, and shall be read together with and deemed part of the District Anglers (Southland Fish and Game Region) Notice 1990 (hereinafter referred to as the "principal notice").
- (2) This amendment notice shall come into force on the 1st day of October 1992.

- **2. Open Season**—(1) Clause 3, subclause 2, paragraph (h) of the principal notice is revoked and replaced with the following:
  - '(h) The Waiau River downstream from the State Highway 96 bridge at Tuatapere, including the whole area of Te Wae Wae Lagoon, but excluding the Hollyburn.'
