Fisheries Act 1983

The Fisheries (Cancellation of Crown Quota for Paua) Notice 1992 (No. 5182)

Pursuant to section 28U (6) of the Fisheries Act 1983, the Director-General of Agriculture and Fisheries hereby gives the following notice.

Notice

1. Title and commencement—(1) This notice may be cited as the Fisheries (Cancellation of Crown Quota for Paua) Notice 1992.

(2) This notice shall come into effect on the 1st day of October 1992.

2. Interpretation—In this notice any reference to a Quota Management Area means the appropriate quota management area as defined in the Second Schedule of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986 (S.R. 1986/267).

3. Cancellation of Crown holdings for paua—(1) Pursuant to section 280D (1) of the Fisheries Act 1983, the Director-General of Agriculture and Fisheries has cancelled Crown holdings of 2.597 tonnes of individual transferable quota for paua in Quota Management Area 5—South East/Southland (Otago and Southland Coast).

(2) The total allowable commercial catch for paua in this area is accordingly reduced in the manner specified in clause 6 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 10. Dated at Wellington this 1st day of October 1992.

Temporary Safeguard Authorities Act 1987

Request to a Temporary Safeguard Authority to Undertake an Inquiry into the Importation of Goods

Pursuant to section 5 (1) of the Temporary Safeguard Authorities Act 1987, I, Philip Burdon, Minister of Commerce, request you to undertake an inquiry into the importation of the goods specified in the Schedule to this request ("the goods") and report on the following matters:

(a) Whether the industry in relation to the goods, has suffered or is likely to suffer material injury as a result of the importation of the goods having regard to the matters set out in section 6 of the Act; and

(b) If the industry has suffered or is likely to suffer such injury,—

- (i) Whether urgent action is necessary to protect the industry in relation to the importation of the goods; and
- (ii) If such action is considered necessary, the nature of the protection that you consider to be appropriate in all the circumstances, and the extent and duration of such protection.

Imported Goods Subject to a Temporary Safeguard Authority Inquiry

Men's and boys' underwear, being underpants and briefs, of Tariff Heading 61.07 of the New Zealand Tariff, but excluding those goods imported under Part II, Reference 99 of the Tariff that are not domestically manufactured by the industry.

Statement of Government Policy in Relation to the Men's and Boys' Underwear Industry

To: Temporary Safeguard Authority.

Pursuant to section 6 (1) (d) of the Temporary Safeguard Authorities Act 1987, I, Philip Burdon, Minister of Commerce give you notice that it is part of the policy of the Government that:

Levels of industry assistance at the border be progressively reduced in order to encourage greater levels of international competitiveness.

In relation to apparel, this policy has been reflected in the removal of import licensing between 1 July 1989 and 1 July 1992, the lowering of the *ad valorem* duty on certain products and the phased reduction of specific tariffs from 1 July 1989. The Government's recently announced decision to retain alternative specific tariffs for certain apparel, including men's and boys' underwear, represents an acknowledgment that the apparel industry faces some problems relating to tariff enforcement given the difficulties in ensuring proper valuation and payments of correct amounts of duty, and in using effectively the anti-dumping and countervailing legislation. This decision did not represent, however, the intention to increase the overall level of assistance to the New Zealand apparel industry.

The determination of any injury and any appropriate temporary remedies should be compatible with New Zealand's international obligations under Australia New Zealand Closer Economic Relations Trade Agreement (ANZCERTA), the South Pacific Regional Trade and Economic Co-operation Agreement (SPARTECA) and the General Agreement on Tariffs and Trade (GATT).

Transport (Vehicle Standards) Regulations 1990

Exemption from Braking Equipment Requirements

Pursuant to regulation 36 of the Transport (Vehicle Standards) Regulations 1990 and pursuant to the powers delegated to me by the Secretary for Transport by an instrument of delegation dated 1 October 1991, I, Peter William Bowen, Senior Automotive Engineer, hereby exempt

the class of vehicle described in the Schedule from the provisions of subclause 1, paragraph (b) and subclause 3 of regulation 13 of these same regulations, subject to the conditions in the Schedule.

This exemption is to take effect immediately.

All vehicles of Class NB as defined in the First Schedule of the Transport (Vehicle Standards) Regulations 1990.

Conditions

(1) First registered in this country on or after 1 November 1990, and on or before 31 December 1994; and

(2) Fitted with the unmodified, original manufacturer's braking system, comprising the following features:

- A mechanically operated transmission parking brake; and
- A low level driver warning device fitted to the brake system fluid reservoir; and either
- A single line service brake in which the output of the master cylinder/booster is divided into two independent braking circuits. Each circuit to pass through an excess flow prevention valve, (otherwise known as a safety cylinder); or
- A dual line service brake which contains a tandem/dual master cylinder and or booster.

Overseas Investment Regulations 1985

The Overseas Investment Exemption Notice 1992, No. 1

Pursuant to the Overseas Investment Regulations 1985, the Overseas Investment Commission hereby gives the following notice.

Notice

1. Title and commencement—(1) This notice may be cited as the Overseas Investment Exemption Notice 1992, No. 1.

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. Interpretation—(1) In this notice, unless the context otherwise requires:

"Specified person" means any company which is an overseas person but which would not be an overseas person if Brierley Investments Limited were not an overseas person.

"The regulations" means the Overseas Investment Regulations 1985.

(2) Terms or expressions used in this notice shall have the same meaning as they have in the regulations.

3. Exemption from Part I of the regulations—Every person is exempt from the provisions of Part I of the regulations in respect of the issue of shares to, or the allotment of shares subscribed for by:

(a) A specified person; or

(b) Brierley Investments Limited.

4. Exemption from Parts II and III of the regulations—(1) Brierley Investments Limited and every specified person is exempt from the provisions of Part II (except regulation 16) and Part III of the Regulations.

(2) Every person is exempt from the provisions of regulation 16 of the regulations in respect of the provision of any contract or agreement which provides for the transfer of shares in a company to:

(a) A specified person; or

(b) Brierley Investments Limited.

Explanatory Note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the *Gazette*, exempts persons who issue or allot shares to any specified person, or to Brierley Investments Limited from Part I of the Overseas Investment Regulations 1985. The term "specified person" is defined to mean a company which is an overseas person under the regulations but which would not be an overseas person if Brierley Investments Limited were not an overseas person.

The notice exempts Brierley Investments Limited and specified persons from the requirements of Part II (except regulation 16) of the regulations (which relates to takeovers by overseas persons) and from Part III of the regulations (which relates to the acquisition by an overseas person of assets used in carrying on a business).

The notice also exempts persons from compliance with regulation 16 in relation to any contract or agreement which provides for the transfer of shares in a company to a specified person or to Brierley Investments Limited. au9124

Bylaw Fixing the Maximum Speed of Vehicles on Part of State Highway No. 5 at Ngongotaha Intersection

Bylaw:

1. This bylaw may be cited as Transit New Zealand Bylaw 1992/5.
