Finance and Expenditure

Summary of Bills Introduced

Electoral Reform

Proposes a general reform of electoral law in New Zealand.

Part I provides for the holding of a referendum at the time of the 1993 general election. Electors will be asked to choose between the present first-past-the-post system and a Mixed Member Proportional (MMP) system and to show whether they favour the creation of a Senate.

Parts II to X provide for the introduction of the MMP system if the proposal favouring change is carried at the referendum.

Under the MMP system proposal the House of Representatives would have 120 members—60 members elected by a plurality method in single member electorates and 60 members elected through nationwide party lists. No provision is made for separate Maori seats. A threshold would apply—a party can participate in the list vote only if either its combined list vote is greater than 4 percent of all list votes or it wins at least 1 constituency seat. This threshold would be waived for parties representing Maori interests. Party list members will be selected from ordered party lists nominated by each registered political party before polling day.

Parts XI to XVI provide for the creation of a Senate, if at the referendum voters do not carry the MMP system proposal and agree to the proposal for a Senate. The Senate would have 30 elected members and its main function will be to give further consideration to legislation passed by the House of Representatives. The Senate would provide another channel for the introduction of Private, Local, and Government bills (other than money bills). The Senate would not have the power to reject any bill or to introduce money bills.

Resource Management Amendment

Amends the Resource Management Act 1991. Deals largely with a considerable number of technical amendments, which do not change the fundamental principles contained in the principal Act. One issue, which relates to the provision of esplanade reserves in the case of subdivision, amends the original policy of the principal Act by changing the current regime for areas of 4 hectares or more.

Earthquake Commission

Provides for the insuring of residential property (as defined) against earthquake and certain other kinds of disaster. Non-residential property will no longer be insured after a "phase-out" period ending at 31 December 1996. Coverage for war damage is no longer provided for.

Human Rights

Amalgamates and revises the Race Relations Act 1971 and the Human Rights Commission Act 1977.

The Human Rights Commission, established by the Human Rights Commission Act 1977, is continued. The Race Relations Conciliator, whose office was established by the Race Relations Act 1971, becomes the Race Relations Commissioner. The Human Rights Commission is to comprise the Chief Human Rights Commissioner, the Race Relations Commissioner, the Privacy Commissioner and three other Commissioners.

New grounds of unlawful discrimination are provided. Carries forward the provisions of the Race Relations Act 1971 and the Human Rights Commission Act 1977 which prohibit discrimination on the grounds of race, colour, ethnic or national origins, sex, marital status, religious or ethical belief, and, in the area of employment, age. The new grounds are disability, age (in areas additional to employment), political opinion, employment status, and family status. There are new provisions on racial disharmony, sexual harassment, and racial harassment.

Special provisions relating to superannuation schemes deal with different treatment on the grounds of age and disability.

Seeks to establish a Complaints Division. The Chief Human Rights Commissioner is to have power to designate certain Commissioners to act as a Complaints Division. New provisions in relation to dealing with complaints enable the Complaints Division to call a compulsory conference to assist in settling a complaint; and enable the person, against whom a complaint has been found to have substance, to bring proceedings before the Human Rights Tribunal. A power of entry, which is a new power in relation to discrimination complaints, is conferred on the Complaints Division.

The Equal Opportunities Tribunal, established under the Human Rights Commission Act 1977, is re-named the Human Rights Tribunal. It has new powers to make interim orders and to declare that otherwise unlawful behaviour constitutes a genuine occupational qualification, in relation to employment, or a genuine justification, in relation to other areas covered by the Bill. There may be 2 Chairpersons of the Tribunal if the Minister of Justice determines that it is necessary.

Foundation for Research, Science, and Technology Amendment

Amends the Foundation for Research, Science, and Technology Act 1990.

Requires that the Foundation consult with representatives of industry, researchers, Maori and the community in forming advice to the Minister of Research, Science, and Technology on national priorities for research. There is a requirement for a regular programme of consultation to assist with the formulation of other advice.

Requires the Minister to provide a Statement of Priorities every three years, replacing the current requirement for the Statement to be provided annually before the start of the financial year.

Clauses 7 and 8A-8C provide the powers and framework for the Minister to direct the Foundation to allocate funds for the purposes of certain schemes. The clauses establish the purposes for which schemes may be set up, and also establish requirements for funding, monitoring, and annual reporting.

Law Reform (Miscellaneous Provisions)

Amends section 16 of the Animals Protection Act 1960 to give courts power to disqualify people who have been convicted of cruelty against animals, from custody of animals, and also increases the fines payable.

Amends the Law Practitioners Act 1982 to exclude the Solicitors Fidelity Guarantee Fund from any liability for loss relating to money a solicitor was instructed to invest on a person's behalf. The Fund's purpose is to protect clients using solicitors for legal transactions only. For claims made after 31 March 1993 there will be a maximum liability of \$5,000 which each practitioner can be required to pay into the Fund in any one year.

Amends section 32 of the New Zealand Society of Accountants Act 1958 to provide for the abolition of the New Zealand Society of Accountants Fidelity Fund.

Taxation Reform (No. 6)

Proposes a number of miscellaneous amendments to the Income Tax Act 1976, the Goods and Services Tax Act 1985, the Estate and Gift Duties Act 1968, and the Inland Revenue Department Act 1974; makes related amendments to the Social Security Act 1964; and provides the annual confirmation of rates of income tax for the 1992/93 income year.

The main areas of the proposed amendments are: estate duty, the livestock regime, the regime for attributed foreign dividends, the controlled foreign company regime, the foreign investment fund regime, the treatment of entertainment expenditure and benefits, provisional tax and the use of money interest, retiring allowances, and depreciation.

Broadcasting Amendment Act (No. 2) 1990

1993 General Election

Qualification of Political Parties for Allocations of Broadcasting Time

The Broadcasting Amendment Act (No. 2) 1990 (amending the Broadcasting Act 1989—"the Act") describes the responsibilities of the Broadcasting Standards Authority to

decide which political parties will qualify for allocations of time or money for political party election programmes. Time may be made available free or at discounted rates by broadcasters; and the Act provides for the appropriation of money by Parliament for the purpose of enabling political parties to meet all or part of the costs of producing election programmes during the election period.

Section 70A (1) of the Act requires the Authority to specify, by notice in the *Gazette*, a date by which it is to be advised by any political party that that party considers that it will qualify for an allocation of time under section 73 of this Act, in respect of the election period that will apply in relation to the general election to be held this year.

The Authority specifies noon on 26 March 1993 as that date.

Each political party that considers that it will qualify should notify the Authority in writing by that date.

Section 76 (3) of the Act provides that the failure of any political party to give such notice shall not prevent the Authority from making any allocation of time or money or making any determination, and shall not affect the validity of those decisions.

Under section 70c of the Act, every notice given to the Authority by any party shall state, among other things—

- (a) the full name of the political party;
- (b) in respect of each person belonging to the party who has declared his or her intention of becoming a candidate at that election,
 - (i) the full name of that person; and
 - (ii) the electoral district for which that person intends to be a candidate.

Section 70D of the Act provides that where a political party states in its notice to the Authority that a person has declared his or her intention of becoming a candidate at the election, that person shall be deemed for the purposes of section 75 of the Act to be a candidate until noon on nomination day, whether that person is nominated or not.

Under section 75 (1) of the Act, the Authority shall not allocate any time to a political party under section 73 of the Act or make under section 74A of the Act an allocation of money to a political party unless—

- (a) that political party conducts its affairs throughout New Zealand and has a national organisation; and
- (b) that political party has consistently expressed philosophies or policies on a range of issues over the period of 12 months preceding the issue of the writ for the election; and
- (c) in the case of a general election, persons belonging to that party are candidates at the general election for at least 10 seats in the House of Representatives.

The Authority also invites parties to make submissions on matters relating to the allocation of time and money, such as the classification of "major political parties" (section 73 (2) (a)), and the criteria of section 75 (2), viz.—

- (a) the number of persons who voted at the immediately preceding general election for candidates belonging to that political party;
- (b) the number of persons who voted at any by-election held since the immediately preceding general election for any candidate belonging to that political party;
- (c) the number of members of Parliament who—
 - in the case of a general election, were members of that political party immediately before the expiration or dissolution of Parliament;
- (d) any other indications of public support for that political party such as the results of public opinion polls and the number of persons who are members of that political party.

The Authority will consult with political parties which give it notice.

The Authority is currently inviting broadcasters to permit political parties to broadcast election programmes free of charge or at discounted rates in the election period. Any such time made available will be allocated under the terms of the Act, by the Authority.
