Imprest Supply Bill (No. 6)

This bill enables the issue and application of certain amounts of public money towards the service of the year ending with the 30th day of June 1993 and to authorise costs to be incurred towards the service of that year.

The Methodist Church Property Trust Amendment Bill

Notice to Introduce Bill

Notice is hereby given of the intention of the Methodist Church of New Zealand to apply for leave to introduce into the House of Representatives a private bill to be named The Methodist Church Property Trust Amendment Bill.

1. Title and Commencement—(1) This order may be cited as The Local Government (Southland Harbour Board Property) Reorganisation Order 1993.

(2) This order shall come into force on the 28th day after the date of its notification in the *Gazette*.

(3) The Southland Harbour Board referred to in this order was a local authority dissolved on 1 November 1989 under section 36 of the Local Government Act 1974.

2. Vesting of Property—The property paid and/or transferred by the Southland Harbour Board to the trustees of the South Port Staff Benefit Trust created by Deed dated the 6th day of December 1988 and more particularly identified as:

(a) the deposit of \$500,000 made by the Southland Harbour Board with Westpac Banking Corporation on 26 September 1988 and repayable on 19 January 1989, and thereafter paid to the South Port Staff Benefit Trust together with all interest earned thereon; and

(b) one million shares in the capital of South Port, transferred by the Southland Harbour Board on 26 September 1989, to the trustees of the South Port Staff Benefit Trust, together with all dividends declared thereon or paid to the South Port Staff Benefit Trust;

Pursuant to section 8 of the Local Authority Reorganisation (Property Transfers) Act 1990, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

Order

1. Title and Commencement—(1) This order may be cited as The Local Government (Southland Harbour Board Property) Reorganisation Order (No. 2) 1993.

(2) This order shall come into force on the 28th day after the date of its notification in the *Gazette*.

(3) The Southland Harbour Board referred to in this order was a local authority dissolved on 1 November 1989 under section 36 of the Local Government Act 1974.

2. Vesting of Property—The Port Company Plan prepared pursuant to the provisions of the Port Companies Act 1988 by the Southland Harbour Board in respect to its port related commercial undertaking, and approved by the Minister of Transport with amendments on the 6th day of December 1988, shall continue in effect but is hereby modified to the extent that the provisions in that part of paragraph (b) on page 6 of the Plan providing for the satisfaction of the debt owing to the Southland Harbour Board for the purchase of the port related commercial undertaking, commencing with the words "To satisfy the purchase price . . .", is deleted and the following is substituted:

"To satisfy the purchase price of the assets it is recommended that the Port Company issue to the Board:

(i) 30 million class A shares of \$0.50 par value = \$15 million

(ii) debt securities of \$8 million value to secure the repayment of the Board's debts = \$8 million

Total cost of assets = \$23 million".

Traffic Regulations 1976

Approval of Flashing Headlamps

Pursuant to regulation 88 of the Traffic Regulations 1976, and regulation 6 of the Transport (Vehicle Standards) Regulations 1990, approval is hereby granted, for the purpose of subclause (8) of the regulation 67 of the Traffic Regulations 1976, for the fitting and use of a flashing headlamp system in vehicles as described in the Schedule of this notice, provided those vehicles comply with the conditions below.

Schedule

1. Vehicles owned and operated by the New Zealand Police Department.
2. Vehicles that are approved by the New Zealand Ambulance Board.
3. Vehicles that are operated under a New Zealand Fire Authority.
4. Vehicles owned and operated by the Life Flight Trust, Wellington and Auckland Regional Rescue Helicopter Trust, that are equipped and dedicated for emergency rescue operations.

Conditions

1. This system shall not be used during the hours of darkness, as defined in regulation 2 of the Traffic Regulations 1976.
2. This system shall incorporate an override system, that will immediately de-activate the headlamp flashing system as soon as the standard vehicle headlamp switch is activated.
3. When this system is in operation the headlamps shall flash at a rate of not less than 60 or more than 120 flashes per minute.

4. This system is approved for emergency response vehicles only, and must be removed from the vehicle when the vehicle is withdrawn from this service.

The Traffic (Waikato District) Notice No. 1, 1993

Pursuant to the Transport Act 1962, a delegation from the Minister of Transport, and a subdelegation from the Secretary for Transport dated the 16th day of November 1992, I, John Paul Edgar, Senior Traffic Engineer, give the following notice:

Notice

This notice may be cited as the Traffic (Waikato District) Notice No. 1, 1993.

The area and roads specified in the First Schedule are declared to be closely-populated localities for the purposes of section 52 of the Transport Act 1962.

The roads specified in the Second Schedule are declared to be 70 kilometre an hour speed limit areas pursuant to regulation 21 (2) of the Traffic Regulations 1976.

The Traffic (Waikato District) Notice No. 3, 1991, signed on the 28th day of June 1991*, and the Traffic (Raglan County) Notice No. 1, 1986, signed on the 12th day of September 1986†, and the Traffic (Waipa County) Notice No. 1, 1986, signed on the 3rd day of July, 1986‡, and the Traffic (Waikato County at Matangi) Notice No. 1, 1974, dated on the 11th day of November 1974||, issued pursuant to section 52 of the Transport Act 1962 and regulation 21 (2) of the Traffic Regulations 1976 are revoked.

The extract from the *New Zealand Gazette* published on the 2nd day of October 1958, "Limited Speed Zone Declared" issued pursuant to the Transport Act 1949, and for the purposes of the Traffic Regulations 1956, dated on the 25th day of September 1958¶, is revoked.

First Schedule

Situated within Waikato District at Matangi:

Good Street.

Matangi Road: from Tauwhare Road to a point 530 metres measured westerly, generally, along Matangi Road from Tauwhare Road.

Tauwhare Road: from Good Street to a point 250 metres measured north-easterly, generally, along Tauwhare Road from Matangi Road.

Situated within Waikato District at Raglan:

All that area bounded by a line commencing at a point on the southern side of the No. 23 State Highway (Hamilton-Raglan) at its intersection with the north-western side of Manukau Road; thence across the said State highway at right angles from its southern side to its northern side; thence south-easterly, generally, along the northern side of the said State highway to its intersection with the north-eastern side of Lorenzen Bay Road; thence north-easterly, generally, by a right line to a point on the south-western side of Greenslade Road 500 metres measured northerly, generally, along Greenslade Road from the No. 23 State Highway (Hamilton-Raglan); thence across Greenslade Road at right angles from its south-western side to its north-eastern side; thence due north by a right line to the shore of the Raglan Harbour; thence north-westerly, and south-westerly, generally, along the said shore to the north-eastern bank of the Oporuru River; thence south-westerly, generally, by a right line across the mouth of the said river to its south-western bank; thence westerly, generally, along the shore of the Raglan Harbour to a

Pursuant to section 15 of the Broadcasting Act 1989, notice is hereby given that the Broadcasting Standards Authority has made the following decisions on complaints referred to it for investigation and review:

(i) In decision 1/93, the authority declined to uphold a complaint from Mr Kerry Sharp of Palmerston North that the broadcast by Television New Zealand Limited of the film *In Bed With Madonna* on 25 September 1992 breached the responsibility placed on broadcasters to maintain standards of good taste and decency.

(ii) In decision 2/93, the authority declined to uphold a complaint from Mr Roger Helm of Christchurch that the broadcast by Television New Zealand Limited of an item on *One Network News* on 6 August 1992 breached the responsibility placed on broadcasters to be truthful and accurate on points of fact, to deal justly and fairly with people referred to in a programme, to show balance, impartiality and fairness in dealing with controversial issues and to present news accurately, objectively and impartially.

(iii) In decision 3/93, the authority declined to uphold a complaint from Ms Jenny Ritchie of Hamilton that the broadcast by TV3 Network Services Limited of the programme *The Ralston Group* on 2 September 1992 breached the responsibility placed on broadcasters to give reasonable opportunities to present significant points of view when controversial issues are discussed, to deal justly and fairly with people referred to in a programme and to avoid portraying people in a way which is likely to encourage denigration on account of race.

(iv) In decision 4/93, the authority declined to uphold a complaint from Monsignor F. D. O'Dea of Dunedin that the broadcast by TV3 Network Services Limited of an item on *Nightline* on 2 September 1992 breached the responsibility placed on broadcasters not to encourage the denigration of, or discrimination against, a section of the community on account of religion.

(v) In decision 5/93, the authority declined to uphold a complaint from Mr A. G. Georgeson of Auckland that the broadcast by Television New Zealand Limited of an item on *Holmes* on 4 September 1992 breached the responsibility

placed on broadcasters to maintain standards of good taste and decency and to be mindful of the effect any programme may have on children during their generally accepted viewing periods.

(vi) In decision 6/93, the authority declined to uphold a complaint from Mr J. B. Bertram of Nelson that the broadcast by Television New Zealand Limited of an item on *One Network News* on 5 October 1992 breached the responsibility placed on broadcasters to maintain standards of good taste and decency.

(vii) In decision 7/93, the authority declined to uphold a complaint from Mr Kristian Harang of Auckland that the broadcast by Television New Zealand Limited of an item on *Holmes* on 24 September 1992 breached the responsibility placed on broadcasters to maintain standards of good taste and decency and not to encourage the denigration of, or discrimination against, a section of the community on account of their sex.

(viii) In decision 8/93, the authority upheld a complaint from the Group Opposed to Advertising of Liquor of Hamilton that the broadcast by Canterbury Television Limited of the programme *DB Sport* on 7 September 1992 breached the responsibility placed on broadcasters that the saturation of liquor advertising must be avoided.

(ix) In decision 9/93, the authority declined to uphold a complaint from Mr Kerry Sharp of Palmerston North that the broadcast by TV3 Network Services Limited of an item on *3 National News* on 18 October 1992 breached the responsibility placed on broadcasters to show balance, impartiality and fairness in dealing with controversial issues.
